

TRIES TO FIND PAGE REATE

Thomas Jacques and His Wife Charged With Abduction.

Joseph O'Hare and His Money Cannot Be Located by Sister.

The strange story of the disappearance of an aged and demoted man caused warrants to be issued late last night for the arrest of Thomas Jacques and his wife on a charge of abduction.

Joseph O'Hare came to the Pacific Coast in 1852. By frugal habits he made weekly deposits in the savings banks and ten years ago was reputed to be worth \$50,000.

Macondray and Miss Richardson were married less than a year ago, despite strenuous objections of their parents, and their troubles commenced shortly after the ceremony was performed.

Their honeymoon trip included a voyage to the Orient, where young Macondray was slated for a position in the foreign branch of the house of Macondray & Co. Little is known of the happenings of the trip across the ocean, but within a month after their arrival word was received that the newly wedded couple was bound for this city.

They arrived here and took up their residence with the parents of the bride at 109 Frederick street. Hardly had they become settled when people were startled by the rumor that the young husband had attempted suicide. The rumor was denied and all seemed serene until public yesterday.

MORE TEACHERS NOT NECESSARY

Twenty About to Return From Leaves of Absence.

Those Who Replaced Absent Tutors Will Become Substitutes.

The fact that at least twenty teachers are about to return from leaves of absence will preclude the possibility of any more appointments by the Board of Education for some time to come. Director Mark stated yesterday that the absentees until July 22, or the beginning of the fall term, to report for duty, and those now serving in their stead will be returned to the substitute list in the order of their appointment. As it is intended to limit the substitute list to fifteen, the surplus will of necessity be put on the day unassigned list.

The only way in which the displacement of teachers assigned to regular classes may be avoided will be for the board to act favorably on the recommendation of Superintendent Webster that thirty additional teachers be employed in overcrowded districts. The fact that the board is not disposed to look kindly on the suggestions of the Superintendent's office and that the Supervisors are disposed to cut contracts for the teachers who are on the list of the School Department makes the possibility of additional teachers a remote one.

The board announces, however, that in no event will the salaries of the teachers at present employed be reduced, as feared by Superintendent Webster. Provision will be made to keep the salaries where they are, and teachers, say the Directors, need not share Webster's fear. The names of the teachers who are on leave of absence until July 22 and are expected to return on that date follow:

Cookson, Holmes; Miss M. E. N. Erb, Lincoln; Mrs. Hemmings, Miss E. B. Cleary, Miss M. E. Barrington and Miss S. E. Kelly.

Of these Miss S. E. Kelly will return to the substitute list when she reports for duty, as her leave has been so long continued that she has agreed to waive her right to her old position. The names of the teachers now serving in place of those who will come back on July 22 and who will be relegated to their old places on the substitute list follow: Miss L. E. Wolfe, Cooper Primary.

Unused Tracks on Fifth Street to Be Taken Up Valley Road Asks for Additional Franchises in Order to Reach Potrero Industries.

The Supervisors' Street Committee cited Jere Burke of the Market-street Railway Company to appear before it yesterday to explain why the unused tracks on Fifth street, between Howard and Townsend, had not been removed. This action was the result of the petition of the Southside Improvement Club that the tracks be taken up, and that the company construct tracks on Fifth street so as to afford communication between the Market street line and the Southern Pacific depot.

Captain Payson of the San Francisco and San Mateo Railway Company asked that the petition for a franchise to lay tracks on Fourth, Michigan and Georgia streets be granted. Payson explained that the tracks will be necessary in order to reach the Potrero industries in the operation of the Illinois street and the construction of a seawall. Action was postponed for one week.

CITY'S CREDITORS WILL NOT BE PAID IN FULL Supervisor Jennings is authority for the statement that the Finance Committee, of which he is chairman, has practically decided to pay only 50 per cent of the old debts of the city contracted under former administrations. Jennings believes that the constitutional amendment recently adopted and providing for the payment of the old claims gives the board discretionary power in the matter of settling them. This action is in consonance with recommendations of Auditor Wells, made some time ago, that the claims be pro rated. Wells states, however, that there are final judgments against the city amounting to \$30,000, and these must be paid in full. The teachers are included in the pro rata proposition, and it is quite likely that all the city's creditors will obtain final judgments to secure the full amount of their claims.
