Complaint of Kentucky Railroad Commission.

WASHINGTON, Oct. 20.—The Interstate Commerce Commission to-day made public the complaint of the Railroad Commission of Kentucky against the Atlantic Coast Line Railway Company, the Louisville and Nashville, the Southern Railway, the Southern Railway in Indiana, the Cincinnati, New Orleans and Texas Pacific Railway Company, the Cincinnati Southern Railway Company, and the Chicago, Indianapolis and Louisville Railway Company.

Charges that the Defendant Lines Have Unlawfully Combined.

The complaint says these roads cover all important railroad points and all rail lines in a territory aggregating 25,000 miles with an operating income of more than \$30,000,000 annually, and charges that J. Pierpont Morgan & Co. have secured the management of the affairs of all these lines. The transportation facilities in this territory, the complaint charges, practically will become one system, operated by a few individuals, and will control the commerce of Kentucky, Tennessee, Mississippi, Alabama, Georgia, Florida, North Carolina, Virginia, West Virginia, Maryland, and Delaware.
