# QUESTIONS ACTS OF ARBITRATORS

## Decision in Il Triumfo Case Does Not Suit Salvador.

WASHINGTON, April 20.—According to advices received by the State Department, the Salvadoran Government will pay the judgment rendered by the arbitrators in the case of Il Triumfo, although it will do so with ill grace, according to reports received here. Before coming to this conclusion a professional opinion was called for from General Regalado, the former President of the republic. This opinion states that there was nothing more unjust, nothing more vulgar than the arbitrators' disregard for the opinion of the Salvadoran arbitrator, Dr. Pacas, whose powers were brutally ignored by Messrs. Dickinson and Strong. The opinion further declared that the sentence which they rendered was rude and immoral in several respects, but added that, despite all equity and despite all right, the consequences of that decision must weigh with Salvador for the simple and obvious reason that compulsion cannot be resisted by force. "Therefore," said General Regalado, "the simplest way to put an end to this question is by hurrying at the claimant a little gold, with the contemptuous manner of one who is disposing of something immaterial and thus not conceding an iota with reference to its dignity and its rights."

# SENATOR ELKINS REFUSES TO PAY

## Suit Is Brought Against Him by Two Former Employees.

WASHINGTON, April 20.—Senator Stephen B. Elkins of West Virginia is made defendant in a lawsuit for \$500,000 filed to-day in the District Supreme Court by Robert Burton and George A. Dubruell. The declaration in the case alleges that Senator Elkins employed the plaintiffs in November, 1901, to procure for him certain information, plans, data and legal opinions concerning the Western Maryland Railroad Company for the purpose of aiding him to acquire a controlling interest in that company. He proposed to pay them for services rendered him or his business associates in this matter, provided he obtained a controlling interest in the road. The declaration avers that they accepted the employment on these conditions and from time to time furnished the defendant certain information at the expense of much time and great labor, and also transmitted him legal information, etc., which assisted him in securing the controlling interest in the company. When, however, they requested compensation for their services, Senator Elkins, it is stated, failed and neglected to pay them. It is declared that after the Goulds acquired the Western Maryland, Messrs. Burton and Dubruell demanded their share, but that Senator Elkins refused to pay, although he had made millions out of the deal.



# AFTER TWENTY-THREE YEARS AS AGENT VETERAN RETIRES

## D. W. Hitchcock Will Receive a Pension From Union Pacific and His Position Will Be Filled by Samuel Booth on Fifteenth of Next Month

HAVING reached the age limit of 70 years, D. W. Hitchcock, who has been for twenty-three years general passenger agent of the Union Pacific Railroad in this city, will retire on a pension on the 15th of next month. The responsible position will be filled by Samuel Booth, who for the last two years has acted as confidential secretary to Traffic Director J. C. Stubbs at Chicago. The retirement of Agent Hitchcock will be greatly felt by all who know the genial old man. He is a universal favorite and is one of the best known and respected railroad men on the coast. With the exception of Agent Clinton Jones of the Rock Island system Mr. Hitchcock has held his position continuously longer than any other general agent on the coast. Mr. Hitchcock began, like nearly all successful railroad men, at the bottom of the ladder. His first service was with the Cleveland, Chicago and Cincinnati road, known as the "Big Four." He started in as a brakeman away back in 1854, but the officials recognized his ability and his promotion was rapid. In 1871 he came to this city as agent of the Burlington route. He was later called to Chicago, where he held the position of passenger agent for that road for six years. In 1880 Mr. Hitchcock was appointed general passenger agent of the Union Pacific in this city, and has held that position for the last twenty-three years. In 1881 he made a trip to Australia in the interests of the Union Pacific and the Santa Fe railways. He was absent about four months and gathered in his travels much valuable transportation data for the companies. Mr. Hitchcock is now 72 years of age, and under the new rules of the pension system of the Union Pacific he retires on half-salary. He was a great friend of the late S. H. Clark, who was president of both the Union Pacific and the Missouri Pacific roads for many years. Samuel Booth, the successor of Mr. Hitchcock, is 40 years of age. He has been in the Southern Pacific service for many years, and was until appointed secretary to J. C. Stubbs district agent for the Southern Pacific at Fresno.

# RATES ARE CUT BY HUNTINGTON

## Electric Road Magnate Begins a Vigorous Fight.

LOS ANGELES, April 20.—H. E. Huntington proposes to wield a long knife in the fight with the steam roads and to-day his company, the Pacific Electric, announced a sharp cut in the interurban rates. The plan is to issue a 500-mile ticket book, selling for \$5.25 and making a fare of a cent and a quarter a mile between Los Angeles, Long Beach, Pasadena, Monrovia, Alhambra and all points on the trolley lines. The city fare remains at five cents. The new book will be the same as the steam road mileage and good over the entire Pacific electric system.
