FIGHT FOR EXCELLENCE IN THE COURT

Attorneys For and Against Government Again Battle in the Land Fraud Case

EXPECT RULING TO-DAY Indictment Attacked Once More by Defense—Many Witnesses Attend Court

In the land fraud case the attorneys for Fred A. Hyde and Henry P. Dimond made another brave attempt yesterday before United States Commissioner Heacock to have the Government's complaint dismissed and their clients discharged.

GOVERNMENT WITNESSES. In their effort to reverse the commissioner's ruling of Wednesday the attorneys for the defense brought into court yesterday all but three of the Government's witnesses on whose testimony before the Grand Jury at Washington the indictment was found.
