ADULTERATED

Health Board Will Order Arrest of Owners of Depots Who Use Thickening

INQUIRY IS UNDER WAY

Artificial Matter Is Mixed With Pure Article in Violation of the State Law

Following close upon its crusade for pure milk the Health Board, upon the recommendation of Health Officer Ragan, will, within a week, order the arrest of some thirty owners of dairy depots on the charge of adulterating cream.

Dr. Ragan has been making a quiet investigation for the past three weeks and ascertained that the cream supplied by dairy depots was being mixed with thickening for the purpose of doubling its quantity.

One of the samples was found to contain vegetable coloring matter, together with borax and gelatine. A sample of thickening known commercially as "viscogen" was analyzed and found to be nothing but cane sugar.

Dr. Ragan further learned that it was the common practice of some dealers to mix the cream which was received in its pure state from dairies with skimmed milk and also the thickening with the result that one gallon of cream would be transformed into two gallons of the mixture.

In connection with Ragan's investigations the Board of Health is preparing to recommend to the Board of Supervisors the passage of an ordinance requiring the presence of 30 per cent of butter fat in cream.

The dairy inspectors are engaged in serving copies of the new ordinance prescribing regulations for the sanitary conduct of dairies, which will go into effect on September 15 next.
