Dr. Douglas Hyde Lectures at Sacred Heart College.

TALKS OF THE LEAGUE'S WORK

In a long address last night at Sacred Heart College Dr. Douglas Hyde, president of the Gaelic League, told a large audience of the glories of the past history of Ireland, of her ancient civilization and literary renown. He also spoke briefly of the work of the league in bringing about a restoration of the national tongue and the revivification of the national institutions of Erin.

Before the alumni, the students and their friends last night at Sacred Heart College, Dr. Douglas Hyde delivered an impressive talk on the origin and progress of the Gaelic League. He spoke of the Gael in the thousand years preceding the Christian era, and incidentally spoke of the work of the Gaelic League, of which he is the president, in bringing about the return of the language to the tongue of the Irish. Frequently during the discourse the speaker was interrupted by applause from the audience that packed the hall of the college, and upon its conclusion the men and women crowded around Dr. Hyde to meet and congratulate him.

The address was made the occasion of a social and musical program, given under the auspices of the Christian Brothers, presided over by Brother Lewis. Frank J. Sullivan was chosen as chairman and he introduced those of the entertainment program. The presence of Mr. Sullivan was made the occasion by the Alumni of Sacred Heart of making him an honorary member of the alumni.

In introducing Mr. Sullivan as chairman Brother Lewis paid him high compliments, in speaking of his well-directed energy and perseverance which resulted in Dr. Hyde's visit. Turning to Mr. Sullivan he presented him to the audience as a man whose heart, hand and pocket were always open for the cause in which the distinguished visitor, Dr. Hyde, stood as leader.

Mr. Sullivan then responded briefly by thanking Brother Lewis for the kind introduction and launched into praise of the work of the Christian Brothers in Ireland and America. He spoke of the work of the Irish pioneers in California and added with pride that his own father was one of the first names on the rolls as giving money for the construction of Sacred Heart College.

PRESENTS DR. HYDE.
"But in introducing the chief speaker of the evening," continued Mr. Sullivan, "I want to tell you that a man to be an educator must be a man whose soul is in his eyes and whose heart is in his hand. He must be a man of sincerity and truth, and the people to whom he comes as a teacher must believe in him and be interested in his work. Such a man is the distinguished visitor before you this evening and I take pleasure in presenting him to you Dr. Douglas Hyde."

"After bowing acknowledgments to the applause that rang for minutes through the hall, Dr. Hyde began his address in the Gaelic tongue and Gaelic repartee from individuals in the audience caused laughter and good-natured applause. Changing to English, however, the speaker said that the pith of his Irish talk was praise of the work of the Christian Brothers in Ireland and from that sense that many of his hearers might lose the spirit of his gratitude to them, he spoke as follows:

"If it were not for the work of the Christian Brothers in Ireland from the earliest times until the present day there would be precious little of the spirit of Irish patriotism and Irish heroism. The schools and colleges of the Christian Brothers kept alive the language and the literature of the people at a time when the flame was flickering by their absolute independence of Government support. They had their own Irish books and their own Irish spirit and through the children entrusted to their care for education and teaching they handed down the spirit of independence."

WORK OF THE CHURCH.
"In particular I may speak of the work of the De la Salle Christian Brothers at Waterford, whose influence in the training of the young has been the best. It is to this branch of the brotherhood also in America that the credit of keeping alive the Irish spirit here must be given. It is the spirit that is the birthright of every son of Erin, a spirit of liberty and national life or death."

"The primitive inhabitants of Ireland were one of the great branches of the Indo-European race that passed the Caucasus and overran Europe fifteen hundred years before Christ. By about the year 1000 B. C. the tide had reached to the western shores of Ireland. Thus may be seen as a glance our ancestors' ancestors. Then began the history of Ireland, a nation, glorious in war and peace, glorious in literature and art, in science and commerce."

"The Celtic branch, or Irish and Welsh, was the first to leave the parent stem of the Indo-European race. It is older than the Teutonic, Slav, Greek, Latin or Sanskrit branches. Its language is still allied to that of Sanskrit and its kingdom at one time spread from the Black Sea to the western shores of the Atlantic. It may be said that the ships had to be strong enough to brave the Atlantic. I may add, however, parenthetically, that the ships have since been built and the Irish have moved westward."

LINGUAL AFFILIATION.
"I might take example after example to show the close relationship between the language of the Celt and that of the Indo-European. Irish bears all the external marks of the Indo-European tongues. Many words may be found to be almost identical with the Latin and not a few with the Greek, but the majority of the words are of an older origin than either of the two languages of Southern Europe."

"The English have insisted on teaching the youth of Ireland that Irish is the language of the barbarian. Why? On other days, representatives of Trinity College in Ireland assured the vice-regal commission that was inquiring into Irish intermediary education that Gaelic was the language of the scholar and pedant. It took a German scholar to change their minds of that idea. The Irish

GAS INQUIRY IS PROCEEDING

Naphtaly Compares Prices of This and Other American Cities for Supervisors

WAGES HAVE INCREASED

Official of Company States That Pay Has Reached to Sixteen Per Cent Higher

The inquiry for the fixing of gas and electric rates for 1906-1907 was resumed by the Supervisors last night. Supervisor Samuel Davis, chairman of the artificial lights committee of the Board of Supervisors, presiding.

Samuel L. Naphtaly, superintendent of the San Francisco Gas and Electric Company, was examined by Supervisors Gallagher and Duffy as to the cost of the several parts of the plant, and also as to the selling price and cost price of gas and electricity. He showed that the total gross revenue from all sources was \$4,657,468.19. The total sales of gas for the year amounted to \$2,828,958.81; from sales of electric current, \$2,165,925.48, and from all other sources, \$728,583.90. The cost of gas, \$2,038,123.72. Cost of electric current, \$1,638,667.41.

Naphtaly stated that the average selling price for electric light in the city is 4 1/2 cents, while the average selling price for the majority of other cities in America is 6 cents. The price of pipes had largely increased and wages during the last fifteen months had increased 15 per cent. The amount paid in wages for labor last year amounted to \$1,220,000. Garrett McEnerney brought out the statement that the charge for depreciation by the company was about 2 1/2 per cent, whereas authorities through the United States Bureau of Labor Statistics figured the depreciation on such work at 5 per cent on gas and 7 per cent on electric. The further inquiry was adjourned until next Monday.

BACHELOR OFFICERS TO HAVE QUARTERS

Contract Approved for Remodeling Old Hospital at Presidio of Monterey.

The contract for the remodeling of the old hospital at the Presidio of Monterey into modern quarters for the bachelor officers, which was recently awarded to J. Clarence Anthony of Monterey, has been approved by the quartermaster's department, and work will begin immediately.

The bids for the work were opened several weeks ago, but it was not until yesterday that they were approved and the contractor ordered to proceed with the work. The remodeling of the hospital for bachelor officers will greatly relieve the congested condition which exists at present, besides adding materially to the beauty of the post.

The officers at the Presidio have decided to give the last hop of the winter season on February 27, at which time all the officers and their wives from the surrounding posts will be invited to attend.

Use School Lot as Dumping Ground.
Truant Officer Campion, attached to the Board of Education, yesterday discovered that A. P. Clute, who has a contract with the city for the removal of the refuse from the streets, was dumping the dirt on a school lot at the corner of Fourteenth and Castro streets, upon which the new McKinley School is to be built. Campion ascertained that more than a thousand loads of dirt had been dumped on the lot and Clute's foreman was notified that he will be arrested if he allows any more dirt to be deposited thereon. The Board of Education will now be put to the expense of removing the dirt in order to grade the lot. It is said that others besides Clute used the lot as a dumping ground.

Says Dairies Will Be Confiscated.
P. A. Bergerot, attorney for the dairymen who are protesting against the proposed extension of the so-called "two-cow limit" so as to include the University and district yesterday filed a formal protest with the Supervisors against the passage of the ordinance on the subject. The ground of the protest is that the extension of the limits would be a virtual confiscation of dairy property valued at more than \$200,000.
