With tears in her faded blue eyes and trembling but close shut lips Mary O'Neil, an aged inmate of the almshouse, fought desperately for the possession of her treasure when taken to the hospital and discarded by the nurse in charge.

It has always been so. From the time Mary O'Neil, aged 81 unmarried and a pensioner on the bounty of the state, was taken to the Ingleside hospital after the fire, homeless and apparently friendless, she has clung to the one thing on earth around which her thoughts centered.

She lived with it, hugged it tight to her, slept with it, dreamed over it, and even when bathed would not be satisfied if her black skirt with its ample hidden pocket were out of her sight.

Vaguely she thought that she had a treasure and desperately she struggled to retain it when for a few moments it was taken from her, but even that is forgotten now.

It is probable that an attempt will be made to purchase her life in the Old Ladies' home. Should she die intestate the \$16,000 will revert to the state should no relatives appear.
