

### THREATENS LAWYER IN PERJURY TRIAL

#### Witness for the Prosecution Clashes With Attorney of Richard H. Blumberg

The preliminary hearing of Richard H. Blumberg, charged with perjury in testifying for the defense at the examination last November of Michael Joseph Conboy, accused of the murder of Bernard Lagan, was continued before Police Judge Deasy yesterday. It was marked by open threats made by E. W. Hoag, real estate dealer, against Attorney Ferral, who put him through a grueling cross examination. At one time Hoag said that Ferral was evidently holding him up to ridicule, and if so not even his age would save him from punishment.

### CRUISER AND HER CREW QUARANTINED

#### Washington Arrives and Anchors Off Angel Island to Be Thoroughly Fumigated

The United States armored cruiser Washington, Captain Charles C. Rogers, arrived yesterday afternoon from Puget sound and went direct to an anchorage off the quarantine station on Angel island, where the ship and crew will spend the next two weeks taking the "third degree" of disinfection. No new cases of smallpox developed during the run from Port Townsend. The last case was discovered February 25, four days after the cruiser had been released from quarantine at Port Townsend. This time no chances will be taken.

Chief Quarantine Officer Trotter boarded the ship and had a long consultation with Captain Rogers and Surgeon J. G. Field, U. S. N., the senior medical officer of the cruiser. As a result of this conference a plan of campaign was arranged and has been submitted to the surgeon general of the navy and the surgeon general of the marine hospital service for their approval. The surgeon general will be heard from today and this morning the work of ridding the ship and crew of all further danger from the deadly germs will begin.

On board the Washington are 850 men. All but enough to take care of the ship will be landed on Angel island, where quarters have been prepared for them. All clothing and bedding will be sterilized and every man from the skipper to the Filipino mess boy will be given an antiseptic bath. When the men are off the ship the cruiser from which they were taken will be fumigated with sulphur.

It is probable that the Washington will go to Mare island for the repairs necessary before the warship starts on its long voyage around the Horn. Since leaving Yokohama nine cases of malignant smallpox have been discovered on the Washington, and of these four died.

### JUDGES SCORED IN DISSENTING OPINION

#### Chief Justice Beatty Flays the Lower Courts for Decision in Stockton Case

Chief Justice Beatty of the state supreme court, in a dissenting opinion handed down yesterday, takes occasion to brand the action of every branch of the judiciary as wrong in the case of A. Hamberger against the police court and city of Fresno. No court escapes the criticism of the chief in his opinion. Beginning with the justice court, he proceeds to the police court, superior court and district court of appeal, ending by a criticism of the action of his own court in the refusal of a rehearing in the case in question.

The original case, brought in a justice court in Fresno, was a civil matter covering the collection of a bill amounting to \$121.65. Each court, as the matter was brought before it, refused to order a rehearing of the case as decided by the police judge.

### DUNPHY REGARDED MARRIAGES LIGHTLY

#### Announced One by Telephone and Left the Other to the Newspapers

James Clay Dunphy's manner of announcing his marriages was somewhat casual, according to the testimony of T. R. Curtis in Judge Seawell's court yesterday during the trial of the wealthy cattleman's suit to annul his union with "Dodie" Valencia-Baird-Dunphy. The night of his marriage to Edith Silverstone in January, 1903, Dunphy telephoned Curtis from the Palace hotel.

"Well, I'm married. What do you think of that? I've got a right to get married, haven't I?" Curtis said that he did not question his right and then Dunphy added: "You tell the family. But I think I'll call it off. One thousand dollars should settle this."

The marriage to Miss Valencia became known to Curtis through the papers, he said. The witness testified that the night prior to the marriage Dunphy arrived home in company with Billy Plunkett, a saloon keeper, saying, "I've been in the chain gang. Ain't it awful? Billy bailed me out."

Curtis testified that he had seen Dunphy drunk on many occasions and said that it was a habit of Dunphy's to paint and powder his face. William Graham Richardson, whose father is a member of the paper firm of Bonestell & Co. permitted his wife Adelaide to obtain a divorce by default in Judge Van Nostrand's court yesterday for desertion. They were married in Paris, France, in December, 1907, when their parents were opposed to the match. Mrs. Richardson testified that her husband gambled all his money away and insisted that she earn her own living.

Deserted one day after marriage, Katie Prout obtained a divorce in Judge Graham's court yesterday from Richard Prout. William F. O'Brien is a hoisting engineer earning \$50 a month. His wife, Bertha, filed a suit for separate maintenance yesterday asking to be awarded \$150 a month for her support. O'Brien has \$12,500 in bank and owns real estate. ### LABORING MEN EMPLOYED ON CITY JOBS IN SPOKANE, WASH.

The laboring men employed on city jobs in Spokane, Wash., are making a fight to receive from the city all that the city pays to its workers and to abolish the practice of a "rake down" for the city boss. It is said that many of these employees are foreigners, who are under the impression that they must pay a certain percentage of their wages to "the city padrone" in order to hold their jobs. Some of the enlightened labor leaders of that place are under the opinion that the laborer is worthy of all that the city has agreed to pay him, have taken the matter in hand and have induced Mayor Pratt to declare that there should be a city labor agent or commissioner whose duty it shall be to see that the law is enforced and that the men employed on city jobs receive all that is coming to them for labor performed. An effort is being made there to increase the pay of laborers from \$2.75 to \$3 per day.

A communication from Spokane, Wash., received in this city says that the Spokane is a city of cooks and that the Falls City is gaining rapidly a reputation for its supply of unequaled chefs. Although there is no pretension to rival the gay capital of France, there through years if the present reputation of the city for good cooks continues to increase.

Herman Robinson, for many years a general organizer for the American federation of labor in New York, has been appointed a commissioner of licenses for the city of New York at a salary of \$5,000 a year. In talking of the interest in the appointment, Robinson said: "The laboring leaders had the habit of silent thought and discretion and always looked before they leaped, as does Herman Robinson, it would be well for us all."

The postoffice clerks of this city, as well as those all over the country, are making a strong effort to have the bills now before congress passed in the interest of the working portion of the postal department. They are working to the end that postoffice employees shall be placed on the basis of merit rather than on "political pull."

Stanley Wilson, former candidate for mayor on the labor union ticket, was the principal speaker.

An effort is being made there to increase the pay of laborers from \$2.75 to \$3 per day.

A communication from Spokane, Wash., received in this city says that the Spokane is a city of cooks and that the Falls City is gaining rapidly a reputation for its supply of unequaled chefs. Although there is no pretension to rival the gay capital of France, there through years if the present reputation of the city for good cooks continues to increase.

Herman Robinson, for many years a general organizer for the American federation of labor in New York, has been appointed a commissioner of licenses for the city of New York at a salary of \$5,000 a year. In talking of the interest in the appointment, Robinson said: "The laboring leaders had the habit of silent thought and discretion and always looked before they leaped, as does Herman Robinson, it would be well for us all."

The postoffice clerks of this city, as well as those all over the country, are making a strong effort to have the bills now before congress passed in the interest of the working portion of the postal department. They are working to the end that postoffice employees shall be placed on the basis of merit rather than on "political pull."

Electrical workers' union No. 6 has decided to give its annual smoker on the night of March 19 at a place to be selected later. Steam fitters' union No. 45 met in the San Francisco labor temple Wednesday night and made a donation to the steam fitters of New York City, who are on strike for an increase of 50 cents a week. One candidate was initiated and two applications were presented. The next meeting will be the quarterly one.

Housemiths' union No. 78 has decided to have a ladies' night in the auditorium of the building Trades union on Saturday, April 9. E. Lewis, B. Richardson, B. McGuirk, Henry Lay, T. Seabill, C. Hague and L. Ayers were named a committee to make arrangements for this event. Butchers' union initiated seven candidates at its meeting in the Labor temple Wednesday night.

### EXCLUSION LEAGUE IS FORMED IN LOS ANGELES

Unions Take Stand Against Asiatic Immigrants. LOS ANGELES, March 3.—At a meeting of members of various labor unions of this city in Labor temple tonight an Asiatic exclusion league was formed and resolutions were adopted declaring that the report of the Immigration committee of the Los Angeles chamber of commerce, which favored Japanese and Chinese immigration to California, was unwise and unfair to laboring people. Stanley Wilson, former candidate for mayor on the labor union ticket, was the principal speaker.

### BAILIFF BREAKS ARM CRANKING AUTOMOBILE

OAKLAND, March 3.—David Jones, bailiff in department 4 of the superior court, broke his right wrist last night while cranking an automobile. Jones was with a party of deputies of County Clerk Cook, who were returning from a meeting for the registration of voters. The wrist was set at the receiving hospital.
