

MILOS GOPCEVIC IS MARRIED AGAIN

Montenegrin Husband of Harry Floyd Takes Marion Dodd to the Altar

Bride Is a Beauty, Rich and Is Rated Among Best Business Women on Coast

Milos M. Gopcevic, member of the royal Montenegrin family, streetcar conductor and wealthy rancher of Lake county, who secured his great fortune at the death of his wife, formerly Miss Floyd, a society girl of this city, has again married a young woman of great wealth.

Last night, at the Russian Greek church, at the corner of Van Ness avenue and Green street, Miss Marjorie B. Dodd, daughter of Colonel Marshall Dodd, a civil war veteran of the best Kentuckian lineage, was wedded to Gopcevic in the presence of about 100 friends.

EVADING NOTORIETY
An effort was made by the family to keep the affair as quiet as possible, not wishing for a repetition of the notoriety attending the groom's marriage when he was but a poor streetcar conductor on the California street line. But about 100 friends were present at the wedding and a score sat down to the supper afterward at the family home.

Though on the first occasion, Gopcevic secured a wife with a fortune of over \$1,000,000, he can scarcely be said to be less fortunate in his last choice, the bride of last night being one of the shrewdest of business women of the Pacific coast. With her as a helpmeet the fortune, amassed from both sides, should swell to a great extent. Miss Dodd has been interested in a local wire company for but six years and has already brought forth a revenue from it of more than \$1,000 a month. It is her great hope, when she has the additional advantage of her husband's money, to become the foremost steel operator on the Pacific coast.

SIMPLE CEREMONY
The ceremony performed at the Greek church was very simple. Judge John P. Davis was best man and Mrs. Maude de Camp acted as maid of honor. Miss Marie Dodd, sister of the bride, alone acted as bridesmaid. The brothers of Gopcevic, Bozo M. and Andro M., the latter of whom came especially from Austria for the wedding, and Miss Dodd's brother, Marshall, acted as ushers. Among those invited to the wedding were Mr. and Mrs. John Rodovic and their daughter, Bertha; Mr. and Mrs. William B. Pritchard and daughter; Eliza and Mrs. Shorb de Bar and daughter.

The Gopcevic family has had the public gaze directed against it on a number of occasions. The first was in 1904 when the social world was startled by the report that the vivacious Harry Floyd was to marry the apparently penniless streetcar conductor. The marriage was a most fortunate match and the couple lived in great domestic bliss for a few months and then the young woman was taken suddenly ill and died. Just before her death she called for paper, ink and pen and willed her entire fortune to her husband.

WINS WILL CONTEST
Then came the great will contest in Lake county, where the couple had lived at the bride's great estate, "Konoyah," her relatives claiming that she was hypnotized, frightened and under the influence of her husband, and her best friend, Eliza Pritchard. The will was successfully defended by Judge John P. Davis, and he and Miss Pritchard were among those present last night to see fortune again smile on Gopcevic.

Gopcevic's name next sprang into publicity in November, 1908, when he held Dr. Walter H. Pearn, a Lake county physician, a veritable prisoner in the "Konoyah" mansion. When sued for \$250 fees by the doctor, he gave as his reason, the laconic statement, "It was for my brother." It was his brother, Peter, who while visiting at "Konoyah" had been taken quite ill and was in need of medical attendance, and Dr. Pearn was kept there nearly a month.

Bozo M. Gopcevic, brother of Milos, is said to be the rightful king of Montenegro and of the royal blood of the ruling house of Servia-Bulgaria. The family is most influential in its native land and the one or two times Bozo has returned it has been a signal for a general insurrection. He returned on one occasion and rescued his brother Andro, who came here, for the first time, from Europe to attend last night's event, as he was about to be transported into exile. The home of the brothers at 2845 Sacramento street is loaded with many valuable presents sent from Europe and from friends in this city. The walls are covered with photographs, etchings and oil paintings of the ruling families of Servia-Bulgaria. Many of the oil paintings were done by the versatile Bozo, whose greatest boast now is that "I am an American."

BRIDE IS BEAUTIFUL
The history of the bride is also most interesting. She is a striking brunette and said to be one of the most beautiful women in California. She is very wealthy in her own name and has made her home for some time first at the St. Francis and later at the Fairmont hotel. She is determined to stay with her steel interests and become one of the greatest financiers of the west. Her father is at his home in Los Angeles.

When King Gustave III was in Paris he was visited by a deputation of the Sorbonne. That learned body congratulated the king on the happy fortune which had given him so great a man as Scheele, the discoverer of magnesium, as his subject and fellow countryman. The king, who took small interest in the progress of science, felt somewhat ashamed that he should be so ignorant as never even to have heard of the renowned chemist.

The king dispatched a courier at once to Sweden with the laconic order, "Scheele is to be immediately raised to the dignity and title of a count."

PLUMBERS SUED BY THEIR HELPERS

Journeyman and Masters Accused of Entering Conspiracy to Monopolize Trade

Injunction Asked For in Effort to Break Up Alleged Unlawful Agreement

Charges of illegal conspiracy to monopolize the plumbing business in San Francisco were made yesterday against the journeymen plumbers, gas and steam fitters' union, local No. 44, and the master plumbers' association of San Francisco, through the medium of a suit for injunction begun by the plumbers' and gas fitters' helpers' union, local No. 1.

The accusation refers to the agreement between the journeymen and the masters on April 30 that in future but one helper or apprentice should be employed in each shop to four journeymen and that in no event should more than four helpers be employed in one shop. In pursuance of this agreement some 125 helpers were discharged, and it is said that they have diligently sought re-employment, but without success.

The court is asked to grant an injunction restraining the journeymen and the masters from carrying out the secret agreement and from seeking by force, threats, intimidation, or any other means, to prevent helpers getting work. Harry K. Wolf and H. W. Glenson are the attorneys for the plaintiff union.

According to the complaint, the trade of plumbers' helpers or plumbers' apprentice is a separate and independent occupation or trade and has always been recognized as such. It is charged that the secret agreement to limit the number of helpers to one for every four journeymen was the result of a malicious conspiracy, formed to obtain a monopoly of the plumbing business and not for the welfare of the public or in the interests of humanity.

When the master plumbers discharged a majority of the helpers they told the latter they were perfectly satisfied with their work and that there was sufficient work to keep them busy, it is alleged, but that by reason of the agreement with the journeymen they could not do so, being in fear that their business would be ruined. The attorneys for the helpers' union said yesterday that a damage suit against the journeymen and the masters' organizations probably would be begun later. The officers of the helpers' union are Otto Boeddiker, Edward Martin, Norman L. Nichols, John H. Herman, Leland S. Bond, Julius Caen, James Leonard and Andrew Boyle.

MEXICO BEGINS FIGHT ON TYPHOID FEVER

California Physician Employed to Conduct Campaign

BAKERSFIELD, June 16.—Dr. A. F. Schafer, Kern county physician, has been engaged by the Diaz government to establish in Mexico systematic methods of fighting typhoid fever, typhoid pneumonia and typhus fever, which letters to the doctor indicate are epidemic in coast and interior cities.

The doctor will take specially trained nurses and will make the trip from El Paso to the City of Mexico by automobile. The main feature of the treatment, outside of sanitation, is the use of a serum.

Dr. Schafer returned today from San Diego and Los Angeles, in the county hospitals of which places typhoid patients were successfully treated.

SPLENDID MAP OF CALIFORNIA ISSUED

Development Board's Report Is Distributed Free of Charge

In the annual report of the California development board, just issued, is a map of California, one of the best ever published in the state.



SUPREME COURT UPHOLDS CONVICTION FOR PERJURY

Cigar Dealer Must Serve Three Years in Prison

Gustav Hoingren, convicted in the United States district court of perjury in 1905 and whose case has been on appeal before the United States supreme court, must serve his sentence of three years in the penitentiary. The mandate of the supreme court affirming the judgment of the lower court was received yesterday from Washington at the office of United States Attorney Robert T. Devlin. Hoingren, who was a cigar dealer on the water front, perjured himself in a naturalization case.


