BERKELEY MAY GET TWO ASSEMBLYMEN

Alternative Plan Would Give College City Senator and Assemblyman

BERKELEY, Nov. 14.—Berkeley may get two assemblymen in the reapportionment of representatives in the state legislature from present indications. The Alameda county delegation will meet next week to complete an agreement as to the lines of partition of the county into new senatorial and assembly districts and Berkeley, with a population of 40,000, is the crux of the situation.

The proposed apportionment will be made on a basis of 30,000 persons to each assembly district, and 60,000 to club senatorial district. Virtually the county delegation has determined that the district now represented by Assemblyman A. A. Rogers will be retained and that Alameda, represented by Sumner Crosby, shall be undisturbed.

By a partition according to population Berkeley, under a scheme proposed by Senator John W. Stetson, will have a majority of the voting strength in two assembly districts; that is, will elect two of the Alameda county assembly members. But the plan will make Berkeley a minority in a senatorial district, or in two such districts.

Another plan is to divide North Oakland so that the northernmost section with Berkeley would have 60,000 persons for a senatorial district. This will give Berkeley, with 40,000 population, the control of the senatorial district. But the same plan proposes a distribution of assembly districts so that the college city will elect only one assemblyman.


Affidavit Alleges Employee of Company Opened Pipe

CONSOLIDATED CITY PROJECT OPPOSED

Directors of Oakland Chamber of Commerce Resolve to Fight Absorption

OAKLAND, Nov. 14.—The directors of the Chamber of Commerce voted unanimously to oppose the consolidation of Oakland and San Francisco at a meeting held this morning.

The "Greater San Francisco movement" was brought up by President H. C. Capwell, who said that in a conference with State Senator John W. Stetson the danger of the initiative call on the matter of annexation was brought out, although no action could be taken at present.

A special committee will be appointed by Capwell to confer with representative organizations of this city to plan a campaign against the absorption of this city by San Francisco.

Capwell said that he felt so strongly against the proposition that he was willing to give \$10,000 to fight it, provided other took similar action.

Director W. E. Gibson proposed a motion of opposition to the scheme. The motion was seconded by Director George C. Pardee and was carried unanimously.

The resignation of W. J. Layman, who was made a director of the Chamber of Commerce at the last meeting, was accepted.

The proposed extension of the Foot-hills boulevard to Niles, Mission San Jose and several other picturesque spots was brought up by Henry Lachman of Mission San Jose and endorsed by the directors.

Julius Abramson, Theo Gier and Professor Gibson were appointed a committee to audit the accounts of the chamber. A report showed that the fixed expenses of the body were about \$1,800 a month, and that there were receipts of very nearly that amount, together with the monthly income from the advertising fund of about \$700.

USE OF CRAFT BY INCENDIARY SHOWN

Man Wounded Near Livermore Tried to Kill Dog Before Applying Match

LIVERMORE, Nov. 14.—That Antonio Frank, who was shot by Mrs. Mary Bankowski on her ranch on the Tesla road Sunday afternoon, had decoyed her shepherd dog from the house and had attempted to kill it before firing the tankhouse and the barn was a development of today's investigation of the affair.

From Frank's incoherent mutterings since his removal from the ranch, officers here declare they have obtained a confession that Frank fired Mrs. Bankowski's tankhouse last Thursday evening and that he set fire to some loose hay in her barn on the following night.

Sheriff Barnett has learned that Frank called the shepherd dog to a point near the deserted barn in which Frank camped. One of the dog's legs was badly slashed by a knife, and it was apparent that Frank hoped the animal would bleed to death and so fall to give warning by barking when the tankhouse was fired.

The dog revived and barked, and a servant girl was aroused before the blaze had reached dangerous proportions. It was found that the water supply had been turned off and the tankhouse could not be saved. A few hours later the blaze in the barn was discovered. It was extinguished by neighbors.

Frank is believed to be insane. No charge will be brought against Mrs. Bankowski.
