Attorneys for Defense Hope the Case May Be Dropped if Jury Disagrees

Vigorous cross examination today marked the defense in the fifth trial of former Police Captain Michael Joseph Conboy for the murder of Bernard Lagan, June 23, 1909.

George Greenwood, Lagan's companion when the shooting occurred, a witness for the prosecution, was somewhat tangled by Attorneys J. J. Dunne and Nathan Coghlan yesterday in some of his testimony, but he was straight on the main story, telling of Conboy's condition, how he had slipped into the gutter, and how Lagan helped him to his feet and then was shot by the drunken policeman.

Both sides are ready to present new material. Every effort is being made by Conboy's attorneys, because they believe that the case may be dropped if it is not decided in five trials. Conboy was convicted once, but the higher court ordered a new trial. The jury disagreed three times.

Judge B. V. Sargent of Monterey, presiding, created a diversion yesterday by declaring that the courtroom "smelt like a barroom."

"I do not object to that smell in its proper place," he said, "but its place is not in this court. Therefore, I order that during the trial no smoking be done in this court."

Judge Sargent admitted testimony by Dr. Charles B. Pinkham, formerly surgeon at the central emergency hospital, concerning Lagan's recognition of Conboy and Conboy's reply. The witnesses, examined yesterday were: Dr. Charles B. Pinkham, Dr. John Lagan, George Greenwood, Dr. James H. O'Connor, J. A. Ulrich and J. B. Brooks.
