
They reached this city this morning and were met at the station by a large reception committee. This evening they are to be the guests at a reception given in their honor by the Bremen senate.

Giant Collier Jupiter Will Be Launched Sometime Next Month

Wife of Naval Constructor Thomas F. Ruhm Will Christen Vessel Which Is Largest Ever Built on This Coast

[Special Dispatch to The Call] VALLEJO, July 12.—Next month at Mare Island the United States naval collier Jupiter, the largest vessel ever built on the Pacific coast, will be launched from the ways where its gigantic steel hull is now resting just below the navy yard landing. The date for the launching has not been definitely set, but will be some time during August.

The keel of the Jupiter was laid October 18, 1911, and the hull is now practically completed. The vessel will be entirely finished and ready to go into commission in about six months from the present time. An army of men is at work upon the ship, and many speed records have been shattered already during the construction period.

The Jupiter will be 524 feet in length with a beam 65 feet and a draft of 28 feet when loaded. It will have a displacement of 14,000 tons of coal and oil and a total displacement of 20,000 tons. It is a twin screw steamer and will be equipped with steam turbines, dynamos and motors.

CRUISERS TO JOIN IN WATER PAGEANT

Several Naval Vessels Will Be Stationed at Santa Cruz During Carnival

[Special Dispatch to The Call] SANTA CRUZ, July 13.—Water pageant plans are being carried out to the minutest detail. While naturally Pageant island will be the scene of most activity, there will be plenty to see on the beach front.

The visit of the Corinthian Yacht club and yachts from other places on the coast, two cruisers and probably several submarines, will give the city an animated appearance, especially in the evening, when craft of every kind will be illuminated.

Word was received from Senator George C. Parks today that the cruiser Cleveland and Denver had been ordered here to remain during the nine days of the pageant. The war department is considering also the advisability of sending several submarines.

A SHIP OF LIGHTS In the center of Pageant island will be located the principal design, which will be a huge ship, the outlines of which will be set off by incandescent lights of many colors.

OROZCO'S STAR IS SLOWLY WANING

Gomez in Ascendancy; Report Is That He Will Be Provisional President of Mexico

EL PASO, July 13.—Evidence is in the hands of Mexican government agents here tending to show that Emilio Vasquez Gomez soon will be asked to assume the provisional presidency of Mexico and that General Pascual Orozco Jr., who repudiated him, will be deposed and succeeded by General David de la Puente.

Emilio Vasquez Gomez is in San Antonio, while General de la Puente is said to have been in El Paso for medical treatment. A meeting between the two men at San Antonio is looked for within a few days.

General Orozco, after distributing the rebels at designated places on the border line between Sonora and Chihuahua, will resign as chief of the revolution and join his family in California. It is known that Generals Salazar, Campa and Rojas, the three principal military leaders, are in sympathy with the cause of Emilio Vasquez Gomez, having been in the revolution with the idea that he would be the civil head of it.

YOUTH'S PAST LIFE BECOMES A BLANK

Assistant Gunner on Training Ship Is Afflicted With a Strange Malady

[Special Dispatch to The Call] SAN MATEO, July 12.—One of the strangest cases that the surgeons in the marine hospital service ever have met with is that of Horace Walling, the eldest son of Mr. and Mrs. H. H. Walling of San Mateo, who was stricken with a mysterious malady while with the United States training ship Nashville in San Domingo bay, Haiti, and now lies in the naval hospital at Portsmouth, Va., suffering from a complete loss of memory.

One day, while the Nashville was in port at San Domingo, Walling, assistant gunner on the training ship, went ashore alone. Half an hour later he was brought back to the ship in a dazed condition, unable to speak, hear or walk. At first the surgeons were inclined to believe that he had been drugged by the natives, but as his condition remained the same that theory was abandoned.

Walling is now normal in every respect, except that his mind is a blank as to all persons and events that took place before his illness. He can not recall his home, family or friends.

Word of the boy's condition was received here last week, and Mrs. Walling, who is a prominent schoolwoman of San Mateo county, departed Thursday for the naval hospital at Portsmouth with the intention of bringing her son back to California. If Walling's mind was affected by the heat of the tropics, the physicians believe that the cool climate of the Pacific coast and the familiar scenes and faces of home will soon result in a complete recovery of memory.

RUBBER MEN KILL INDIANS IN PERU

Torture Worse Than Death Inflicted on Women and Children by Exploiters

LONDON, July 13.—The disclosures as to the state of affairs in the rubber industry in Peru, published in the Blue Book just issued by the foreign office, as the result of Sir Roger Casement's investigations, attract a great deal of attention and have caused comparisons to be drawn between these wholesale atrocities and those at one time reported from the Congo Free State.

The foreign office says that after months of futile attempts to get the Peruvian government to take measures to prevent the recurrence of such horrors and punish the guilty, it had decided with the cordial acquiescence of the United States government that the only course to take was to publish the facts in full.
