DEFICIT PREDICTED FOR YEAR

WASHINGTON, Aug. 26.—Congress closed another billion dollar session today, but the exact total of the nation's "cost of living" varies as it is seen through republican and democratic eyes.

The total appropriations for the fiscal year 1913, which began July 1, 1912, amount to \$1,019,636,143.66, as given to the senate and house today by Senator Warren and Representative Fitzgerald, respectively chairman of the two appropriation committees.

It is conceded by both of these leaders that this is \$7,046,000 less than the nation's budget of 1912, but it remained for former Speaker Cannon, in behalf of the republican forces of the house, to produce figures to show that the present democratic congress had

actually appropriated more for general purposes than did the preceding republican congress.

Representative Penrose declared that out of the total should be taken all expenditures made for the Panama canal. With such deductions, he said, the total appropriations for 1913 would be \$990,656,143, as compared with a total of \$981,122,881 appropriated for general purposes last year.

Predictions that the government would face a heavy deficit at the end of the year were made both by Senator Warren and Representative Cannon. Senator Warren said that the cabinet had carefully reduced estimates to the lowest figure. The appropriations actually made are more than \$21,000,000 less than the estimates, and the republican leaders say it will be impossible for the existing government agencies to keep within them.

Civil Service Considers Amendment for Temporary Employes by City

The civil service commission listened last night to the first reading of an amendment to rule 26, which will permit the board of public works to make temporary appointments of employes on the Highways and Lake Eleanor water project service. The amendment will enable appointments until the civil service commission can supply eligibles. The places can be filled by the temporary appointees only 30 days.

The commission also has under consideration an amendment which will enable it to revoke at pleasure any leave of absence it grants. The change consists in adding to rule 26 the words "any leave of absence granted under this rule may be revoked at the pleasure of the civil service commission."

Commissioner Rosenthal, who protested strongly against the proposition to open the examination for assistant chief engineer of the fire department to both the battalion chiefs, the next lower rank, and the captains, last night presented a document setting forth his reasons. The question is now being considered by the attorney, and Rosenthal's reasons will be submitted to that officer.

Rosenthal bases his objections on the grounds that the charter limits examinations to fill vacancies to only the next lower rank, and separately classifies the positions of battalion chief and captain beyond the power of the commission to make such a double classification. He also believes the battalion chiefs have a vested right in having the test confined to that rank. He closed with the observation that no good reason for having the two classes eligible to the examination has been advanced.

The commission will begin a series of noneducational examinations for various mechanical positions under the information furnished in their applications and need not give the commission. A key for the examinations will be adopted at the next meeting of the commission. There are about 600 positions involved, and 25 more classes of noneducational work will be put under civil service rules next week.

Second Batch of Bids for Highway Opened Contracts for \$350,000 Worth of Road Soon to Be Let

SACRAMENTO, Aug. 26.—Forty-three bids for the construction of six separate links of roadway under the \$18,000,000 highway bond issue, amounting to about 56 miles, were opened today by the state highway commission. Contracts will be awarded within a few days. The work will cost in excess of \$350,000. Five stretches of road for which bids were opened are in route No. 4, the general highway from Sacramento to Los Angeles via the San Joaquin valley. The sixth is in route No. 2, the general highway from San Francisco to San Diego via Los Angeles. The five in route 4 are in Mariposa, Merced, Stanislaus and Fresno counties. The one in route 2 is in San Diego county.

BOSTON TO LOS ANGELES STEAMER LINE PLANNED
