

NAVAL APPROPRIATIONS.

The Bill Finally Passed by the House After More Debate.

"Oh! Shame and Hypocrisy, Thy Name is Democracy."

Said Mr. Balford in Expressing His Opinion of the Democratic Party.

A Memorial from Labor Organizations Presented in the Senate.

THE SENATE. Among the memorials presented was one by Mr. Cockrell, from the United Labor organizations of St. Louis, which protests against the attempt of employers, as illustrated by recent events in connection with the glass blowers and other trades, to reduce the compensation of American labor to a point on a level with the average labor of Europe, and praying the passage of laws to restrict wholesale immigration intended to effect a reduction of the wages of American workmen.

Mr. Hutchins opposed the amendment, calling attention to the fact that the cruisers were not to be completed until congress shall have been in session again for fifty days.

Mr. Balford, while declaring himself in favor of making liberal appropriations for the navy, opposed an appropriation for the armament of cruisers until it was better understood whether the vessels would be a success.

Mr. Adams thought that if, according to their contract, the committee on appropriations, this was but an additional reason why they should be furnished with the best guns.

Mr. Sewell denied that the committee on appropriations exhibited the least hostility to building up a navy. He did not believe that there was any animosity of representatives of the navy, who did not esteem the navy and its brave officers, and seek to make it what it should be and what was not.

Mr. Balford offered an amendment authorizing the detail of naval line officers to act as instructors in the various departments of agriculture, provided that the total number so detailed shall not exceed forty.

Mr. Calkins offered an amendment providing for the construction of seven new cruisers. Rejected on a point of order.

Mr. Warner offered an amendment reducing the number of naval cadets one-half.

Mr. Calkins moved to amend the clause prohibiting officers on the retired list from accepting a position in the civil service by the United States by providing that the prohibition shall not apply to any officer below the rank of major in the army or commander in the navy, who has been discharged by reason of wounds received in the service.

The committee then rose and reported the bill to the house, and it was passed—yeas 209, nays 1 (Mr. White, of Kentucky).

Mr. Randall, of the request of the senate for a conference on the joint resolution increasing the contingent fund of the senate was appointed conferees, Mr. Holman, and Mr. Ryan appointed conferees.

The house then, at 4:15, adjourned.

Tariff on Works of Art. The President yesterday transmitted to the house a report from the secretary of state in response to a resolution asking for information in regard to representations made to this government in relation to existing tariff discriminations against the works of foreign artists.

Several communications from diplomatic officers of France and Italy are transmitted, and also a communication from Minister Morton to the secretary of state, in which he says that the increased duty on foreign works of art, which naturally bears more heavily on French artists than on any others, created such a feeling that for a measure of retaliation were contemplated. He did not mean that the French government had any intention of the kind, but that French artists contemplated such action.


