

MINOR LOCAL EVENTS.

The Smaller Happenings of a Day in and about the City. Mrs. Catharine Carragher, of West Washington, died suddenly yesterday of hemorrhages.

Several citizens have complained of a very dangerous hole in the sidewalk at the corner of Fourth and G streets southeast.

In the police court yesterday William Freeman was placed on trial for violating the gaming law, and the case was continued.

John Ows, a colored man, was sentenced to two months in jail for violating the law for robbing the dressing room at the National Theater.

The grand complimentary ball of the Grand Council of the Order of G. W. M. Friends, to be held at the National Hotel this evening, promises to be an enjoyable affair and an honor to the order in this city.

In the police court yesterday the counsel for Butler Malone, charged with shooting at John Willis last Friday night, waived examination, and the case was sent to the grand jury to be tried on a charge of manslaughter.

Hugh Downey, by a bill in equity against Margaret Kine and others, asks for the appointment of a receiver to take charge of the estate of the late Michael Downey, with a view of securing a proper settlement of the same.

The will of Daniel O'Connor, filed with the register, leaves the entire estate of the testator to his widow, Winifred O'Connor, during her life, and the residue to his children.

Rev. Dr. Theodore Appel will lecture upon "The Wonders of the Moon" to-night in Grace Church, corner of Filbert and G streets northwest, which promises to be exceedingly interesting, as the doctor is said to be an eminent lecturer, and was formerly professor of astronomy in Franklin and Marshall college.

In the court in general term, yesterday, Justice James delivered the opinion of the court in the habeas corpus of Wm. M. Bryant, who was discharged from the insane asylum by order of Chief Justice Carter, on the ground that he was held without due process of law. The opinion and decree sustained the action of the chief justice.
