RAID, BUNGLE DEMOCRATIC FRAUDS DISCOVERED.

Feeble Excuses and Explanations—A Mandamus for the Production of Missing Returns—Prosecuting Violators of Registry Law.

COLUMBUS, Ohio, Oct. 19.—The official count of this county was continued this morning. T. E. Powell appeared for the Democratic candidates, and spoke three-quarters of an hour in favor of and urging authorities to the effect that the returns from precinct A, fourth ward, and precinct A, thirteenth ward, should not be counted. They are both Republican precincts.

The returns from the thirteenth ward have been read through the list of Republican candidates, there being a total vote of 700 in the precinct. The original vote sheet had been added to the full Democratic list, with the exception of a few names for whom no returns had been given. This made the total vote a little over 1,000, about 300 more than are in the returns of the precinct as returned. They will elect about the entire Democratic county committee and the board of canvassers, by 45 votes. Myers and Young, Democrats, for representatives, will be defeated.

There is considerable feeling over the discovery of the frauds. The returns have been in possession of the clerk since Saturday. The ticket was read through, and it was not discovered that an addition of 300 had been made to the vote of the Democratic candidates. The addition, however, seems to have been to the entire ticket, county and state. The poll-books were 400 names short of the tally sheet.

Clerk Joyce, Democrat, who has had charge of the returns, has undoubtedly been changed. His theory is that while they were in the hands of the clerk, they were changed during the night by the returning board on Saturday, that some one slipped out with the tally sheet and made the changes in the returns declared to be true. II. J. Oving, Democratic judge, says the figures have been changed since the tally sheet was read through.

An inspection shows the changes and additional tallies to have been made by a different hand from that which made the original tally. The Republican vote in the precinct was 704 or 505 votes and the Democratic 293. The figures beginning the number opposite the name of Hancock, which had been changed in each instance to a figure 5. The work is done in a very bungling manner.

When the board reassembled at 5 p. m. there was a large crowd present. The clerk was announced, and there appeared on the scene the returns from precinct A, thirteenth ward, a bold fraud, which had been consummated since Saturday. LATEST FOREIGN NEWS.

ATTACK ON THE TURKISH FRONTIER IS REALLY IMMINENT.

Victory for French Republicans—United States Officers Applauded—Daring Chinese Pirates—Boycotted a Pan-European—English Political Campaign.

LONDON, Oct. 19.—Despatches from Athens say the Greek army is eager for war, and that the ministers are deliberating inflammatory speeches. The war rumors from the Balkans conflict. A dispatch to the Standard from Pesh states that the Bulgarian troops now mask their movements, and that an attack on the Turkish frontier is really imminent.

The Bulgarian premier, M. Karavel, it is stated, despite the refusal of King Mian to receive an emissary of Prince Alexander, has left for the Serbian capital to propose a joint Bulgarian and Serbian attack upon Turkey. The Serbian minister to England has written a letter to Mr. Gladstone in defense of his country's action. He says that Serbia does not herself desire, and cannot allow Bulgaria, to attain to political ascendancy. He hopes that the present war clouds will clear away and leave cordial relations between the two nations.

LONDON, Oct. 19.—At Rutehik, Bulgaria, the landing and shipment of war munitions by the Bulgarian army is reported. The troops displayed great enthusiasm. The Roumelian frontier is quiet. Several forts are in process of erection. SOFIA, Oct. 19.—The relations between the Bulgarian and the Greek army are reported to be very strained. The Bulgarians are exasperated by Serbia's attitude. A cabinet council was held today, and the Bulgarian government is reported to be determined to resist a violation of their frontier. The danger is at present diverted from Turkey.

VIENNA, Oct. 19.—The situation in the east has again assumed a serious aspect. It is reported that the Austrian government is determined to resist a violation of their frontier.
