## Railroad Meeting at West Liberty.

WEST LIBERTY, Jan. 21.  
Editor HAZEL GREEN HERALD:  
Pursuant to the request of R. M. Pieratt, Senator from the 34th Senatorial district, by letter addressed to Judge Oscar McKenzie and County Attorney W. A. Maxey, asking them to call together the voters and taxpayers of Morgan county to meet at the court house in the town of West Liberty on Monday, January 23rd, 1888, it being county court day, a vast assemblage of the good citizens of Morgan met on yesterday to give vent and publicity to their feelings in regard to the county voting a tax to aid and encourage railroads.

Although the anti railroad men had given considerable circulation to the request of our worthy Senator, and had urged their friends to come out and, by their down cry, crush the people's hopes for aid and assistance by railroad transportation, the men who stood on the outskirts of the citadel of development to give us timely warning of the approach of friends, spread the glad news through the country, telling the people that now was the time to be up and doing and show to the world that they were not opposed to the development of their country.

Promptly at 1 o'clock the meeting of the anti railroad men was called to order, and on motion of W. A. Maxey Judge McKenzie was made chairman, and on motion of W. W. McGuire W. C. Kendall was made secretary.

Speeches were made by Col. John T. Hazelrigg, Hon. W. W. McGuire, Hon. J. W. Kendall and J. W. Steel.

Resolutions were offered by W. A. Maxey endorsing his action of R. M. Pieratt in the stand he has taken in regard to railroad meetings. W. W. McGuire offered as a substitute to the resolutions offered by W. A. Maxey to the effect that we, the people of Morgan county, ask our Senator and Representatives to enact such laws as will enable the people of Morgan county, upon the petitions of fifty land holders of Morgan to the county Judge, to vote upon the question that Morgan county vote a subscription to the capital stock of the first railroad that reaches West Liberty of not exceeding \$100,000 payable in county bonds in thirty years at a rate of interest not exceed six per cent. The vote was taken on the substitute.

Judge W. W. Cox then demanded a count of the vote, and the tellers announced 141 for and seventy-nine against the substitute. The meeting then adjourned. ISRAEL.
