**CONVENTION

**Finish of Dunn-Collins Fight
Locally Comes On
Tomorrow.**

**BOTH SIDES CLAIMING VICTORY
IN COUNTY.**

Convention Will Have Total Representation of Ninety-Nine Delegates if All Attend.

The finish of the Dunn-Collins fight in Beltrami county, which has been particularly warm and interesting for some time past will come with the holding of the county convention tomorrow, when the delegates to the state convention will be elected and the preliminaries to the most sensational fight for the Republican gubernatorial nomination in the history of Minnesota will be over as far as Beltrami county is concerned.

Both sides are claiming the convention as favorable. The Collins men claim a certain victory and expect to have sixty delegates in the convention. The Dunn claims are not so elaborate, but Wm. McCuaig, chairman of the county central committee, who has been handling the Dunn campaign does not admit the defeat of the Princeton man. The convention will be called at one o'clock at the city hall and the preliminary test of strength will come with the selection of chairman. Both sides are straining every nerve and the convention will be one of the most interesting ever held in this city.

It has so far been impossible to obtain any sort of reliable information on the result in the county at large. There is substantially no news from the outlying country precincts and upon this fact the hopes of the Dunn men are built. They say that the country will rally to the Dunn standard with enough votes to carry the day over the victory scored by the Collins workers in Blackduck, Bemidji and a number of the country towns so far heard from. The Collins men who have been working quietly for three months past and have a strong organization, refuse to give out any figures—but state with the greatest apparent confidence that there is no question as to the result.

Telegraphic advices from the various managers in this city to the St. Paul and Minneapolis headquarters of the gubernatorial candidates have claimed the county both ways, but the Collins claims appear to be the strongest and the Twin Cities generally conceded the county to Collins. Discussing the effect of the Collins victory in Beltrami county, the St. Paul Dispatch yesterday contained the following interesting bit of gossip:

"As to Beltrami county every estimate made by the Dunn managers had it as a Dunn strong hold. What makes the loss of Beltrami so keen is that Verity, the 'glad hand artist' of the Dunn headquarters, with another party, conducted the Bemidji Sentinel, and its columns, ever since the campaign began, have teemed with boasts for Mr. Dunn. Mr. Heatwole was understood to be the silent partner in this enterprise."

That there is some little truth in the foregoing the most ardent Dunn men do not deny and there is no hesitancy in expressing the opinion that the Dunn candidacy suffered by its friends in this county as it did in Wadena county and it was freely predicted that C. C. Eastman, the able editor of the Wadena Pioneer Journal who takes an active interest in politics and is a member of the Republican state central committee had met his Waterloo and was no match for Mr. Verity. The county went straight for Collins. Mr. Eastman and his Pioneer Journal are endorsed and for local reasons there are not many tears being shed over the outcome in certain sections of the Dunn camp in this city.

Uninstructed Delegation.



**CONVENTION
TOMORROW**

**Finish of Dunn-Collins Fight
Locally Comes On
Tomorrow.**

**BOTH SIDES CLAIMING VICTORY
IN COUNTY.**

Convention Will Have Total Representation of Ninety-Nine Delegates if All Attend.

The finish of the Dunn-Collins fight in Beltrami county, which has been particularly warm and interesting for some time past will come with the holding of the county convention tomorrow, when the delegates to the state convention will be elected and the preliminaries to the most sensational fight for the Republican gubernatorial nomination in the history of Minnesota will be over as far as Beltrami county is concerned.

Both sides are claiming the convention as favorable. The Collins men claim a certain victory and expect to have sixty delegates in the convention. The Dunn claims are not so elaborate, but Wm. McCuaig, chairman of the county central committee, who has been handling the Dunn campaign does not admit the defeat of the Princeton man. The convention will be called at one o'clock at the city hall and the preliminary test of strength will come with the selection of chairman. Both sides are straining every nerve and the convention will be one of the most interesting ever held in this city.

It has so far been impossible to obtain any sort of reliable information on the result in the county at large. There is substantially no news from the outlying country precincts and upon this fact the hopes of the Dunn men are built. They say that the country will rally to the Dunn standard with enough votes to carry the day over the victory scored by the Collins workers in Blackduck, Bemidji and a number of the country towns so far heard from. The Collins men who have been working quietly for three months past and have a strong organization, refuse to give out any figures—but state with the greatest apparent confidence that there is no question as to the result.

Telegraphic advices from the various managers in this city to the St. Paul and Minneapolis headquarters of the gubernatorial candidates have claimed the county both ways, but the Collins claims appear to be the strongest and the Twin Cities generally conceded the county to Collins. Discussing the effect of the Collins victory in Beltrami county, the St. Paul Dispatch yesterday contained the following interesting bit of gossip:

"As to Beltrami county every estimate made by the Dunn managers had it as a Dunn strong hold. What makes the loss of Beltrami so keen is that Verity, the 'glad hand artist' of the Dunn headquarters, with another party, conducted the Bemidji Sentinel, and its columns, ever since the campaign began, have teemed with boasts for Mr. Dunn. Mr. Heatwole was understood to be the silent partner in this enterprise."

That there is some little truth in the foregoing the most ardent Dunn men do not deny and there is no hesitancy in expressing the opinion that the Dunn candidacy suffered by its friends in this county as it did in Wadena county and it was freely predicted that C. C. Eastman, the able editor of the Wadena Pioneer Journal who takes an active interest in politics and is a member of the Republican state central committee had met his Waterloo and was no match for Mr. Verity. The county went straight for Collins. Mr. Eastman and his Pioneer Journal are endorsed and for local reasons there are not many tears being shed over the outcome in certain sections of the Dunn camp in this city.

Uninstructed Delegation.

"Doc" Falk, the veteran Bagley editor, is in the city today. Mr. Falk says that things political up his way are not nearly so warm as they are down this way. Clearwater county will hold its primaries tonight and Mr. Falk's best opinion of the situation is that the delegation will be uninstructed. It will try to locate a band wagon after it arrives in St. Paul and people up "Doc's" way seem to be largely of the opinion that the politicians are all making a lot of statements they will be unable to substantiate.
