James C. Hooton Dead.

James Cass Hooton died Sunday morning at 7:40 o'clock at the home of his brother-in-law, Robert Norfolk. His death was due to paralysis.

Mr. Hooton was born in Bethesda county, Indiana, January 29, 1844. On June 9, 1880, he was married to Miss Anna Gertrude Hayes, who died five years after marriage. To this union one daughter, Mrs. John J. Skinner, was born and survives. For forty years he was in the employ of the Missouri Pacific railroad as a conductor. In this capacity he enjoyed the confidence of his superiors to a remarkable degree, and at the time of his retirement, he had served the company longer than any other man in its employ.

The funeral was held Monday afternoon at 2:30 from the Methodist church. Rev. C. M. Davenport conducted the services at the church, and the Masons had charge of the services at the grave.
