COL. RYLAND TODHUNTER DEAD

Prominent Confederate Veteran Dies at the Age of 81 Years.

Col. Ryland Todhunter, one of the most widely known Confederate Veterans of Missouri, died Monday morning at his home, Greystone Park, after an illness of several weeks. Col. Todhunter had been in failing health since last fall, but his condition had not been considered dangerous until about ten days ago, when it became apparent that the disease could not be stayed.

Col. Todhunter was born at Oakland Farm in Jassamine county, Kentucky, February 10, 1840. He entered the Confederate service under Gen. Kirby Smith, and was later transferred to the Army of Tennessee under Gen. M. D. Ector, of Texas. He was in the battles of Richmond and Perryville, Kentucky; Murfreesboro, Jackson and Chickamauga, Tenn., serving nearly four years. He was wounded five times and had five horses killed under him while in action. Col. Todhunter was a man without fear. He was a lover of good horses and gained considerable fame as a breeder of pure blood trotters.

Col. Todhunter was married in Lexington, June 30, 1874, to Miss Anna W. Neill, daughter of Major and Mrs. Henry Neill, of Warrensburg, who with three daughters, Misses Elliott, Katherine and Emory, and one son, Neill Todhunter, of Eudora, Arkansas, survives.

The funeral services conducted by Rev. Robt. W. Cowan and Rev. Baxter Waters, were held from the home Wednesday morning at 10:30 o'clock. Interment was in Machpelah.

Elmer H. White, County Superintendent of Schools, spent Friday in the Higginsville Public Schools where Dr. C. A. Phillips, of Warrensburg Teachers College, and Supt. D. W. Branam of Higginsville were giving an Intelligence Test to the pupils in grades 3 to 9 inclusive. Dr. Phillips assisted Supt. P. G. Buckels of Odessa, Mo., recently with a similar test to the pupils in the Odessa Public Schools. As an economic benefit the work in Odessa with the test will save the taxpayers of the district hundreds of dollars because a number of pupils were advanced an entire grade. We are hoping the same results will be accomplished at Higginsville.

Friday night following the extension work in Lexington, Dr. Phillips promised Supt. L. H. Bell, that he would come to Lexington within the next few weeks and assist him with a similar test in our schools here. Therefore, three of our largest City School Systems in the county will receive Dr. Phillips' expert service this term, not to say anything about the valuable service he is rendering us in giving his three extension courses.

In addition to the above services Dr. Phillips has promised County Superintendent White that he will be in Higginsville Saturday, March 12th and address the members of the several school boards in Lafayette county at their annual convention.

TWO FROM CHILlicothe

Wentworth Defeats C. B. C. 36 to 15 And 42 to 11.

Wentworth passed another hurdle in the conference race for basket ball honors this week when she trimmed Chillicothe Business College in two games, 36 to 15 and 42 to 11. Wentworth has now won nine out of ten games played with conference teams. The game lost was to Kemper, and Kemper yet has to be reckoned with in two games before the season closes. These games will be played in Boonville Monday and Tuesday nights of next week.

FIRST GAME.

Wentworth won an easy game from Chillicothe Business College in the local gym Monday night by the score, 36 to 15. The business men started as if they intended to win, making five points before W. M. A. counted once. Then a beautiful basket by Bradfield started things off and at the end of the first half Coach Wikoff's team led 14 to 11. In the second half the Red and White quintet ran away with the game, the visitors making only four more points. Fannin came into his own with seven field goals, while Thunder of C. B. C. got nervous and missed nearly all his free throws. The Chillicothe team resorted to long shots, most of which went wild.

For Wentworth Bradfield and Fannin were the shining lights. Bradfield played a beautiful game all the way through, especially in the first half when he made five baskets. Fannin after a scoreless first period got his eye on the hoop and threw seven goals, several of them from difficult angles. Wenner and Hand guarded well and Pratt fought as usual.

Levi, the big Indian center, was C. B. C.'s only star.
