HOSPITAL PLANS BEING REVISED

Hospital Benefit Association May be The Outcome.

The trustees of the Highland Heights Hospital, Judge S. N. Wilson, B. C. Drummond, and John Chamberlain, together with J. R. Moorehead, Jr., and W. L. Groves, members of the board of directors of the Chamber of Commerce; Mrs. Cornelia C. Cannon and Miss Mary B. Marquis from the B. & P. Woman's Club, and Drs. J. Q. Cope and A. J. Chalkley are busy devising plans for organizing a hospital benefit association.

Some of the essentials of the plans so far worked out are about as follows:

Single memberships at a fee of \$1.00 per month in advance, non-negotiable. Plural memberships at a fee of \$2.00 per month, which entitles members of the family to the age of 18 years, as well as the parents to hospital care. Memberships written on the basis of a year.

Hospital benefits to be derived from such memberships are board and room and service of the floor nurse not to exceed eight weeks. Cases remain as long as the attending physician designates, paying the usual hospital charges beyond that time the same as non-members.

Reinstatement may be made in the matter of lapses not exceeding thirty days, by the hospital trustees, provided the lapsed and advanced payments are made.

As at present, no contagious cases will be admitted.

The Lexington physicians are to alternate by months as house physicians.

Contracts with members will become valid provided the income from such memberships reaches \$400.00 per month.

These plans also include the maintenance of a registered nurse at the hospital.

Presbyterians 14; Christians 1.

The first game in the Sunday School baseball league was played Friday evening at Athletic Park between teams representing the Presbyterian and Christian Church Sunday Schools. Gas Rate To Be Reduced.

The Missouri Gas & Electric Service Company announces a reduction in the gas rate effective July 1st, of 15 cents per 1000 cubic feet. The present rates are \$2.40, \$2.00 and \$1.75. The new rates will be \$2.25, \$1.85, and \$1.60.

Residents of Missouri who are eager to take advantage of the special radio service broadcasted from the Missouri College of Agriculture, the State Bureau of Markets and numerous commercial agencies will be glad to know that trustworthy and understandable information on radio may be obtained at small cost from the Federal Government.

The Bureau of Markets and Crop Estimates, U. S. Department of Agriculture, has established a radio information service. In connection therewith, its first bulletin has been published and others, we are told, are to follow. Persons interested in radio activities may have their names placed upon a free mailing list to receive this material as it comes from the press. Application should be made directly to the Bureau of Markets and Crop Estimates, U. S. Department of Agriculture, Washington, D. C.
