THE DEFICIENCIES.

CONGRESS ASKED TO MAKE LIBERAL APPROPRIATIONS.

SEVERAL BUREAUS OUT OF FUNDS.

An Extra Appropriation of \$300,000 Wanted for Special Agents and Examiners to Investigate Pension Frauds.—The Treasury Department Calls for \$600,000 for Customs Collections.

WASHINGTON, Dec. 13.—The subcommittee of the house appropriations committee has been considering the urgency deficiency bill which, it is expected, will be reported in a few days. Commissioner of Pensions Lockwood has appeared before the committee and urged an appropriation of \$900,000 for special agents and examiners to investigate pension frauds. The public printer has sent in a requisition for \$200,000 for the deficiency of the government printing office. The treasury department wants \$600,000 for a deficiency on collecting customs. It has been the rule of congress to appropriate \$3,500,000, together with an indefinite appropriation for fines, penalties etc., which may accrue to collectors. This has amounted to \$1,250,000 or \$2,000,000 but in recent years it has been cut down to \$1,000,000 and it has been necessary for congress to appropriate from \$4,000,000 to \$6,000,000 for deficiencies. If the present amount asked for is not appropriated the treasury department will be obliged to curtail its custom service, as the department is not willing to create any deficiency. Another item asked for is \$400,000 for the transportation of silver coin.

The commissioner of the general land office asks \$800,000 for special agents. This appropriation was materially cut in the last congress. The land office also asks \$500,000 for contingent expenses. The last congress appropriated \$250,000 for registers and receivers, and provided that enough land office should be consolidated to make this amount sufficient, but the offices have not been consolidated and if the \$500,000 is now appropriated it will be tantamount to changing the law so as to increase the last appropriation to \$750,000.

It is anticipated that the appropriation for clerks of the senate during the recess of congress in 1899 will be attached to this urgency deficiency bill in the extra session of congress, and that it will be one of the contentions of the session.
