WHETHER the Grover Cleveland Democratic party of New York will subserviently ratify the action of the David B. Hill Democratic party remains to be seen, but it probably will. There is little for the Cleveland Democracy to do this year but eat crow and look cheerful.

SATURDAY night all the tinplate plants in the country closed down, and there is no indication as to when they will again be put in operation. There is a wide difference between the manufacturers and the workers on the subject of wages, and the latter insist that notwithstanding the reduction of the duty, the wages agreed upon in June can be paid the rest of the scale year.

It is rumored in Swansea, England, that there is a movement on foot to strike a blow at the tinplate trade of the United States. It being contended that the Americans cannot produce certain plates without Welsh labor, the representatives of labor in Wales are inviting the return to that country of all makers of tinplate in America who have been discharged from their positions, or whose wages have been reduced as a consequence of the adoption of the new tariff.

A CLAUSE in the new Tariff Law renews the treaty stipulation of 1875 by which sugar from the Sandwich Islands is to be admitted free. Some say this is only carrying out the requirements of a sacred treaty. That must be admitted, but is a treaty stipulation with the Sandwich Islands more sacred and binding than the contract made with our citizens by the Tariff Law of 1890? There is no excuse in law, justice or equity for this betrayal of the confidence of the people of the United States. The law of 1894 takes the bounty from the producers of the United States—a bounty which amounts to about \$11,000,000 annually—but carefully secures to the Hawaiian producers a bounty which annually amounts to \$6,000,000. Is it any wonder that the people reject this un-American bill at every opportunity?

WHEN HILL the politician gets up in convention and deliberately repudiates the utterances of HILL the Senator, it means either that he is a trickster in September or that he was a demagogue in June. He indorses now the measure which he then denounced, and slops over with cheap praise for an Administration which only a few months ago he coarsely reviled. Which is a hypocrite and a fraud, the Senator or the politician? Or, inquires The New York Tribune, do they both belong in that class?

At the recent dinner given by the London Chamber of Commerce to Mister Professor WILSON, author of the Democratic Free-trade Tariff Bill, Sir ALBERT POLLITT, in proposing a toast to the guests, said:  
\* \* \* Mr. WILSON's name has become honored and familiar in England. In honoring the guests, they were honoring London, and its Chamber of Commerce asked them to take back with them a message of peace and good will. \* \* \* The new Tariff might not have realized the aspirations of its promoters, but it had established a freer system of trade and substituted a certainty for an uncertainty to the benefit of both countries. Benefits had already been experienced in Wales and Yorkshire, and an impetus had been given to the textile industries. \* \* \*

And a lot more of the same sort. It must be pleasing to the American workman to know that the new Tariff is opening the furnaces in Wales and Yorkshire, even if it is closing them in Pennsylvania. How gratifying to the iron workers of Boyd county to know that there is prosperity in Albion even though there is poverty in Ashland!

**TRAIN ROBBED.**

**Pacific Express Held Up By Three Men.**  
The Amount Secured Not Known, But Believed to Be Small.

A Sheriff Encounters One of the Robbers Who Begun Shooting—The Fire Returned, the Bandit Mortally Wounded—The Others Escaped.

PHOENIX, Ariz., Oct. 2.—The Southern Pacific east-bound express was held up two miles east of Maricopa by three men, two of whom were masked. They boarded the train as it was leaving Maricopa, capturing the head brakeman, who was compelled to turn on the air brakes and stop the train. The engineer and head brakeman, with pistols at their heads, were compelled to go back to the express car and induce the messenger to open the door. One of the bandits then entered the car and searched for valuables, while the others guarded each side of the train. The amount taken is not known, but is supposed to be small. The trainmen were then marched away a short distance and liberated, the robbers mounting their horses and dashing away.

Sheriff Murphy and Deputy Widmer reached the camp of the suspected men seven miles east of the city, about 8 o'clock Monday morning. The only occupant was Frank Armour, a Tonto Basin cowboy, who commenced shooting as soon as the officers came in sight. The officers returned the fire with shotguns, mortally wounding the man. Their horses, which were badly jaded, were found near by, as well as their rifles, but the remainder of the gang had disappeared. Deputy Prothro and a posse are in pursuit, and it is expected will capture them within a few hours. The men are undoubtedly the same who robbed the Congress stage several weeks ago. Some watches taken from street car employees a few nights ago were also found in the camp. The penalty for train robbery in Arizona is death.

**Puzzling Case.**  
ZANESVILLE, O., Oct. 2.—On Wednesday an unknown man, apparently wealthy and refined, was taken from a B. & O. train going east in an unconscious condition. Since that time he has not regained consciousness. His case baffles the physicians, as he is in apparent good health. His identity is unknown.

**Fatal Street Fight.**  
VIENNA, Ill., Oct. 3.—In a battle between Eli and John Ballowe and Alexander and Herbe Hess, the first named was shot twice and instantly killed. Alexander Hess was also hit twice and seriously hurt. The affair took place in one of the most prominent streets in Vienna.

**Secretary Carlisle's Appointments.**  
WASHINGTON, Oct. 2.—Secretary Carlisle Monday appointed F. C. McDowell, of Iowa, chief of the accounts division, treasurer's office, at \$2,500, and E. M. Dickerson, of Arkansas, a chief of division in the office of auditor for the post office department, at \$2,000.

**Cuts His Throat.**  
NEW YORK, Oct. 2.—John F. Matthews, 46 years of age, a son of a well known manufacturer of soda water apparatus, committed suicide in his room at the Plaza hotel at 10 o'clock Monday night by cutting his throat with a razor. He died immediately.

**Second Degree Murder.**  
NEW MARTINSVILLE, W. Va., Oct. 2.—After having been out forty-eight hours the jury, in the case of George W. Huggins, charged with murder of Young Garner, returned a second degree verdict Monday night.

**Tramp Murderers.**  
DELPHOS, O., Oct. 2.—Seven tramps have been arrested for the murder of Edward Burnett, a barber from Grand Rapids, Mich., while traveling on a P. Ft. W. & C. freight. Six others escaped.

**Receipts and Disbursements.**  
WASHINGTON, Oct. 3.—The receipts of the government for the first three months of the present fiscal year amounted to \$79,379,414, and the disbursements \$96,459,129, leaving a deficit for the quarter of \$19,079,710.

**Will Inherit \$20,000,000.**  
LONDON, Oct. 3.—It is announced that Mr. Harry McCalmont, the owner of the famous horse, Isinglass, will inherit, on October 9, property amounting to nearly £4,000,000.

**Gold Coined Last Month.**  
WASHINGTON, Oct. 2.—The coinage of gold at the various mints during September amounted to \$5,033,092, and of silver \$8,765,370, of which \$672,200 were standard silver dollars.

**The Public Debt.**  
WASHINGTON, Oct. 2.—The debt statement issued Monday afternoon shows a net increase in the public debt, less cash in the treasury, during September, of \$8,152,700.84.

**Patrons of Husbandry.**  
FOSTORIA, O., Oct. 2.—The annual state convention of the Patrons of Husbandry of Ohio will be held in this city October 16 and 17. Over 200 delegates will be present.

**Fell Down Stairs.**  
YELLOW SPRINGS, O., Oct. 2.—Mrs. Nick Pentney fell down stairs here and injured herself fatally. She is now in a dying condition.

**Half of the Town Destroyed by a Cyclone.**  
PARIS, Oct. 2.—The Debats has a dispatch from San Domingo stating that half of that town was destroyed by the recent cyclone.  
**Who to Kill the Khedive.**  
VIENNA, Oct. 2.—An Italian anarchist has been arrested in Cairo charged with an attempt to murder the khedive.  
Gen. Antonio Ezeta has arrived at the City of Mexico. He denies that he is going to make war on anybody.

**SUGAR TRUST OFFICIALS.**

They, With Their Brokers, Must Appear Before a Washington Criminal Court.  
WASHINGTON, Oct. 2.—The grand jury of the criminal court of the District of Columbia brought into court Monday afternoon indictments against H. O. Havemeyer and John E. Searles, of the sugar trust, and Allan Louis Seymour, of Seymour Bros. & Young, brokers, of this city.

The indictments recite the organization of the two political parties in 1892, and go into the matter of contributions to campaign funds, national and local.  
Mr. Havemeyer, as a member of the sugar trust, appeared before a committee of the senate on June 13, and in answer to questions propounded as to contributions made by the sugar trust for campaign purposes, promised to open his books to the committee on the following day.

When he again appeared before the committee he declined to submit his books, upon advice of counsel. He said, however, that the trust made no contribution to the national campaign fund, but did contribute to the state fund. Upon his refusal to answer further questions the case was certified by the vice president to the district courts for the action which was taken Monday. Mr. Seymour refused to answer any questions in regard to stock purchased or sold by his firm, and was likewise certified.

Indictments were also returned Monday afternoon against Brokers John U. Macartney and E. R. Chapman.  
The cases of Havemeyer and Searles had been before the grand jury since the early part of last August, and were expected to be brought into court when Messrs. Shriver and Edwards, the newspaper correspondents, were indicted. For some unaccountable reason, however, their presentation was delayed.

The persons indicted Monday will be notified in a few days to come into court and plead, but no further action will be taken until after the demurrers filed by Messrs. Macartney and Chapman, nearly two months ago, have been disposed of. The argument on these demurrers will come up on the 12th inst., and will be on constitutional grounds—that is, the contention will be that the senate committee had no power to compel witnesses to answer questions. In case the demurrers are sustained no further action will be taken in the matter, as the government has no appeal in a criminal case.

Should the decision of the court be against the defendants, the case will be carried to the court of appeals, and if that court decides against them the matter will be taken to the supreme court of the United States. Should the indictments against Messrs. Chapman and Macartney be quashed, the cases of Messrs. Shriver, Edwards, Havemeyer, Searles and Seymour may never come to trial.

**FIVE BOYS KILLED.**

Stealing a Ride, and the Car Leaves the Track—They Were Runaways.  
WOODSTOCK, Ill., Oct. 2.—Five boys lost their lives and two more were injured, one seriously, near this city, on the Chicago & Northwestern railway. The dead are: Territt Davis, Mt. Morris, Ill.; Ed. —, known as "Milwaukee Ed.," Milwaukee, Wis.; Bert Little, Freeport, Ill.; two unknown boys. The injured are: John Grady, Fall River; Sam Newman, Freeport, Ill.; unknown man, leg broken and injured internally. The axle of one of the cars in the center of the train broke. The boys were riding on the top of the lumber inside the car, the car leaving the track caused the lumber to slide over and upon them. Sam Newman and Bert Little, the Freeport lads, were 13 years old. They ran away from home.

**Wholesale Skin Grafting.**

MONTCLAIR, N. J., Oct. 2.—Fred Griffith, ten years old, of Forest street, was badly burned on the Fourth of July by the explosion of a bunch of fire crackers in his pocket, and on Thursday last 100 bits of skin were taken from the arms of two women friends and transferred to his body. The boy's sad plight became known to many of Dr. Case's friends, and Sunday three of them, William L. Marcus, T. L. Sullivan and H. H. Drake, members of the Montclair club, each gave about fifty pieces of their skin to the boy. The doctor estimates that more than five thousand will be used for one leg and one to two thousand grafts for the other.

**Poisoned Lunch.**  
ST. LOUIS, Oct. 2.—George Thomas, a Negro, is under arrest for sending a poisoned lunch to St. Peter's Episcopal church last Sunday, which caused the death of James Cunningham and the almost fatal illness of Franklin S. Beckett, the church organist. In a west end drug store Monday was found a forged prescription for an ounce of strychnine, which the prescription clerk says was sold to a Negro. Thomas was supplanted as janitor of the church by Cunningham six months ago.

**Newsboys Strike.**  
OMAHA, Neb., Oct. 2.—The newsboys struck Monday night and refused to handle Chicago papers, claiming that hotel stands were supplied first, and this did not give them a fair show. The feeling at one time became so strong that the agents were violently assaulted. Outsiders suggested arbitration, which prevailed, the result being a readjustment of affairs satisfactory to all.

**A Tornado in a Kansas Town.**  
WICHITA, Kas., Oct. 2.—A tornado struck the northern part of this city about 3 o'clock Monday evening and tore up property in all directions. Several people were injured, but so far as heard from no fatalities occurred.

**To Be Court Married.**  
WASHINGTON, Oct. 2.—Capt. Wm. P. Vose and Capt. Geo. S. Grimes will be court-married as an outcome of a case on explosions in Chicago and Evans-ton.
