KENTUCKY REPUBLICAN PLATFORM.

We are opposed to the free and unlimited coinage of silver, believing that it would involve the country in financial ruin. We believe in a sound currency and in the use of both gold and silver for coinage, provided always that a dollar in one is made precisely as valuable as a dollar in the other.

We favor a tariff so regulated as to protect the interests of all classes of our citizens upon articles that may be successfully manufactured or produced in this country, thus insuring good wages to the laborer and a home market to the producer; and in connection with this we favor the re-establishment of the doctrine of reciprocity. We believe that such a system will defray every Government expense, gradually liquidate all indebtedness, restore public confidence and relieve to the rear the undue excitement now prevailing concerning the currency. In view of the past financial history of the Democratic party, its devotion to the old state bank system and wildcat tendencies, we affirm that the Republican party can be more safely trusted to regulate the financial system of the Nation.

We favor an American policy which will protect Americans and American interests in any part of the world at all hazards and will sympathize with strongly Republican rather than ignominious monarchies.

With the imports exceeding the exports, something that has not happened since the war, the prospects for the exportation of gold to meet the balance against the United States are good. This gold would necessarily come from the Treasury, which now has \$90,400,000 in its reserve. For the past five months the imports under the new Tariff Law have exceeded the exports by three to four million dollars a month, showing that besides being a revenue failure the new Tariff Law furthers imports as against exports.

In April, 1894, as shown by a statement issued by the Treasury, the imports were \$60,060,037, and the exports \$64,124,812, an excess of exports over imports of over \$4,000,000. For April, 1895, the imports were \$68,575,755, and the exports \$65,253,648, an excess of imports over exports of \$3,300,000. For March, 1895, the excess of imports over exports was \$4,000,000, and since January the ratio has been about that amount.

That shows that the balance of trade is against the United States. It must be paid in gold. There is to be added to that the large sums of money that have to be sent abroad to meet the letters of credit of Americans traveling in Europe, which amount to many millions. These, too, have to be settled in gold, so that the export of the precious metal seems inevitable.

To meet this excess of imports over exports either securities must be sold abroad or gold shipped. There is no great demand for the securities. The Morgan syndicate kept the price of exchange down by getting gold abroad, but now it has almost completed its contract, having but \$7,000,000 more to pay the Treasury, so the necessity for keeping down the rate of exchange so as to prevent exportation of gold is almost ended.

When the syndicate's contract expires gold exports must come in large sums, again jeopardizing the Treasury and possibly necessitating an extra session or another bond issue. Such is the condition that the Administration must face.

PROCLAMATION.

The President Warns Against Giving Aid to Cubans.

Americans Not to Accept Commissions of Warlike Service.

By Enlisting or Procuring Others to Enlist For Such Service, by Fitting Out or Arming Ships of War—All Offenders Will Be Rigorously Prosecuted.

WASHINGTON, June 13.—The president Wednesday issued the following proclamation:

"Whereas, the island of Cuba is now the seat of serious civil disturbances, accompanied by armed resistance to the authority of the established government of Spain, a power with which the United States are, and desire to remain, on the terms of peace and amity; and

"Whereas, the laws of the United States prohibit their citizens, as well as all others being within and subject to their jurisdiction, from taking part in such disturbances adversely to such established government, by accepting or exercising commissions for warlike service against it, by enlisting or procuring others to enlist for such service, by fitting out or arming or procuring to be fitted out and armed ships of war for such service, by augmenting the force of any ship of war engaged in such service and arriving in port in the United States, and by setting on foot or providing or preparing the means for military enterprises to be carried on from the United States against the territory of such government;

"Now, therefore, in recognition of the laws aforesaid, and in discharge of the obligations of the United States toward a friendly power, and as a measure of precaution, and to the end that citizens of the United States, and all others within its jurisdiction, may be deterred from subjecting themselves to legal forfeitures and penalties, I, Grover Cleveland, president of the United States of America, do hereby admonish all such citizens and other persons to abstain from every violation of the laws hereinafore referred to, and do hereby swear them that all violation of such laws will be rigorously prosecuted; and I do hereby enjoin upon all officers of the United States engaged with execution of said laws the utmost diligence in preventing violations thereof, and in bringing to trial and punishment any offenders against the same.

"In testimony whereof I have hereunto set my hand and caused the seal of the United States to be fixed.

"Done at the city of Washington this twelfth day of June, in the year of our Lord one thousand eight hundred and ninety-five, and of the independence of the United States of America the one hundred and nineteenth.

THE CRUISER RALEIGH.

WASHINGTON, June 13.—The navy department officials expect that the cruiser Raleigh will start from New York for Key West Wednesday. It is expected that she will make the trip in about three days and a half.

MISS DODGE MAY RECOVER.

WASHINGTON, June 12.—Miss Dodge (Gail Hamilton), passed a good day, and was much better Wednesday night. Her improvement Wednesday was so marked that her friends, the Blaines, now have hopes of her recovery.

DISMISSED FROM THE NAVY.

WASHINGTON, June 13.—The president has directed that Paymaster H. R. Smith, of the navy, be dismissed from the service, as approving of a record, findings and sentence of a court-martial which tried Smith on charges of drunkenness, absence without leave and scandalous conduct on the China station. Smith has already been turned adrift in Japan.

RESPETS TO THE NEW SECRETARY.

WASHINGTON, June 13.—Senator Morgan called upon Secretary Olney Wednesday to discuss briefly the conditions of our foreign relations. The new secretary has addressed formal notes to the various embassies and legations in Washington, advising them of his appointment, and notifying them that he would be pleased to receive them Thursday at 10 o'clock, a. m.

HAPPY PRINTERS.

WASHINGTON, June 13.—Arrangements have about been perfected to place the employees of the government printing office under the classified service. Rules will have to be formulated in regard to the force to be employed with every session of congress upon the Congressional Record. Upon the adjournment of congress the compositors on the Record will be dropped. They will continue on the eligible list for one year, and upon the reassembling of congress can apply for reinstatement within that time.

Rain in Northern Indiana.

WABASH, Ind., June 13.—This section was visited Wednesday morning by a heavy rain which has worked wonders in reviving vegetation. The wheat and oats were greatly benefitted and the corn is in good condition. The long drought, however, has destroyed the hay crop, there being no timothy or clover left.

A Costly Frigate.

LOGANSPORT, Ind., June 13.—Mrs. Sarah Ronk was given \$400 damages Wednesday in the suit brought by her against Solomon Harness for injuries due to a fright. Harness assaulted Mrs. Ronk's husband, one day last week, and that she was so badly frightened that nervous prostration of a temporary character ensued.

Foreigners' Danger in China.

PARIS, June 13.—The growing anti-foreign feeling in certain sections of China, and especially in the district of Yunnan, leads the Matin and the Soleil to express the hope that the government will take measures without delay for the protection of French citizens in China.

Cut Her Lover's Throat.

Mr. VERNON, N. Y., June 13.—Jutiss Grilla avenged herself upon her recreant lover, Pasquelli Muschito, on Seventh avenue Wednesday, by cutting his throat in the public streets. The girl is only 16, is slight and quite pretty.

THE OHIO G. A. R.

Twelve Thousand Visitors at Sandusky—Addresses By McKinley, Bushnell, Brice and Others.

SANDUSKY, O., June 13.—Twelve thousand strangers are in the city in attendance upon the twenty-ninth annual state reunion of the G. A. R. The department encampment was called to order Wednesday morning in Biemiller's opera house. Addresses were delivered on behalf of the city by Mayor Bouten and by Gen. M. F. Force on behalf of McMeans and John F. Toland posts. Commander Nutt delivered his annual address. The grand event of the day was the parade.

Gov. McKinley, Senator Calvin S. Brice and Gen. Asa Bushnell arrived in this city Wednesday morning and spoke to the veterans at the camp fires Wednesday night. Many prominent men are in the city, among them Col. A. T. Brinsmade, Col. A. L. Conger, Capt. P. H. Dowling and Gen. Keifer.

Mrs. Sarah D. Winans, of Troy, O., president of the State Woman's Relief corps, made her annual report to that body Wednesday morning. Her administration has been a very successful one. She is not eligible to re-election and the fight for the place lies between Mrs. Lena Springsteen, of Cleveland, and Miss Hanna U. Maxon, of Gallipolis.

Killed in a Tunnel.

CINCINNATI, June 13.—R. Thomas, a bricklayer, was accidentally killed Wednesday evening on the L. & N. railroad near Independence, Ky., by passenger train No. 6, from Louisville, due at Cincinnati 7 o'clock. Thomas was a foreman, and arrived from Nashville, Tenn., where his wife and family reside, Wednesday morning.

Poisoned Her Babe.

CLEVELAND, O., June 13.—Mary Flachmyer, a country girl, about 20 years of age, who was charged with having poisoned her babe with paris green, pleaded guilty to manslaughter in the criminal court Wednesday, and was given the extreme penalty of the law, twenty years in the penitentiary.

Found Hanging to a Tree.

GALLIPOLIS, O., June 13.—William Jackson, while driving along the road, found the body of a man hanging to a hickory tree. The body was cut down and identified as that of John S. Ellison, son of Rev. William Ellison. In a fit of despondency Ellison had committed suicide.

Evangelist Phillips Ill.

DELAWARE, O., June 13.—Phillip Phillips, who until a few years ago was traveling over the world in wonderful evangelistic work, is now seriously ill at his home in this city. His numerous exposures brought on an attack of consumption, which may result fatally.

Fatal Runaway Accident.

CANTON, O., June 13.—While attempting to pass another rig on a hill, Wm. McCauley and Charles Myers were thrown over an embankment. McCauley was instantly killed and Myers slightly injured. The dead man was 60, and leaves a wife and several children.

Two Thousand Miners Resume.

GLOUBERT, O., June 13.—Two thousand miners went to work in the Sunday Creek valley Wednesday morning. They based their action on the fact that half a loaf is better than no bread, and expressed the belief that better wages would soon prevail.

Valentine Nominated.

COLUMBUS, O., June 13.—H. E. Valentine, of Bucyrus, was nominated for state senator by the democrats of the Wyandotte-Crawford district in convention at Carey Wednesday evening. A resolution declaring for free silver coinage was adopted.

The Facer, Don Juan, Dead.
