PRESIDENT CLEVELAND is disgusted with public life and expresses his opinions in language more forcible than eloquent. "I shall be glad to get away from Washington," he said recently to a caller; "the whole country seems determined to use me for a spittoon."

A CABLEGRAM from London, under date of Monday, says American railroad stocks became heavy on the Stock Exchange at noon today under the influence of the progress which is being made by the silverites in the United States. The average fall was from 1 1/2 to 3 points.

THE HON. WILLIAM C. WHITNEY, sound money Democrat, in an interview at New York, said that he looked for no compromise at Chicago, and admitted that unless Southern and Western Democrats were disposed to reason with those of the East, he saw no chances whatever for sound money. Judging from the letters he receives he says there is no apparent disposition to discuss the matter. He asserts that a free coinage platform at Chicago will disrupt the Democratic party.

WHY not? A "Practical Farmer" writes from Chesterville, Ind., to The Times-Star saying: "I am not much interested in free and unlimited coinage of silver, as I have no silver bullion, but I find by weighing the United States copper coin that there are just ten to the ounce. I have quite a good supply of copper bullion and can only get three cents a pound for it from junk dealers. Should the Democrats in their Chicago platform endorse free and unlimited coinage of copper I think I shall have to vote the Democratic ticket, as I can then have my copper bullion coined at a clear profit of \$1.57 a pound, which I consider a good investment; it will enable me to lift the mortgage off my farm."

DEMOCRACY—that is, the free silver branch of it,—appears to be in a bad row of stumps. They don't know just where to look for campaign funds. Almost without exception the Democrats who have been contributing members of the party are sound money men and they have given the leaders to understand that they do not propose to contribute toward a campaign that makes the renunciation of their business. Then it is practically certain that the larger commercial interests of New York and other seaport cities, always a fruitful source of Democratic campaign money, will have nothing this year to give to the cause. Little can be expected from Administration appointees, for the Administration has been turned down, and the Federal officeholders know that they are as likely to be displaced under a free silver President as under a Republican Administration.

SENATOR LINDSAY says the Democratic party is going home, that is, as he expresses it, "We are going straight to the devil."

KENTUCKY NEWS.

The Latest News From All Parts of the Commonwealth.

Judge Hall Released.

STURGIS, Ky., July 1.—Judge Hall was arrested Tuesday on the charge of murdering Dr. Stevens, and had an examining trial. He proved that he was at the house of John Gentry at the time of the shooting, and as there was no direct evidence to the contrary he was released. Dr. Stevens, the man who was shot, once spent a term in Joliet prison for performing a criminal operation. Still more trouble is expected over the affair, as each side has a strong following.

Pepper Sued for \$35,000.

LEXINGTON, Ky., July 1.—Thomas C. Barnes, brother of Col. Will S. Barnes, has filed suit against the Security Trust and Safety Vault Co., the assignee of Col. James E. Pepper, for \$35,000 as salary and \$30,000 damages. Barnes says he had a contract with Pepper for five years at a salary of \$7,000 per annum, and in addition Pepper agreed to make for him each year free of cost 250 barrels of whisky.

Shot His Daughter's Lover.

HOPKINSVILLE, Ky., July 1.—George R. Grant, residing near Crofton, fatally shot Charles Lyle, a neighbor. Lyle had been visiting Grant's daughter against her father's wishes, and he had been told to cease his calls, but refused to do so. The shooting occurred during his visit to Grant's house. Grant came to this city, surrendered and was released on bond.

Confessed to Robbing a House.

MAYFIELD, Ky., July 1.—Saturday night the residence of Jack Humphreys, four miles south of this place, was broken into and \$40 taken from the trunk of Ben Humphreys. Zeno Willis was suspected. He was followed and arrested in Murray and confessed the crime.

Splash Dam Destroyed.

WHITESBURG, Ky., July 1.—The great splash dam located on Boone's Fork, belonging to W. S. Wright, was entirely destroyed by the recent high tide in the Kentucky river. A fine grist mill and saw mill belonging to Mr. Wright was swept away. The losses amount to \$4,000.

Fire at the Western Lunatic Asylum.

HOPKINSVILLE, Ky., July 1.—An alarm of fire from the Western lunatic asylum, near this city, was occasioned by the discovery of flames in the roof of the central cook room, which caught from a fire. The fire was soon under control, but considerable damage was done.

Illicit Liquor Selling Cases.

WEST LIBERTY, Ky., July 1.—Circuit court is in session here with Judge J. S. Kenner on the bench and M. M. Redwine prosecuting attorney. There are 95 cases to be tried this term, almost all for the illicit selling of whiskey. There is only one murder case.

Kentucky Chautauqua.

LEXINGTON, Ky., July 1.—The Tenth Kentucky Chautauqua assembly will be held on the Chautauqua grounds again this year beginning Tuesday and continuing until July 10. Dr. W. L. Davidson will again be the superintendent.

Rapid Justice.

PARIS, Ky., July 1.—Henry Pate, aged 20, was arrested in Georgetown for horse stealing and brought to Paris. A special grand jury was impaneled, Pate was indicted, he plead guilty and was immediately given two years in the penitentiary.

Mind-Reader Ready Weds.

LEXINGTON, Ky., July 1.—Thomas Ready (Thomas Y. Dear), the mind reader, and Miss Marie Louise Haley were married at St. Paul's Catholic church Tuesday morning at seven o'clock and left immediately after the ceremony for Chicago.

A Freshet Releases Rafts.

CATLETTSBURG, Ky., July 1.—About 300 rafts reached here Monday and more will arrive Tuesday. The city is full of timber men and everyone is hustling. Ohio river 20 feet 8 inches and falling. Sandy river is falling slowly.

Hon. E. P. Campbell Dead.

HOPKINSVILLE, Ky., July 1.—Hon. E. P. Campbell, lawyer, republican politician and president of the bank of Hopkinsville, died Tuesday afternoon of Bright's disease, aged 64 years. He was elected to the state senate one term.

Geotogian's Suicide.

BOWLING GREEN, Ky., July 1.—Nimrod Haner, a farmer near Franklin, was found in his barn Tuesday morning hanging by a rope, dead. He is 57 years old, had been in poor health and was worried about financial matters.

Capt. Herndon Out.

LANCASTER, Ky., July 1.—Capt. William Herndon said he would withdraw from the race for judge in the Fifth appellate district. He does so for business reasons, not having the time to spare for two canvases.

Held Without Bail.

PAINTSVILLE, Ky., July 1.—Milt Franklin, the young man who killed Tom Stafford, has been held without bail by Special Judge James Goble who said it was a clear case of willful murder.

Woman Killer Acquitted.

PADUCAH, Ky., July 1.—Marshal McCollum, who killed Mrs. Lena Jones, at Kuttawa, last Thursday, was acquitted on examining trial Tuesday, the court holding that it was justifiable homicide.

Died From a Snake's Bite.

MIDDLESBORO, Ky., July 1.—James Wade, of Claiborne county, was bitten by a copper-head snake and died in great agony some hours later.

NO CHANGE.

The Republican Headquarters Will Remain in New York.

The Advisory Headquarters Will Probably Be in Cleveland.

Chairman Mark Hanna Will Divide His Time Between the Two Places—Maj. McKinley Has Not Definitely Decided on His Summer Movements.

CANTON, O., July 1.—The city has settled down to a state of normal quiet after the excitement of the last few days. Maj. McKinley devoted a great deal of time Tuesday to his mail. There were few callers and none of any prominence. Gen. W. M. Osborne, who is to be secretary of the executive committee, left for his home in Boston Tuesday. He will not return here until after the committee has been appointed.

It has been definitely settled that the headquarters of the executive committee will be in New York. Gen. Osborne admitted as much Tuesday. The headquarters of the advisory committee will in all probability be in Cleveland. Mr. Hanna will divide his time during the campaign between Cleveland and New York.

M. J. McKinley has not yet decided definitely what his movements will be this summer. It is possible he will take a lake trip of three or four days on Mark Hanna's yacht, the Comanche, some time in July. He will do this in order to be absolutely free from interruption while he is writing his formal acceptance of the nomination. After this Maj. McKinley may visit Gen. Osborne in Boston for a few days, but the greater part of the summer will be spent here in Canton. All Maj. McKinley's campaign speeches will be made here and as a city of importance during the campaign, Canton will divide the honors with New York and Cleveland. The latest news with regard to Quay is that he will lay aside all feeling that it is claimed has existed between himself and Hanna and will cheerfully accept a place on the executive committee.

SENATOR HARRIS

Will Probably Be Permanent Chairman of the Democratic Convention—Removal of the National Headquarters.

CHICAGO, July 1.—A morning paper says Senator Isham G. Harris, of Tennessee, the chairman of the democratic bimetallic national committee, will probably be the permanent chairman of the democratic national convention. This is a part of the programme of the silver men which includes the removal of the national democratic headquarters to Chicago and the election of Senator Jones, of Arkansas, as the chair-

man of the national committee to precede William F. Harris, Senator Harris reached the city Monday night. He came to Chicago almost direct from Atlantic City, where he has been resting in expectation of the appointment as permanent chairman of the convention. Mr. Harris is said to be a splendid parliamentarian, and when presiding over a convention can not be confused, intimidated or bulldozed. Such a man the silver men claim must be the chairman of the convention, and they further assert that Senator Harris just fills the bill.

The removal of the national headquarters to Chicago, the silver men declare will certainly be accomplished. They say that as Illinois will be the battleground it is necessary that the directors of the campaign be in close touch with the men who are in the field making the fight. The republicans, the silver men assert, would have changed their headquarters to Chicago had they not feared that the eastern capitalists would have refused to make their usual contributions to the campaign fund.

POPULIST CONVENTION.

The Sergeant-at-Arms Takes Charge of the Headquarters in the Lindell Hotel, St. Louis.

St. Louis, July 1.—Sergeant-at-Arms Hugh McDowell, of the national populist convention, took charge of his headquarters in room 356 of the Lindell hotel Tuesday.

The populist managers have secured satisfactory rates from all the roads excepting the far eastern lines, which have not yet consented to the half rate agreement. Applications for rooms are pouring in upon hotel proprietors and indications foretell as large a crowd as attended the republican convention.

Turkish Troops Defeated.

LONDON, July 1.—The Daily News Wednesday publishes a dispatch from Canea, Crete, saying that a body of Christian insurgents have had an engagement with and defeated a body of Turkish regular troops near Boukolica. Seventeen of the troops were killed and many wounded. The Christians captured several guns.

Harris Leaves for Chicago.

PHILADELPHIA, July 1.—National Democratic Chairman William Harris left for Chicago Tuesday afternoon. He was accompanied by Magistrate Charles P. Donnelly and Charles F. Ingersoll, of this city, and a stenographer. A special train will leave here on Friday bearing the delegates to the convention and others.
