ON BOARD U. S. T. LOGAN,
MANILA BAY, Jan. 5, 1900.

We arrived here yesterday about 8 p. m. We are all glad that our voyage is over. I will mail you my notes as I made them on the way.

ON BOARD U. S. T. LOGAN,
IN THE HARBOR OF MALTA,
December 5, 1899.

As we entered the harbor this morning we met a large English warship coming out. This is a fine looking place. There are 9 big warships here besides several torpedo boats. They all, together with the fort, saluted us. We had better believe there was some noise. We are about fifty yards from shore. We will stay here two days to coal.

December 7.—We left Malta this morning at 7:30. I missed my breakfast too. I was reading and waited to finish the piece and when I went up had eaten it all up—but I had a few hard tack so I wasn't left altogether.

December 9.—I wish I could express to you how very enjoyable a trip through this sea is. The atmosphere is so delightfully pleasant, like a pleasant May day at home. We pass such lovely small islands, while today far to the South we can see the coast of Egypt. I spent the greater part of this afternoon drilling my squad on deck.

December 10.—We arrived at Port Said at 1:30 today. We anchored near the entrance of the canal 'til 8 p. m. when we began its passage.

December 11.—We traveled all last night and all day today in the canal; will pass in to the Red Sea before midnight. The canal varies in width from 25 to 50 yards. We passed—or met—several large steamers; we also passed Bitter Lakes, the place where it is said Pharaoh and his army were drowned. We saw a good many camels as we came through and Arabs in their native dress. We reached Suez about 7 p. m. and stopped there a few minutes.

December 12th.—At daylight we could see the shores of the Red Sea far away on either side. At 7 a. m. we passed Mt. Sinai. We soon after passed entirely out of sight of land.

December 14th.—Two months yesterday since I left home. We have awnings all over the ship to protect us from the severe heat. The breezes on this sea are not so pleasant as those on the Mediterranean.

Friday, 15th.—We had a fine rain storm last night. This morning the waves are running high, and while we were drilling on deck one of them, a little higher than the rest, came dashing through the portholes that had been left open because of the heat and more than deluged our bunks. There was a good deal of excitement among the boys today when bugs were discovered in two companies' quarters, not "firebugs," either.

Saturday, 16th.—At 1 p. m. we reached Aden.

Sunday, 17th.—We left Aden at sunrise. I saw more Negroes there than I ever saw before. They are smaller in stature than our American colored people, none of them being over 5 feet in height.

Monday, 18th.—We passed a low-lying coast to our right, which is the last we will see of Africa. I am Sergeant of the Guard today.

Saturday, 23d.—The days have become monotonous, made more so because of the heat. We passed to the South of Ceylon today.

Monday, 25th.—This does not seem much like Christmas. It is much warmer than a June day at home. I know you are having a good time at home today. We had a very good dinner—turkey with dressing, cranberry sauce and rice in addition to our regular rations.

Wednesday, 27th.—We are running along between large islands covered to the water's edge with tropical forests. It is a beautiful sight.

Thursday, 28th.—We began drawing our tropic clothes today. Each of us draws a blouse, 2 pairs pants, 2 suits underwear, 4 pairs socks, 2 light blue shirts, 1 pair leggings, a campaign hat and a pair tan shoes. This afternoon we arrived off Singapore. There is plenty of tropical fruit for sale here.

Saturday, 30th.—At 10 a. m. we drew up to the docks, and our company with several others was allowed to go ashore. We marched in columns of fours through the city. rather tired from our tramp. It was the first time we had been on land for 40 days. Since arriving here we have heard a report that General Lawton has been killed, but hope it is only a report.

Sunday, 31st.—We started on our last run at daylight this a. m. We were said to be within 1 1/2 degrees from the equator. We have only 1,400 miles to go now, and will soon make it, as we have most excellent coal and seem to be going very rapidly.

Thursday, January 4th.—We had gun inspection yesterday. Several of the boys got a calling down for the condition of their guns. They are all on fatigues duty today, getting ammunition out of the hold. We are each drawing 100 rounds of ammunition. About noon we came in sight of the Philippines. All is now hurry and bustle getting ready to land.

Friday, 5th.—We arrived at Manila during the early part of last night. When we arrived to within four or five miles out a powerful searchlight was thrown on us and kept on us till we anchored. Our voyage is at last over and we certainly have had a good one; only 45 days out from New York. Everybody well and in good spirits. I hope to find news from home awaiting me. Write soon to your soldier boy,

The Keystone State will pass down tonight from Pittsburgh. She has a fine trip.

The John A. Wood left Louisville today with 28 boats of coal and 2 barges of steel rails for New Orleans.

There is a fine stage of water now in the Ohio, and with yesterday's rain it will more than likely reach the 40-foot mark.

The W. F. Nisbet, cut down by the ice some time ago below Augusta, will now be abandoned. The Hercules Carrel pumped at and tried to raise her Sunday, but failed. She is fast going to pieces.

A report comes from the Cumberland river that the Lee Line, with headquarters at Memphis, is preparing to put one of its new boats, now building at Jeffersonville, in the Cumberland river as soon as they are finished. It will probably run between Paducah and Nashville, but may extend its trips to Cincinnati, giving direct water transportation to Nashville.

Along the Ohio river for miles may be seen a procession of passing tow-boats heading for Pittsburgh as rapidly as possible with heavy tows of empties. They are hurrying to get there in order to return South with coal on this rise. There is in the pools about 5,000,000 bushels of coal practically ready for shipment, though several tows have left within the past few days with a portion of it.

The rapidly rising river has covered all the coalboats of the Joseph B. Williams' tow that were not sunk at the time of the accident, and has rendered impossible any attempt to recover any of the coal now with steam shovels. The coming rise in the river will render the Williams' loss much greater than it would otherwise have been, as much of the coal will be washed away and the coalboats will go to pieces in the swift current of the higher river.
