DEMOCRACY.

Judge Wall Talks About the Recent Conference of Leaders at Louisville.

Future Policy of the Party on the Money Question—Our Next President.

(Mayville Evening Bulletin.)
As heretofore stated, Judge Garrett S. Wall attended the conference of Democratic leaders at Louisville, last Saturday. In a talk on the subject yesterday he said:

"It was my good fortune to be one of the Democrats invited to that assemblage in Louisville to meet the leaders of the party, and to discuss generally the future of Democracy and the best mode to secure the return of that party to the control of every position within the gift of the people of the State."
How was the attendance, Judge?
"It was the largest and most influential assemblage ever privately called together in the state, every section being represented by some of its best Democrats. It was a veritable lovefest, and an intellectual justification of the recent victories in this and other states. The large banquet hall and parlors of the Hotel House were filled with senators, congressmen, judges, ex-governors and other party leaders. The next president, William J. Bryan, was the central figure, of course, supported by two of his cabinet-to-be, Senator Jones, of Arkansas, secretary of State, and ex-Senator Blackburn, Secretary of War. There was enough talent there to complete the cabinet, and fill all the leading positions, but further announcements were deemed premature. Messrs. Bryan, Jones and Blackburn were the chief speakers and the cause of Democracy and its financial views were never more able presented. All received an ovation, and the cause of bimetallism has never seemed brighter."

What seemed to be the sentiment on the financial question and the tariff?
"Since the Republicans and gold men have announced that in future they will advocate a single gold standard, all lovers of the double standard have turned their eyes toward the Democratic party, and see in that party the only salvation of the country. It was clearly demonstrated that in 1900 the contest would be made by the only two same leaders that they had in 1896, and upon the same platforms, except that the Democrats will insert their single gold standard as their financial plank. The success of Democracy under Bryan seems assured. The promises of prosperity in case of McKinley's election have not been fulfilled. The Dingley tariff is a lamentable failure. The deficit in the treasury increases a million dollars per week. The spasmodic increase of industries has ceased and manufactures are closing. The promising increase of wages has not come, but reductions are made day by day. The quantity of labor and the rate per day. Famine abroad caused an advance in breadstuffs and meats, which gave the farmers fair prices, but the tariff upon all wearing apparel and household goods and farming utensils increased the price so that the benefit to the farmer was lost. The Dingley tariff has caused the foreign demand for our cotton to almost cease, unless it is sold at five cents per pound, which is two cents below the cost of profitable production, and our home manufacturers being heavily protected, and having driven out foreign competition are unable to consume the cotton of the South, and the whites and blacks in all of the cotton states are the sufferers. The lumber trust makes the poor man pay more for the timber in his house. The sugar trust raises the price of his sugar and all things that require it. The iron trust raises the price of iron, and everything made of iron or steel or metal of any kind. The oil trust advances the price of oil. The leather trust of boots and shoes. The glass trust makes you pay more for glass of all kinds, and the whisky and beer trusts make it so costly that you cannot "drown your sorrow." The vegetable and fruits corner the markets and depress prices when the farmer has such products, and enhance the cost of living. The coal trust is supplied. Gas, electric light, water and railway trusts charge what they please, and the humble American citizen must not complain, or, if he does, he is restrained by an injunction. The only trust amenable to the law is the "labor trust." The moment it attempts to force the other trusts to give fair wages to labor, the law is invoked and a United States Judge enjoins and restrains the labor organization from all action. It always judges who hold the appointment for life that issues the injunction. No judge amenable to the people ever issued one. Invoking the power of the court to enable the trusts to violate the law seems to be a scheme of the Republican party to perpetuate its power. It was unknown to Democracy, and when that party is again in power it will cease, and law and justice will be synonymous. This is a plain statement of the case, and we all know it is true. The way to remove it is to stand by Democrats wherever we find them. Stand by them as our nominees, or our elected officials. Patrolize them in every way because they are Democrats, and above all and beyond all, stand by our Democratic papers, county, state, and national. No party ever amounted to anything that did not have the press upon its side to disseminate its doctrines and point out the fallacies of its enemies. The origin of a party voices the sentiments of a party, and it must have the moral and financial support of its party. Think you that the Democracy of Kentucky would have won its fight in November had not Tennessee sent her gallant ex-Congressman, B. A. Enloe, to take editorial management of the Louisville Dispatch, and by his energy, ability and courage make it possible to redeem our state? I don't mean to disparage the country press, most of the local papers did their part. There was not a metropolitan paper in the state, however, but what was fighting the Democracy, and many of the country papers were lukewarm, if not open enemies. Where would Mayor Weaver, of Louisville, have been today

BEAUTY AND FORM IN THE TROTTER.

(Kentucky Stock Farm.)
The value of beauty, form and good gait in the trotting horse was never more clearly exemplified than at the recent horse show in New York. The team Alice Leyburn and George M., that was sold to the Viennese for \$2,000, proved beyond a doubt that elegance, style and beauty are at a premium. This team was not the best at the Horse Show, nor was it even a blue ribbon winner among all comers, and yet a large price was paid for exportation, simply for road purposes. It has been reported that the Paris winners, Emoleta and Mambrino Belle, but Colonel Kip could not be tempted to part with them.

The recent show in New York was a great thing for the trotter, more so, probably, than for any other type of horse, for not only were they shown in light harness, but also were prize-winners in heavy harness, and if trotters in heavy harness had first prizes, not merely because they had reputation for speed and racing ability, but because they were well formed as well. And they sold at the recent sale in New York for the same reason.

No matter how good a race horse one may like, or how much he has won, no owner likes to exhibit before a large and critical audience a horse that is unattractive in appearance, and if breeders in the future will be careful in mating their mares and use good judgment as regards individuality, the type of the American trotter will improve as far as beauty is concerned. During the boom times in the horse business the fact of having form as well as speed was lost sight of in the wild scramble for pedigree alone. The result of this promiscuous breeding had made itself apparent in the trotters of today. We do not mean that all trotters sold on the trotting tracks are lacking in beauty, for the most exquisite mare ever seen in races appeared this year in Ellerbe, but the average campaigner was far from the type of the daughter of Axtell.

LOCAL OPTION OR PROHIBITION.

(Columbia (Mo.) Herald.)
Georgia has defeated a measure which would have made that commonwealth a prohibition state. This result is more significant when it is remembered that Georgia has for years had a local option law and that under this law nearly every county in the State has voted against the sale of intoxicating liquors. It seems, therefore, that in a contest between State prohibition and local option the Georgians prefer the latter.
We believe the decision is right. The liquor question is an important and delicate one. There are few, if any, evils so great as the immoderate use of intoxicants. But the question will not be solved by the intolerance of unreasoning fanatics on either side. No law can long be enforced against public sentiment. In communities where the sentiment is strongly in favor of "no license" it is Democratic to permit the majority to rule. The same is true in communities where the opposite view prevails. Hence the justice and practicality of local option.
Back of temperance reform, as back of all reforms, must be an educated, enlightened public sentiment. Until this is secured it is folly to attempt legislation.

EQUAL SUFFRAGE IN COLORADO.

By Martha A. Bushnell Conine, member of the State Legislature.

In trying to determine the effects of equal suffrage, would it not be well to consider a few of the objections most frequently urged against it, and determine whether or not these objections have been sustained by the facts of the case?
Take, for instance, as objection No. 1: "Men would lose their respect for women. A woman running for office would be liable to assaults upon her character, and a campaign would necessitate her coming into contact with disagreeable and degrading conditions. My own observation and experience do not in the least sustain this objection. The man with whom we came in contact treated us in precisely the same manner which prevails when men and women meet in society, in church, or elsewhere. There were the names of thirty-three women candidates on the ballot at our last election, but notwithstanding the fact that this has been the most exciting campaign in the history of our State, not one word derogatory to the dignity of any one of those women appeared, so far as I know, in any newspaper in the State.

Objection No. 2: "Women would lose her love for domestic avocations, her children would be neglected, and home would no longer be attractive to parents or children. Answer: A true woman's home is to her the first and last concern on earth. Very little else should be required of the mother of young children than their proper care and training. But the mother of young children is by no means the only woman. None of the women elected in Colorado this year have young children, and they will probably enjoy as much of the society of their families as is usual in the average home where the avocations of the different members separate them through the day.

Objection No. 3: "Women of immoral character would be particularly active in politics, and women who are now self-respecting would be contaminated by politics, and become as corrupt as the 'gang' element among the men is now known to be." Answer: The women of the demi monde in Denver declined to register, but were compelled to do so, also to vote, by the "gangs." Their action shows that if left to themselves they would take no part in the election. The most cultured, most intelligent women in the State, are the ones most deeply interested and most active in politics.

The women, realizing their ignorance of political subjects, went to work at once to inform themselves, and in their endeavor to grasp the subject, aroused new interest in the minds of their men friends, and I am positive that this is a better unending line of political methods and of desirable reforms among the men of our State, particularly in our cities, than ever existed before outside the circle of professional politicians.
It would be very strange, indeed, if the women had made no mistakes, but comparing their progress in two years with the results in the previous one hundred years of disfranchisement, they may well be proud of their record.
