A prominent farmer who has been making some figures on the subject estimates that two-thirds of the fattening hogs have been killed in Christmas, and that two-thirds of the pork put up spoiled during the recent warm weather. He further estimates that at 4 cents per pound the meat lost in this county alone was worth not less than \$180,000. If this is true of our county the aggregate loss throughout this and adjoining States is simply enormous. Among the heavy losers in this county were the following parties: W. E. Adcock, 3,000 pounds; E. D. Jones, 4,000; J. P. Nichols, 5,000; J. T. Coleman, 5,000; W. H. Adams, 3,000; J. M. Adams, 2,500; Baker & McHilton, 3,000; Mrs. Knight, 1,000; C. F. Jarrett, 4,500; Dr. E.
