THREE COURTS

To Begin Business At State
Capital Today.

Judges Paynter and Guffy To
Draw For Chief Justice-
ship.

Frankfort, Ky., Jan. 6.—The January terms of the United States District Court, the Kentucky Court of Appeals and the Franklin Circuit Court or State Fiscal Court begin at noon to-morrow. The first and last-named will hold sessions for about three weeks. In the District Court there are no cases of especial note, and the time will be taken up with mountain revenue cases. More than 100 mountaineers, some of them of the type here last winter, arrived to-night to testify in the cases to be tried.

In the Circuit Court the cases of W. H. Culton, Wharton Golden, Green Golden, W. S. Taylor and Charles Finley, charged with being in the conspiracy which resulted in the death of William Goebel, will be called and postponed, the three first-named by agreement and the others because they are fugitives from justice. The terms will be taken up with local cases and the trial of corporations for failure to make proper reports to the State Auditor. There are a number of these cases and Commonwealth's Attorney Franklin will push them.

In the Court of Appeals the appealed cases of Caleb Powers and Jim Howard will be disposed of during the month. The Howard case is to be orally argued.

Justices Paynter and Guffy will draw lots to-morrow to determine which shall be Chief Justice of the court. Both have been on the bench for six years.

DEATH OF TEACHER.

Laytonsville Lady Succumbs to
Attack of Pneumonia.

Mrs. Mary A. Sands died at the home of her brother, Mr. J. E. Saunders, near Laytonsville, aged 65 years.

Mrs. Sands was a native of Virginia and came to Kentucky from Prince Edward county many years ago. For years she had charge of a school near Laytonsville and was a very painstaking and popular teacher. She was highly educated and was a graduate of a Petersburg, Va., college. She had been a member of the Episcopal church for 35 years.

Pneumonia was the cause of death. She was only ill about two weeks. The body was laid to rest in the Ebenezer church cemetery.

RATHER SUDDEN

Was The Death of Mr. Sam'l
Wright.

Mr. Sam'l Wright, a well known and highly respected citizen of Sinking Fork, died rather suddenly at 3 o'clock yesterday morning at his home. Last Friday he was attacked with pneumonia and despite the efforts of his physicians he grew rapidly worse until the end came as above stated.

Mr. Wright was about 55 years old and leaves a widow. He was a member of the Methodist church.

The remains were interred in the Brick Church burying ground yesterday afternoon.

Sinking Fork Couple Married Last
Sunday Evening.

SET FOR TOMORROW.

Examining Trial of Bob Morris to
Be Held.

The preliminary hearing of Bob Morris, charged with the murder of Marion Henderson at Carl Christmas eve, is set for tomorrow before the County Judge. There are a number of witnesses in the case.

TEN YEARS

For Dr. Clark Who Figured in the
Sturgis Tragedy.

Dixon, Ky., Jan. 5.—Never has Dixon seen such a sensational murder trial as that of Dr. W. E. Clark, charged with performing a criminal operation upon Miss Cora Waller, which resulted in her death. The case has been on for the week, and the court house has been crowded daily with eager listeners to the evidence, which at times has been highly sensational.

The evidence in the case was closed yesterday afternoon and the instructions given.

P. B. Miller opened the argument for the defense, and was followed by County Attorney Cinna-mond, Messrs. Bourland, Stanley, Flournoy and Lockett were the other speakers.

The physicians introduced by the defense disagreed with the Sturgis doctors almost diametrically as to the theory of the shock killing Cora Waller.

The case went to the jury at exactly 12 o'clock today. County Attorney Flournoy closed the argument after one of the hardest fought legal battles in the history of this part of the state.

"We, the jury, find the defendant guilty as charged, and fix his punishment at confinement in the penitentiary for ten years," was the verdict. The jury was out three hours.

REPUBLICAN COMMITTEE.

Calls an Early Primary to Nomin-
ate a County Ticket.

The Republican County Committee met Saturday and the Court House Ring rode rough shod over the outsiders who are vainly trying to get on the ticket. Esq. Major and others who wanted a primary in May or June were doomed to bitter disappointment. Not even the forty days time allowed by law, when the primaries are held under the law, was considered short enough, but the primary was set for Feb. 9, but little more than thirty days off. The slate was further fixed up in such a way that the following nominations are settled in advance:

Senator, John Feland.

This leaves the offices of Sheriff, Jailor and Assessor to be contested for.
