FOR KENTUCKY—Increasing
cloudiness and warmer Thursday.

Capt. H. H. Denhardt, of the
Bowling Green company, is a candi-
date for the Democratic nomination
for county judge of Warren county.

Judge H. B. Hines is going into
the newspaper business at Bowling
Green. In connection with C. M.
Coombs, W. B. Taylor and J. M.
Robertson he will start a new paper
to be called the Messenger.

Senator Aldrich and Secretary
Cortelyou joined issues this week
and killed the proposed bill to allow
unstemmed tobacco in the natural
leaf to be sold without payment of
tax.

By a vote of 7 to 6, chairman Mc-
Quown casting the deciding vote,
the Democratic Executive Commit-
tee called a convention to meet at
Lexington June 11. The county con-
ventions will be held on June 6.

A gentleman who was in Paducah
a few days ago says Robt. Hollowell
and wife, plaintiffs in the night rider
cases tried in Federal court at Pa-
ducah, are preparing to bring heavy
suits for slander and defamation of
character against M. E. Webb, of
Trenton, Ky., and also libel suits
against newspapers that printed Mr.
Webb's Clarksville speech.

Lincoln Steffens heads the list of
contributors to the 5th Anniversary
number of Everybody's with a power-
ful exposition of the lives of Pres.
Roosevelt, Secretary Taft, and Sen-
ator La Follette, upon "What the
Matter is in America, and What to
do About it." He has put a lot of
leading questions to these men, and
their answers are wonderfully in-

taken specially for the magazine.
There is also an article by Charles
Edward Russell, "A Burglar in the
Making," which brings to light some
of the horrors perpetuated in the
convict camps of Georgia. Hamlin
Garland carries his psychic experi-
ments into wider and more varied
fields.

Overtures for compromise have
been refused and the defendants in
the celebrated Hollowell cases from
Caldwell county must now realize
for the first time that the doom of
night riding in Kentucky has been
sealed and that the Federal courts
cannot be controlled by procrastina-
tion or sympathy. Judge Evans'
court has done what no court in
Kentucky has ever done before—
brought the defendants in a night
rider case to terms in thirty days
with offers to pay one man and his
family \$50,000 for injuries sustained.
They realize that the slow methods
of procedure in State courts, by
which one absent witness may drag
the case from court to court, will not
avail in a court where justice moves
not only surely but swiftly. The
compromise offers have not only
been refused but it comes from ap-
parently reliable sources that the
Hollowells are preparing for other
suits growing out of the defamatory
utterances of certain public speak-
ers. At last there is light ahead.
Even sympathizers with night riding
are not safe and the strong arm of
the law will fall heavily upon those
who come within its reach.

Tobacco Trust Now In Court

New York, May 19.—Before four federal judges sitting in the United States Circuit Court here to-day will be held the trial of a suit brought by the Government against the American Tobacco Company alleging that corporation to be a monopoly in restraint of trade in violation of the Sherman anti-trust law. The testimony in this case was taken at preliminary hearings before United States Commissioner Shields, as special examiner, the proceedings covering a period of from November last to February of the present year.

**Demented Farmer Who Died
of Starvation.**

Caleb Fields, a farmer who lived
on the Kirkmansville road eight
miles from town, died Tuesday and
was buried at New Barren Springs
churchyard yesterday. He was 54
years old and leaves a family. A few
months ago his mind became impaired
and he refused to eat or drink
and gradually starved himself to
death. His life was prolonged by a
little nourishment he was forced to
take at times, but his aversion to
food became so settled that he expired
from weakness following his re-
fusal to eat.

BANKERS ARRESTED.

**Former Heads of Two Con-
cerns Under Heavy Bonds.**

Owensboro, Ky., May 18.—Spurred
on by the revelation of certain facts
and by a change in newspaper pol-
icy, warrants were today issued for
James H. Parrish and T. S. Ander-
son, former presidents of the recent
Owensboro Savings Bank and the
Davies County Bank. They were
arrested at once, and each gave bond
in the sum of \$15,000. They waived
examining trials.

County Attorney Finn gathered
depositors in his office and the affi-
davits were prepared. The entire
town is indignant against the men,
and charge them with being robbers
of widows and orphans.

COL. JOUETT HENRY

**Placed in Command of Wes-
tern Kentucky Troops.**

Col. Jouett Henry on Wednesday
evening received an order assigning
him to the command of the troops
of the Western Kentucky district.
The same order relieved Maj. Geo.
W. Albrecht, who has been in charge
since Feb. 8, except while Gen. Wil-
liams was in personal command. Other
changes are rumored. It is said
a battalion of Louisville troops will
soon be ordered out, whether to re-
place those now on duty or to
strengthen the present forces is not
known.

**Henry Bowling
Is Held Over.**

The examining trial of Henry
Bowling, col., charged with destroy-
ing the plant bed of Albert Mc-
Reynolds, col., May 9, near the city,
was held yesterday and the defend-
ant held over. The evidence was
circumstantial, but considered strong
enough to hold Bowling.

**Warns Negroes of Woodland
Mills, to Leave There.**

Hickman Ky., May 18.—An anon-
ymous letter was received at Wood-
land Mills, seven miles from here,
warning the negroes of that village
and vicinity to leave not later than
May 20. The letter was mailed on
train No. 53, which leaves Hickman
at 10:30 p. m., and, from all indica-
tions, was mailed at Hickman or
State Line. The negroes seem con-
siderably wrought up over this no-
tice, and it is probable that some of
them will make arrangements to
locate elsewhere in the near future.
