Why it is that in a fight like this that Democrats can not get over their soreness of one year ago, we are unable to discover, unless it is that they are yet mad-- because some hot-headed Democrats can not bear with them and charge them with holding to Republican sentiment. We believe, firmly believe, that is the main reason, because the Democratic party, the Democratic nominee has done every act that these dissatisfied Democrats have demanded. The Democrats who supported Brown last year demanded that voters should elect the county committee, that the Goebel election law should be repealed and that the candidate should receive his nomination fairly. All these demands have been honestly and fairly granted, and now, at the supreme hour of peril, many of them are not in line for the Democratic nominee for Governor of the State. No party has ever made a harder effort or granted more fully the demands of the dissatisfied element, in any State, than has the Democratic party in this State. No candidate ever received a nomination, from any party or any people, on a higher and more honorable plan than did Mr. Beckham. And yet there are men whose heads have whitened in the service of their party who are giving all the aid possible to enthrone the Republican party in this State. We hear them speak of the "crooked deeds of the past," we hear them charge the Democratic party with partisan prejudice in prosecuting a gang of murderers who conspired to murder a Legislature and who did murder our leader and yet we do not hear a single one of them denounce the partisan acts of the other side. Judge Evans, a federal judge, in the city of Louisville is committing the most partisan acts ever known in the history of our State or the annals of partisan demands. The federal court in this State has ceased to be a court of honest enquirer but is being used to advance the interest of the Republican party. Democrats alone are indicted; Democrats alone are prosecuted and convicted for the violation of the federal law that gives special guarantee to negro voters. Under this law Evans is imposing heavy fines and sending Democrats to prison while his Republican cohorts, intimidators, ballot-box stuffers, coercers of negro voters are allowed to go free. The provocation for a vigorous prosecution of the assassins of Mr. Goebel has no parallel in criminal history in the State and while this is true, the Republicans, as a party, assert that these trials are partisan from start to finish; but on the other hand the Republican party is dragging Democrats from their home for the insignificant offense of hiring negroes to stay away from the polls while it permits and condones the act of Republicans to buy them and to drive them to the voting booths and force them to vote the Republican ticket. Men who call themselves Democrats, men who have whitened in the service of their party, who have opposed federal interference at the polls, who believe in State rights are now, by reason of madness, permitting themselves to support and endorse such methods that inevitably rings the death knell of Democratic supremacy in this, the fairest State in the South. Men who accuse our party of being partisan and then support the Republicans on this ground are indeed blind to the real conditions that confront us. Individuals in both parties may go wrong, the parties may drift from the correct path that leads to honor and just results, but should this be the case it does not follow that partisan dealings and prosecutions are a crime in one and a virtue in the other. Mr. Beckham nor his party, stands pledged to any act that disfranchises a single voter, that demands the prosecution of a single individual contrary to the laws or pledged to aid in the liberation of any violator of law, State or federal. He stands for law and order. He stands for the time honored principles of Democracy and his own spotless record as Governor.

HOUSE BILL, NO. 7.

AN ACT to amend section 1460, article 1, chapter 41, Kentucky Statutes, relating to time for opening polls on election day.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

Section 1. That section 1460, article 1, chapter 41, Kentucky Statutes, be amended by striking out the word "seven" and inserting in lieu thereof the word "six" so that said section, when so amended, shall read as follows:

Sec. 1460. The polls shall be opened at six o'clock in the forenoon and kept open continuously up to and closed at 4 o'clock in the afternoon of the same day; and before receiving the ballots of any elector the officers of election shall cause to be proclaimed that such election is opened.

Whereas, A regular election occurs on the 6th day of November, 1900, an emergency is declared to exist and this act shall take effect from and after its passage.
