## Special Registration and Local Option Election.

Voters of Millersburg, Ky.,  
Take Notice.

Notice is hereby given that the County Clerk of Bourbon County has this day delivered to the undersigned Sheriff of Bourbon County a certified copy of an order of the Bourbon County Court which order is as follows:

BOURBON COUNTY COURT.  
March Term, March 5th, 1906.  
G. W. McIntyre, etc., on Petition for a Vote on Local Option in the Town of Millersburg, Ky.

ORDER.  
This proceeding having been docketed and called for hearing, and coming on to be heard, and the petitioners having introduced witnesses in their behalf, and the Court having heard proof, and it appearing to the Court that the signatures to the petition are genuine and that the petitioners are residents of, and legal voters of, the town of Millersburg, Bourbon Co., Ky., and that the number of legal voters who signed the petition herein are more than twenty-five (25) per cent. of the votes cast in the town of Millersburg at the last town election, and that the application for this order is by written petition signed by a number of legal voters in the town of Millersburg equal to and exceeding twenty-five per cent. of the votes cast in said town of Millersburg at the last preceding town election in the town of Millersburg, and all other things appearing from the proof necessary to appear before entering this order, and the petitioners having deposited with County Judge in money an amount sufficient to pay for printing and posting advertisements and the Clerk for making entries in the Order Book.

It is ordered on the Order Book of this Court that an election be held in the town of Millersburg on the 8th day of May, 1906, and that the Sheriff of Bourbon County, who is appointed to hold said election, open a poll at each and all of the voting places in said town of Millersburg, on said date for the purpose of taking the sense of the legal voters of the town of Millersburg, who are qualified to vote at elections for county officers upon the proposition whether or not spirituous, vinous or malt liquors shall be sold, bartered or loaned within the corporate limits of the town of Millersburg, Bourbon County, Kentucky, and the provisions of this law and prohibition shall apply to druggists also.

It is further ordered that the first day of May, 1906, is hereby named and fixed upon as the day for the registration to be held in the town of Millersburg, Ky., of those persons entitled to vote at said election so ordered whose names have not already been recorded on the registration books of the last previous registration of the voters of the town of Millersburg, Ky., which special registration shall be conducted in all respects as required by law.

And this order fixing the day for registration shall be published in like manner as the time and place of holding said election are required by law to be published.

## STOCK AND CROP.

Monday will be county court day at Winchester, Flemingsburg and Cynthiana.

The Burley Loose Tobacco Warehouse Company, at Lexington, sold something over seventy thousand pounds of tobacco Monday. The prices realized averaged better than at any sale during the past four weeks, especially on the low grade of tobacco.

Everything was sold and there were no rejections. The farmers all expressed themselves as satisfied, as the prices was a little over seven cents.

Chas. S. Brent & Bro. furnish us with the following quotations on seeds:

hemp seed, best quality, \$4.00 per bushel; clover seed, \$8.75 to \$9.00; timothy, \$2.00 per bushel; extra fancy export blue grass seed \$1.35 per bushel. Same price to farmers. Seed oats best quality, 45 cents. Hemp is selling on the local market at \$5.40 per 112 pounds; tow at half price.

The Agricultural Department has received from Abyssinia a fine specimen of Grevy's zebra, destined to become the ancestor of a new race of domestic animals, if the experiment proposed by the bureau of Animal Industry proves successful. This is no less than the proposal of a draft animal that will withstand diseases common to the horse and the mule. The cross-breeds of the horse and the zebra is said to be exceptionally hardy and sure-footed. Such "Zebrules", bred in Scotland by Prof. Ewart, are being used as pack animals by the British Animals in India.

Anent the high price of lumber, which in the local markets is selling at from 20 to 50 per cent. higher than a year ago, and in some grades nearly 100 per cent. higher than two years ago, the following is of interest:

Few people realize the rapidity with which the forest of this country are disappearing. The lumbermen of Maine, Michigan and Minnesota, either have sought new fields of operation or very soon will have to do so. They are turning to the immense pine forests of Idaho or the timbered slopes of the Cascade mountains, which at one time seemed to offer an absolutely inexhaustible supply. Even these forests, however, are beginning to recede from the shores of Puget Sound, before the advance of the lumberman's axe. Already vast tracts of land once covered with a dense growth of timber are now stripped of almost all their merchantable trees.
