May Be of Interest Here.

Insurance Commissioner Henry R. Prewitt states that but few reports have been received in the State from those who carry insurance in unauthorized insurance companies. The last legislature passed a law requiring each person that takes insurance in unauthorized companies to report the same upon the first day of July, or within thirty days thereafter, and pay a tax of \$2 upon each \$100 of premiums paid. The law provides a penalty of not less than \$100 nor more than \$500 for failure to make this report. The Commissioner states there is a great deal of this kind of insurance in the State, and many persons will be subjected to the penalty unless the reports are made.

Bourbon Fair Privileges Sold.

Auctioneer George D. Speaks sold at the Bourbon Fair grounds at public auction, Wednesday, the privileges for the week of the fair for an aggregate of \$786. Gov. Beckham at Lexington.

Gov. Beckham opened his campaign at Lexington Wednesday night. He arrived in Lexington on a special train, accompanied by his wife, a number of her friends and several Frankfort politicians. He was met at the depot in Lexington by Mayor Combs and his henchmen and escorted to the Phoenix Hotel, where he received a number of friends, but we are informed by one who was present that the down town reception looked like a frost to him. It was anything but an enthusiastic affair. He was not out to the auditorium where he delivered his speech and could not say how about his reception there.

His speech was lengthy and mainly in defense of his administration and in answering the charges preferred by Attorney General Hays, taking a shot at Senator McCreary as he waded through his manuscript. He did not mention or take a stand on any national question and one would have thought he was running for some state office instead for the United States Senatorship.

We heartily agree with the Lexington Herald when it says: "We should like to see joint debates between the candidates for Senator and also between the candidates for Governor. The voters would be in better position to get the real facts at issue in such a debate than a cavass in which Governor Beckham speaks in Lexington Wednesday night and Senator McCreary answers him in Henderson Saturday night, in which Judge Hager speaks in Mt. Sterling one week and General Hays answer him the next week."

Powers to Be Tried in November.

The fourth trial of Caleb Powers will take place before the Scott county Circuit Court in November, the opening date being yet unfixed.

For the defense will appear Judge James C. Sims, of Bowling Green, Ky.; Samuel M. Wilson, of Lexington, and Judge H. H. Tye and Judge R. S. Rose, of Williamsburg. The latter is a brother-in-law of Mr. Powers.

For the prosecution, Charles J. Bronston, of Lexington; Robert Franklin, of Frankfort; J. K. Hendrick, of Paducah; V. F. Bradley, of Georgetown, and Ben Williams, of Frankfort.
