LEGAL NEWS.
GRAND JURY RETURNS.
The grand jury made its final returns on Friday, finding true bills against the following: Neil Duffy, disseminating a libel; Al Wimer, same; Wm. Truxal, a. b. v. J. Critchlow, f. b. v. J. W. Todd and Jas. Pierce, cruelty to animals; A. W. Kropa, larceny; Wm. Wise, fornication; Emma Eminger, f. b. v. Joe Lewis, f. b. v. Ernest Korn, malicious mischief; Wm. Meichling, fornication; David Thompson, false pretense; John Roth, a. b. v.
Bills against the following were ignored: J. J. Shanor, a. b. v. W. Rodgers, f. b. v. county; pay the costs in bond and return to the grand jury.
CRIMINAL COURT PROCEEDINGS.
Com. vs. A. E. Wimer, jury found him guilty of f. b. v. and disseminating a libel. Tuesday afternoon Wimer was brought into Court and sentenced on the first count to pay a fine of \$25, and to the mother of the child pay \$25, and \$1.25 per week quarterly till the child is seven years old. On the second count he was sentenced to pay \$100 fine, and imprisoned in the work house for 90 days. He was committed from his office as constable of Kams City.
Com. vs. Jack Hanesfahr, desertion, Note Hanesfahr's complaint.
John E. Mader, of the Saxenburg Postmaster, was excused from jury service.
Com. vs. Wm. Wheeler, assault and battery, indictment quashed on motion.
Com. vs. John Shook, of Renfrew, larceny by bailor, jury was ordered to find verdict of not guilty, the charge not being made out.
Com. vs. Edith Smith, assault, not guilty. This was a rather peculiar case. Miss Smith, a school teacher, whipped a pupil, and came before the grand jury which indicted her for assault. The Court ruled that a teacher, or anyone else, is not liable for a whipping, unless it is a cruel and unwholesome one, and that a whipping is not a crime.
The assault and battery and seditious libel cases against George J. Moon and children were settled. The defendants paying the costs and each giving bond of \$200 to keep the peace for one year towards the complainant, and the general public.
Tuesday afternoon Thomas Coxon, Nick Lowers and Geo. Forrester pleaded guilty to burglary committed at the Brown dwelling, in Mercer twp. A plea of not guilty was entered on the part of George Coxon. Bert Thompson, who was also indicted, was taken back to the Mercer County Jail. There he is awaiting a criminal trial.
