A DAY IN THE COURTS

Six Railroad Damage Suits Alleging Personal Injuries Filed.

LARGE AMOUNT OF PROBATE BUSINESS

The Suit of Heitmann vs. Masterson Still On in the Eleventh District Court.

Damage suits for amounts aggregating \$42,000 were filed against the Houston and Texas Central and the Texas and New Orleans Railway companies, alleging various degrees of personal injuries.

The infelicity of married life was also in evidence, there being six suits instituted for divorce.

The Eleventh district court is still occupied with the trial of the case of P. W. Heitmann & Co. vs. Branch T. Masterson.


