In the human-Sennott murder trial at Rutland, a verdict of not guilty was returned on Friday of last week. THIRTY students are in attendance upon the first term of the new Rutland English and Classical Academy. The state quaries in the vicinity of West Pawlet began working on the nine-hour system September 30th. Mrs. W. B. GENTLE of Evansville was seriously injured in a railroad accident in Maryland last Saturday. The buildings of Moses Wheeler at North Troy were totally destroyed by fire on Tuesday night of last week. The Vermont Teachers' Association will hold its fortieth annual meeting in St. Albans, beginning October 24. The funeral of Erick Billings, son of Hon. A TEACHERS' institute was held at Essex Junction last week, beginning on Thursday. The principal address was by State Superintendent Palmer. MICHAEL O'LEARY of Rutland, twenty-six years of age, was killed Saturday afternoon by a barn falling upon him, the foundations of which he was working upon. C. B. PERKINS, proprietor of a dye-house at Brattleboro, has been arrested and held for trial on the charge of having set the building on fire on Tuesday night of last week. The twenty-first annual convention of the State Sabbath-school Association of Vermont is to be held in the Congregational church at Middlebury, October 23d, 24th and 25th. An attempt was made to wreck a Central Vermont train near Grand's crossing, between Burlington and Shelburne, last week Tuesday evening. Some logs were placed across the track. The Bennington knitting industries are being pushed to their utmost capacity. Bradford & Co., the Valentine Knitting Company and Cooper Manufacturing Company are all running overtime. At the funeral of John Bowen, at Manchester Center, Friday, James Kelly of South Dorset, who was acting as one of the bearers, dropped down and expired instantly while in the cemetery and near the grave. It is supposed that he died of heart disease. A DISPATCH to the Boston Journal from St. Albans says the Central Vermont railroad system will this week be equipped with elegant new buffet parlor and vestibule sleeping cars by the Wagner and Co. Car Company. The Pullman contract has expired several months ago and will not be renewed. In the human-Sennott murder trial at Rutland, a verdict of not guilty was returned on Friday of last week. THIRTY students are in attendance upon the first term of the new Rutland English and Classical Academy. The state quaries in the vicinity of West Pawlet began working on the nine-hour system September 30th. Mrs. W. B. GENTLE of Evansville was seriously injured in a railroad accident in Maryland last Saturday. The buildings of Moses Wheeler at North Troy were totally destroyed by fire on Tuesday night of last week. The Vermont Teachers' Association will hold its fortieth annual meeting in St. Albans, beginning October 24. The funeral of Erick Billings, son of Hon. Frederick Billings, took place last week Wednesday at Woodstock. The sash and blind factory of Merrill & Condit at Craftsbury was burned Monday with the stock, loss \$4,000, insurance \$5,000. The president has appointed J. T. Flint postmaster at Derby Line, and C. H. Hill has been appointed fourth-class postmaster at Taffville. DEXTER A. ENGELL, formerly a livery stable proprietor at Bellows Falls, dropped dead on the street last week Wednesday from heart disease. In the county court at Burlington last week Friday, Michael Sullivan was sentenced to seven years in the state prison for the murder of Kane. Hon. D. C. LINSLEY died in New York on Monday of last week October 7, aged sixty-two years. The funeral occurred in Burlington on Thursday. Rev. E. T. SANFORD has declined a call to the First Baptist church at Burlington, owing to his unwillingness to leave St. Johnsbury, and his ill-health. A TEACHERS' institute was held at Essex Junction last week, beginning on Thursday. The principal address was by State Superintendent Palmer. MICHAEL O'LEARY of Rutland, twenty-six years of age, was killed Saturday afternoon by a barn falling upon him, the foundations of which he was working upon. C. B. PERKINS, proprietor of a dye-house at Brattleboro, has been arrested and held for trial on the charge of having set the building on fire on Tuesday night of last week. The twenty-first annual convention of the State Sabbath-school Association of Vermont is to be held in the Congregational church at Middlebury, October 23d, 24th and 25th. An attempt was made to wreck a Central Vermont train near Grand's crossing, between Burlington and Shelburne, last week Tuesday evening. Some logs were placed across the track. The Bennington knitting industries are being pushed to their utmost capacity. Bradford & Co., the Valentine Knitting Company and Cooper Manufacturing Company are all running overtime. At the funeral of John Bowen, at Manchester Center, Friday, James Kelly of South Dorset, who was acting as one of the bearers, dropped down and expired instantly while in the cemetery and near the grave. It is supposed that he died of heart disease. A DISPATCH to the Boston Journal from St. Albans says the Central Vermont railroad system will this week be equipped with elegant new buffet parlor and vestibule sleeping cars by the Wagner and Co. Car Company. The Pullman contract has expired several months ago and will not be renewed. On Saturday of last week Fred Heath of Lyndonville broke into a freight depot by the windows and then unfastened the door. He procured a team and stole eight tubs of butter, which he peddled out at \$1 per tub. He was followed and arrested and the butter was recovered. It is thought that Heath is insane. The fortieth annual meeting of the Vermont State Teachers' Association will be held at St. Albans October 24th. The president of this association is W. H. Sanderson, superintendent of schools, North Attleboro, Mass., recently principal of the high school in St. Albans. The exercises will begin Thursday evening with an informal reception by the president at the high school room. At the Bay State fair, held at Boston last week, the following premiums on butter were won by exhibitors from Vermont: First prize, creamery butter, five tubs, \$50, E. J. Parker, East Ferrisburgh; second prize, \$15, John Reynolds, of Essex Junction; second prize, granulated, \$10, John Reynolds of Essex Junction. Wells & Richardson Co. had an exhibit and were awarded a diploma. It is announced that the case of Henry W. Tewksbury against the Central Vermont railroad to recover \$50,000 damages for injuries sustained in the Hartford accident, which has been on trial in the superior civil court at Boston, has been settled. The case was taken away from the jury, who had been to the scene of the disaster to examine the bridge and the surroundings. It is not known just what sum was paid. Domestic. P. T. FOUR men were killed and twelve wounded in a collision in Ohio, Friday. Two deaths by contact with electric wires occurred in New York last week. The Episcopal convention has been in session at New York for over a week. Two jurors in the Cronin case and three outsiders have been arrested for bribery. CHICAGO has subscribed \$7,000,000 for the world's fair if it is to be held in that city. The seventeenth annual congress for the advancement of women was held at Denver, Col., last week. THE horse Axtell has been sold to Colonel Conley of Chicago for \$105,000, the highest price ever paid for a horse. THE Anthony Loan and Trust Company of Anthony, Kansas, with office in Boston, has decided to stop business. THE international congress party during the past week visited cities in Massachusetts and viewed Niagara Falls. AN attempt was made last Saturday night to steal the skull of Ralph Waldo Emerson. The casket was reached but not opened. THE corner stone of the new World building in New York was laid last week. Thursday, Chauncey M. Depew made an address. A MEETING in honor of "Sunset" Cox's memory was held at New York last week

Thursday night. Ex-President Cleveland and Doctor Knott were the principal speakers. The triennial national council of Congregationalists began its session at Worcester, Mass., last week Wednesday. The French liner "La Bourgogne," from Havre, which arrived in New York on Sunday, had on board Miller's picture, "An Angel," which was recently purchased for the American Art Association for \$100,000. THE Brooklyn Tabernacle, of which Rev. T. DeWitt Talmage is pastor, was burned to the ground Sunday morning, at a loss of \$150,000. It contained the finest organ in the country. This is the second time it has been burned. Foreign. A BASE-BALL league has been formed in England. CONSUL LEWIS of Morocco has been ordered home by Secretary Blaine to explain irregularities. THE czar arrived in Berlin last week Friday and was received by Emperor William, Prince Bismarck and a number of court officials. THE Canadian government announces that it will not issue license to mutual insurance companies to do business on the assessment plan. A ROYAL decree has been promulgated by the king of Belgium in favor of the American mission established in the Congo for the evangelization of the blacks. A CONVENTION between Russia and the Vatican has been signed by M. Isvolski, the Russian representative, and Cardinal Rampolla, the papal secretary of state.
