Many did so, but the jump was a bad one to risk. From the upper story it was thirty feet on the west side, and a plank was laid on which to land. On the east side the creek was only eleven feet from the building. Several persons made the leap for life into the stream and were rescued.

DOMESTIC NEWS.

TERRIBLE FIRE AT BRADFORD, Vt. Hotel Burned—At Least Six Persons Perish—Many Other Inmates Missing.

The Higgins Hotel at Bradford, Pa., was burned early last Saturday morning. At least six persons were burned to death, and the list of injured numbers between twenty and thirty. The bodies of six persons have already been taken from the ruins and were burned beyond recognition. Friday night one hundred twenty-five persons went to sleep in the building, and while it is known that many had jumped from the second and third story windows, it was feared that many others had perished in the flames. It is feared that some of those who jumped into the creek were drowned. The list of injured is a long one. The inmates of the Higgins building were awakened from their sleep by a man who rushed through the hallways, kicking at the doors and calling fire. The men and women rushed into their rooms into the halls, which were already filled with smoke and flames, and the general cry was "Jump from the windows and save yourselves." Many did so, but the jump was a bad one to risk. From the upper story it was thirty feet on the west side, and a plank was laid on which to land. On the east side the creek was only eleven feet from the building. Several persons made the leap for life into the stream and were rescued.
