IN POLITICS.

Congressional Fight Waxing Warm.

The Congressional fight between Mr. Maynard, incumbent, and Mr. Lawless, is getting warmer every day, and these two young giants will probably have the field to themselves.

The voters are waiting to see if any candidate from this side "bobs up" before committing themselves. Some, however, have expressed themselves between the two candidates already announced.

A prominent Charles City man said he wanted a change and thought rotation in office a good thing. He said Mr. Maynard had "done anything in Congress" he didn't know it. Somebody suggested that he had better read the papers. He said he had read them, but the only thing he saw about Maynard was that he favored another prominent public man. But he said probably Maynard worked hard and accomplished much for his district.

The people of this section may want to know something of Mr. Lawless, but all party men know his record pretty well. Personally we know that the second district has no other more active, aggressive or able son than Hon. J. T. Lawless. From what we can gather, the following is a pretty fair sketch of his career:

Hon. Joseph T. Lawless was born on the 2nd day of May, 1866, in the city of Portsmouth, and received his education in the schools of that city.

He had just left school when he got his first glimpse of public life through an appointment as committee clerk of the House of Delegates, in 1883, by the late lamented and beloved J. Bell Bigger. It did not take that experienced and intelligent observer of men long to perceive the remarkable aptitude of young Lawless for public affairs, and quick promotion came in consequence of that recognition.

After serving with Col. Bigger as assistant clerk until 1889, and while only 23 years of age, he was elected by the Democrats of Portsmouth city and Norfolk county to represent them in the Senate of Virginia.

Young Lawless' interest in public life kept broadening, and about the end of his term in the Senate he became deeply interested in Col. O'Farrell's gubernatorial candidacy, and practically managed his campaign in the summer of 1892. In December of that year Mr. Lawless was elected Secretary of the Commonwealth and performed the duties of that office so efficiently and with so much satisfaction to the people of the State that he was elected for four successive terms without opposition and only declined to offer for re-election in 1901 in order that he might enter upon the practice of his chosen profession of the law. While in office in Richmond he found time to attend the law lectures at Richmond College, and he applied himself to that work with so much characteristic earnestness of purpose that he was graduated as Bachelor of Laws in 1895, and after his retirement from the office of Secretary of the Commonwealth he formed a partnership with Senator Geo. L. Jeffries, and with him established a law office in the city of Norfolk.


