Starch Factory for Spokane

Spokane, Wash., May 7.—Louis H. Bearce, largely interested in starch factories in New England, promises a factory at this city if he is assured a sufficient supply of potatoes will be delivered him to keep it running. He has superintended the construction of 14 factories in the east. Mr. Bearce thinks potatoes can be raised cheaper here than in any other section of the union on account of the heavy yield from the absence of bugs.

Charles O. May, president of the defunct Bank of Davenport, was the first to advocate the building of starch factories in eastern Washington, and but for his present troubles it is believed the vicinity would already have several factories.

Preacher Causes Scandal

Marshalltown, Ia., May 8.—The little town of Shellhook has a scandal. The Rev. D. S. Staebler, pastor of the Shellhook Methodist Church, has left town and C. W. Moore, a farmer living near Shellhook, has brought suit for divorce against his wife.

Recently Moore began to suspect all was not right and his suspicions were aroused by finding his wife reading a note that she had evidently tried to conceal from him. Moore's house was searched, a drawer full of notes and letters from the pastor were found. The notes were filled with burning love expressions and some of them named meeting places.

Oakland a Banking Center

Oakland, May 8.—Since resuming business deposits in Oakland banks are exceeding payments by more than \$20,000,000. The banks are overtaxed with work and the forces are working day and night.

Every bank reports a large number of country correspondents added. The city undoubtedly will be one of the leading financial centers of the Coast for years to come.

Shot by Her Mother

New York, May 8.—Miss Agatha Waters, a young member of the "four hundred," was shot and killed early this morning while in bed, by her mother, Mary E. Waters, 52 years old, and wife of a prominent banker. The mother then committed suicide. It is thought the mother was temporarily insane.

Chicago City Hall Unsafe

Chicago, May 8.—The northeast wing of the city hall was vacated today by the public officials, owing to the danger of collapse.

Feeding 50,000 at Frisco

San Francisco, May 8.—Greeley reports that 230,000 army rations are being issued daily to refugees. There are about 50,000 still in the camps and the number is increasing constantly.

Police Battle with Dagoes

Passaic, N. J., May 8.—In a battle between riotous Italian strikers and the police today four rioters were shot and a number of police injured. One rioter is sure to die.

SHOOTS HOLY ROLLER DEAD ON THE STREET

Seattle, May 7.—Franz Franz Edmund Creffield, who calls himself "Joshua," leader of the notorious Holy Roller fanatics, that created so much excitement at Corvallis and other Oregon towns three years ago, was shot and instantly killed on First Avenue this morning by George Mitchell, a Portland young man, who accused Creffield of influencing and running two of his sisters. Mitchell made no effort to escape and coolly submitted to arrest by Patrolman Le Count and Deputy Sheriff Sam Hath. Soon after being placed in jail young Mitchell sent this remarkable telegram to O. V. Hurt, father of Creffield's wife, at Corvallis:

"I got my man. I am in jail here. "George."

The shooting occurred on the side walk directly in front of a drug store and was witnessed by Creffield's wife and other persons who were passing along First Avenue at the time. Mrs. Creffield was holding her husband's arm when he was shot. The bullet penetrated the brain.

Portland, Ore., May 8.—Creffield claimed to be "Joshua," the High Priest, and stated that at some future time he would become "Elijah" the Restorer. His work was to lead the twelve tribes back to Jerusalem, where the restoration of all things would take place and a millenium reign on the earth. His creed was a mixture of free law and fanaticism. Creffield organized his religion in 1903. Several of his followers went insane, among them Mrs. O. V. Hurt, at whose house Creffield made his headquarters and whose husband saved Creffield from a mob.

After the San Francisco fire in 1903, all of their furniture was offered as a sacrifice, and on November 16 they burned cats and dogs alive. Creffield saying it was God's will. On January 5, 1905, citizens, tarred and feathered the leaders and drove them out of town, warning them never to return. Creffield started Corvallis last week by predicting a worse earthquake than that in California, in which the entire town would be swallowed up.

MRS. DOWIE JOINS SALVATION ARMY

Chicago, Monday, May 7.—Mrs. Jane Dowie wife of "Elijah," has joined the Salvation Army. She has been assigned to work in Ravenswood, a Chicago suburb. Mrs. Dowie stated that she will not take up her duties until fight over Zion City is finished. "I was always an admirer of the Salvation Army methods of doing good," said the First Apostle's wife. "And even if Dr. Dowie is successful in retaining control of Zion City I may enter the ranks of Gen. Booth."

Word of the seriousness of Dowie's health and his sudden breakdown reached the Voliva cabinet and all further war measures were halted.

How to Wash Fine Linen.

As to how fine linen should be washed and guarded a large linen manufacturer gives some excellent hints. He advises the best of washing soaps to begin with. Soaps full of alkali discolor linen. It is better to wring linen by hand or at least have the roller of the wringer fairly loose. Be sure that the rinsing process is thorough. A great improvement in doing up linen is this stock: Dissolve one ounce of gum arabic in half a pint of warm water, add one tablespoonful of the solution to a quart of water and wring out the linen in the mixture.

A Versatile Housemaid.

A clever housemaid employed by a family who took to motoring was told by her master that if she proved as good a chauffeur as she was a housemaid he would employ her to drive his car. She took him at his word and learned motor mechanics, and now at a fine salary she combines the two posts. She is a capital driver, can do most repairs and after overhauling her car at the end of a day's run waits at the family dinner table.

HOLY DAY IS DESECRATED BY Y. M. C. A.

Bellingham, May 8.—Because painters worked all day Sunday on the interior of the handsome Young Men's Christian Association building in order to have it ready for occupancy at the time agreed on, a resolution was passed by the Ministerial Association at the meeting this morning condemning the officers of the organization for permitting the Sabbath to be desecrated in such a way. The committee having in charge the matter relating to Sunday closing was instructed to look into the matter, and if possible prevent any recurrence of the desecrating of the holy day.

In view of the fact that the Y. M. C. A. is a Christian association, say the ministers it is the duty of the officers to respect the laws of the church. In permitting work to proceed on the building on the one day in the week that is sacred to them, the ministers say the leaders of the association are working directly in favor of one of the conditions that they, the ministers, are struggling to overcome. It is the day of worship they contend, and when one of the leading Christian organizations in the country will use it as a day of labor it is time that some action be taken to stop the practice.

Secretary Moss of the association stated this morning that the building is not the property of the organization, in view of the fact that the contractors have not turned it over. The work is entirely in the hands of the men who have taken the contract to put up the structure, and Mr. Moss says he cannot see why he should be criticized because they are carrying on the work on Sunday. No conditions were made in the contract as to what days of the week the men should work. If there were any occasion for it, says Mr. Moss, the contractors could be asked to cease working on the Sabbath, and it is possible that they would comply with the request, although it put them back in their work.

CITY BEAUTIFUL PLANS.

New England Town Urged to Emulate Toronto's Civic Progress Scheme.

The idea of the city beautiful has spread rapidly all over the United States. It has even spread to Canada, and the city of Toronto is now giving the world an object lesson in the art of city beautification, says the Sun of Lowell, Mass.

Toronto took its cue no doubt from such cities as Cleveland, which has spent very large amounts for this purpose, and the example is having a magnetic effect upon other cities. The Ontario Association of Architects has prepared a plan for the civic improvement of Toronto. This plan is one that if adopted will call for systematic work through a long period of years. That is the only way to work out a definite scheme of development.

The cities that work without such a plan spend their money to no effect. It often happens even with ourselves that one city official will go to great expense to undo what some predecessor accomplished at equal expense. Thus we find that lack of system is costly and that without it there are many loose ends that go to waste. The money laid out in developing a well devised plan of improvement is not thrown away. Little by little the results appear, and in the end the city will have reason to be proud of the finished design.

When a board of architects, landscape gardeners and engineers goes to work to devise public improvements with a view to beautifying the city they can lay out a plan of what the city should be. Then let the city take up its plan and work slowly, it may be, but nevertheless steadily, in that direction. This is the way in which some of the most beautiful cities in America became the models that they are. It is a wholesome and salutary thing to keep before the government of a city some plan of public improvement sufficient to inspire them to heroic effort in the right direction. In this way with a city as with an individual a great deal more can be accomplished than by haphazard, unsystematic and desultory effort. It is time Lowell embarked in some movement of this kind.
