Grain and Produce

CHICAGO, July 30.—Anxiety over shipping complications due to the switchmen's strike did a good deal Saturday to cause an all-round advance in values of grain and provisions. Corn finished strong, 3/4 cents to 3/8 cents net higher with September \$1.63 3/4 and December \$1.19 1/4 to \$1.19 3/4. Wheat closed unsettled, 3 cents to 5 cents up to \$2.60 July and \$2.29 September. Oats showed a jump of 1/4 cents to 1 1/2 cents, and provisions 10 cents to 20 cents.

New York

NEW YORK, July 30.—Briser trading and a firm tone marked the New York stock market Saturday and the list had an upward tendency from the opening. The short session showed great strength in some of the industrials, rails and other issues, while some of the specialties and motors were much stronger than had been the case during the earlier part of the week.

Oil and Gas.

The week of development work in the Eastern fields closed as it began and continued without a sensational feature. Large producers had no place in the list of completions, neither were any important as to location. With all the work under way there is no section that promises to supply an appreciable amount of new production. Except for the Berea grit field in Kanawha county, West Virginia, the average size of all completions is very small. The sections that show an increase in production are the gas areas. The gas companies are very active in development work in order to have the supply equal the demand for domestic consumption during the coming winter. Operators are now making a determined effort for new gas territory in Lewis, Braxton and Jackson counties in West Virginia. It is realized that West Virginia has more prospective gas territory than any other state in the Eastern fields.

The rounding out of the week brought nothing better than light wells. Operators are making no great effort to find new producing territory. The uncertainty as to what if any action the government may take relative to the industry has made operators skeptical. The consumption is much greater than production at this time and the difference will grow greater unless operators have some assurance that no drastic measures will be adopted. On Bartholomew run, Mannington district, Marion county, West Virginia, the South Penn Oil company completed in the Big Injun sand No. 12 on the E. A. Blackshere farm. It is located in defined territory and good for 25 barrels a day. On Miracle run, Battelle district, Monongalia county, the company's No. 2 on the J. and A. Fox farm had stopped producing and was shut. When put to pumping it produced five barrels a day. On Elk river, Big Sandy district, Kanawha county, the Summit Oil and Gas company drilled a test on the Jas. Young farm through the Weir sand. It is a gasser with a capacity of 1,000,000 cubic feet a day. This location is 1,000 feet east of the United Fuel Gas company's test on the W. D. White farm. Davidson & Gates have the rig completed for a test on the E. A. Woodal farm. On Indian creek, Elk district, Kanawha county, the Ohio Fuel Oil company completed No. 31 on the Charles Hunt farm. It is good for 15 barrels a day. The same company drilled No. 1 on the Isbell Myers farm through the Weir sand. It will make a 10-barrel pumper. McClellan district, Doddridge county, the South Penn Oil company drilled No. 5 on the Iven Hutson farm through the Big Injun sand. The hole drilled 2,000 feet with fluid. In Burning Springs district, Wirt county, the same company completed No. 10 on the E. M. Wilson farm. It is a five-barrel pumper in the salt sand. In Eagle district, Harrison county, the Philadelphia company drilled a test

on the Tetrick farm, located on Jones run, into the Big Injun sand and the hole has filled up 1,800 feet with fluid. On Salem Fork, Ten Mile district, Ernest Randolph's test on the T. H. Williams farm is dry in the Gordon sand and drilling to the fifth sand. On West Fork river, Union district, the Philadelphia company's No. 8 on the W. B. Maxwell farm is good for 10 barrels a day in the Gordon sand. In Court House district, Lewis county, the South Penn Oil company is testing in the Big Injun sand No. 1 on the Michael Mertz farm in Hackers Creek district the Carnegie Natural Gas company drilled its test on the M. O. Brown farm to a depth of 4,564 feet. The hole was abandoned, having found neither oil or gas. In Court House district the Hope Natural Gas company drilled its test on the L. J. Lough farm to a depth of 4,423 feet. A light gas pressure was developed in the fifth sand. There is considerable interest centered in the efforts making in Braxton county. In Salt Lick district, the Clayton Oil and Gas company completed a test on the Jeffre heirs' farm, getting a light gasser in the Big Injun sand. The Philadelphia company's test on the W. L. McVeauley farm is a gasser in the same formation. On Big Isaac creek, Greenbrier district, Doddridge county, the Hope Natural Gas company is giving its test on the J. G. Reynolds farm a try-out for oil in the Big Injun sand. On the North Fork, Grant district, Wetzel county, the same company is testing for oil in the Gordon sand at No. 1 on the E. C. Snodgrass farm. On Frozen Camp run, Curtis district, Boone county, the Ohio Fuel Oil company's test on the William Burdett farm is dry in all sands. On Elk Fork the United Fuel Gas company's test on the G. W. Lance farm is a gasser in the salt sand. In Court House and Freemans Creek districts, Lewis county, the Philadelphia company is drilling and starting about 20 wells. In the same districts the Hope Natural Gas company has the same number under way and starting. In Middle Fork district, Randolph county, the Hope company is down 385 feet at its wildcat on the Mayton Lumber company's tract. In Buckhannon district, Upshur county, the Philadelphia company is drilling at 4,250 feet at a test on the S. and O. Leonard farm. In Union district the company has started to drill a test on the T. W. Simons farm. On Pickenpaugh run, Grant district, Wetzel county, the Consolidated Oil company is rigging up at a test on the J. L. Stevens farm. On Sugar creek, Center district, the Manufacturers' Light and Heat company is drilling tests on the Nicholas Kiger and S. J. Talkington farms.
