KNIGHTS OF THE SAW ORGANIZE

Form a Local Union to Protect Their Rights and Uphold Eight Hour Day.

The carpenters of East Roundup who met several weeks ago to organize a local union, received their charter this week recognizing them as a part of the United Brotherhood of Carpenters and Joiners of America and will hereafter be known as Local Union No. 1783. Geo. Olmstead has been elected temporary president and E. H. Elsmann secretary, permanent officers to be chosen at some future meeting. The union will meet every first and third Saturday in the month.

Considerable scabbing has been going on here in direct violation of union principles and the local men have found the move toward organization necessary. Carpenters have been shipped in from the East not familiar with conditions here who have been in the habit of disregarding the eight-hour law, which obtains in this state, and also working for less than the scale which has had a tendency to demoralize wages in general. The working man of today is entitled to a fair compensation for his labor and an eight-hour day, which is not only provided by law, but recognized in all trades, and the union men feel that this discrimination is unfair. The union does not deny a man the right to come here to earn a living, but does insist that he affiliate with them and live up to union principles, thereby protecting his own rights and those of his fellow workmen, as well as shutting out incompetent men.

At a meeting of the union Wednesday evening the following resolutions were adopted in regard to the eight-hour day:

RESOLUTIONS

BE IT RESOLVED That we, the undersigned, recognize and uphold the eight-hour law in the city of Roundup, Montana.

BE IT FURTHER RESOLVED That we declare anyone unfair that is opposed to it.

DAILY MAIL SERVICE SOON

Congressman Pray Takes Up Matter of Regular Mail Service With the Department.

The petition which was recently circulated in East Roundup for improved mail service has already born fruit and powers are now at work bringing about the desired change. The editor of The Record is in receipt of a letter from Hon. Charles N. Pray, to whom the petition was addressed, which reads as follows:

House of Representatives U. S. Washington, D. C. April 28, 1908.

Mr. A. W. Eiselein, East Roundup, Mont.

Dear Sir:— I just received your letter enclosing petition, signed by a large number of citizens of East Roundup, asking me to use my influence with the Post Office Department for the establishment of regular mail service on the C. M. & St. P. R. R.

I have carefully noted the contents of your letter and the petition and shall be pleased to take up this matter at once with the Department and do the best I can to assist in carrying out the wishes of the citizens of East Roundup. I will also clip from the paper the articles you have written in reference to this matter and send them in to the Department in order that the Officials there may fully understand the public interest that is being taken in the proposed change of service.

As soon as mail service is established on the train all mail intended for both the old and new town will be handled at the local postoffice thus eliminating all likelihood of mixups. A rumor is in circulation to the effect that the office at Old Roundup is to be abolished and a rural free delivery route established up Half Breed creek from here, which would give those people a much better service than they are now getting. Another move is said to be on foot to have the local office and station changed to an entirely different name. Either change would be preferable to the present condition of things, and something of this sort will undoubtedly be done as soon as the new service is established.
