WILL BE GIVEN FOR BENEFIT OF TONOPAH'S FREE LIBRARY.

There will be a concert at Eagles' Pavilion at 3 o'clock on next Sunday afternoon for the benefit of the free library. This will be the second of a series of Sunday afternoon concerts which were started about a month ago.

Three degrees will be conferred and after the secret work of the order is dispatched the knights will be entertained with a banquet. Carpenters' hall and the basement dining room has been engaged for the occasion and all members may be assured that the degree work will be equal to the best. ## ENGINE RUNS WITHOUT SMOKE.

Novel Device Tried on New Haven Does Away With Nuisance.

NEW HAVEN, Sept. 19.—The New Haven road put its new smoke and cinders eating apparatus in operation today on the 3:10 o'clock train to Springfield. According to those who were on the train it worked to perfection. Not a cinder nor a cloud of smoke was noticeable. For several weeks Carl Schreider and another Austrian inventor have been working on a device of their own which has been adopted on the European railroads for consuming smoke and cinders and which they had to accommodate to American engines.

The device draws the smoke and cinders from the firebox into a compartment where they are consumed. This consumption produces extra heat which is also utilized.

## MINERS IN MICHIGAN.

Advance figures from the annual report of the mine inspector of Houghton county, Michigan, in which the principal mines of the Lake Superior copper district are situated, indicate that there are 17,000 men employed in the mines in that portion of the district. A year ago the number employed in the same territory was 16,000. As more men are employed than ever before in mines in Ontonagon and Keweenaw counties, which, with Houghton county, make up the entire Michigan copper district, the total working force of the Lake Superior copper region is the greatest in its history.

## CHARGED WITH EMBEZZLEMENT

GOLDFIELD, Sept. 19.—Charged with the embezzlement of \$663.50 belonging to Mrs. Jennie Donehoo, a nurse, H. T. Weldon, of the Koenig-Weldon company, a brokerage firm at 523 Main street, was arrested Monday evening and released on \$1000 cash bond, pending his hearing, which was set for Friday.

Mrs. Donehoo says that she left with Weldon, in June last, 1100 shares of stock which he was to sell and invest the proceeds in other stock which she directed him to buy. According to her story, Weldon admitted having sold her stock in June, but kept putting her off as to the reinvestment of the money in the stocks she told him to buy, saying that the certificates had not come. Finally, September 13, Weldon admitted to her that he had neither the money nor the stock, and that he could not pay her before December, and would not pay her then if she told about the matter to any one. Mrs. Donehoo, who is a hard working woman and is determined to have her rights protected, at once saw the district attorney, and a complaint was issued.
