FRANK GOLDEN—PUGILIST.

Late arrivals from Reno announce that Frank Golden, president of the Nye and Ormsby county bank, North Star Tunnel and Development company, Rescue Consolidated Mining company, and proprietor of the Golden hotel in the riverside city, has been wearing two beautifully colored optics, one of a blue shade and the other colored black. The painting was the handiwork of a couple of journalists with whom the financier had engaged in an argument.

The engaging in a bar room fight does not appear to speak very flattering for a bank president who took such a personal interest in the affairs of the institutions, that his own fortune was sacrificed that the depositors would receive dollar for dollar. Yet this is what Golden has done—according to his story as published in one of the Reno papers, but contradicted by the depositors.

We would think a president of a bank would think twice before frequenting bar rooms, for he is setting a very poor example for his employees, who were not allowed that privilege. But things have changed during the last year and it would not be surprising to hear of Golden engaging in a one round go with some street sweeper or peanut vender who had lost their savings in one of the string of banks of which he was the chief executive.

A TICKET WITH BACKING.

"There is security with numbers" says an old quotation, taken from somebody, possibly Napoleon or Alexander the Great, and this appears to be the belief of Frank Golden and Oscar Smith, the president of the Rhyolite National bank and the Eureka bank, both of which suspended last month. It is understood that "Honest Tom" Riskey will soon join the Reno colony and that the three will proceed to arrange a ticket for some of the chief state and national offices at the coming campaign. According to rumors sent out from the city of divorcees, Riskey will be a candidate for United States senator while Golden will go after Bartlett's job. Smith, who is the last to join the defunct bank presidents' club, will have to be content with a state situation and may scrap for the gubernatorial toga.

The slate should be a sure winner for the money of the many depositors will be back of the candidates. Just what political party the three will affiliate with is a matter of conjecture, but it is probable that Hearst's Independent party will be adopted, now that William Randolph has again taken up the standard of democracy.

A CHANGE NEEDED.

It appears somewhat strange that the telegraph offices at Carson City, the capital of the state of Nevada, close each night at 8 o'clock. In many instances business matters come up after nightfall and when an attempt is made to communicate with some state official, it is impossible to do so, and the message must wait until morning. Only recently a local attorney had important business to transact at Carson, but there was a possibility that matters would be delayed, and he sent a dispatch to find out. The telegram was sent in the morning, but no answer was received by train time and he was forced to take the train. On arriving at Carson he was informed that his matter had been postponed for a week.

Now that the Postal lines have been extended into Carson, there is a possibility that the hours of closing will be changed from 8 o'clock until later, in order to accommodate the telegraphing public.

MUCH MYSTERY IN DEATH OF MAN AND WOMAN

J. SWARNER AND UNKNOWN WOMAN BELIEVED TO HAVE BEEN DROWNED.

It is now believed that a man and a woman were drowned with the horses near the old James Say ranch on the Humboldt river, near the point where the river flows from the Humboldt to the Carson sink.

The team of horses and the overturned rig were found in the water on last Tuesday and all attempts at that time to find the body of the driver was fruitless.

Sheriff Wightman of Churchill county with the officers of Humboldt county, have gone to the scene and they now have reason to believe that a man and a woman were drowned.

It is now the belief of the officers that a foul murder was committed and that after disposing of the owners of the team the murderers drove the horses into the river to get rid of them.

There is another supposition that the man and woman were driving across the river when the rig was

overturned and they were drowned, and that the horses became entangled in the harness and could not get out of the water.

A camp outfit was near the scene and a trunk was broken open by an officer. In it was found a bank book showing that Harry Swarner had on deposit in the Inyo bank at Bishop, Cal., \$1,380. A lady's back comb and some apparel would seem to indicate that there may have been a woman with the outfit.

A telegram was sent to Bishop and a reply came to Lovelock that Swarner was known there but did not seem to have any relatives. The letter to the sheriff did not give many details, but asked if the sheriff thought it best to go to the scene and drag the slough in an attempt to find the body or bodies.

The place indicated is a few miles from Plains in Churchill county and is difficult to reach except by going around by the railroad.

COUNTY FUNDS SAVED.

It is understood that Judge Breen has ordered Received Reynolds of the Eureka county bank to release the funds of that county deposited in the defunct bank amounting to \$29,164.64, and that the receiver has paid the same over to the county treasurer. This action is certainly commendable and should meet with general approval.
