## EDITOR NOT INFALLIBLE.

The following is from a recent issue of the Dickson, Tenn., Herald, and evidently has a man as editor who believes in speaking out straight from the shoulder. Any editor is to be admired who has opinions of his own and who is not afraid to express them:

"The Herald is here not alone to publish the news of the county, but to make such comment as it sees proper, from time to time, touching all public questions. It does not claim a monopoly on originality; neither does it profess to be infallible. Its editor is just a mere man. We expect our readers to agree or disagree with our opinions, as their honest judgment may dictate. It would be strange indeed if anybody saw things alike. We claim the right to speak out on any question of public interest and to make such suggestions on all matters, as in our opinion seems right, and we would be very unfair not to concede this privilege to others. We are all human beings, having sprung from one common source, fighting the same battles of life, and aiming for the same final goal. Any paper, secular or religious, is likely to express some views that may not meet your approval. But that same paper may say many other things that are good to your way of thinking. So take what appears to be good and leave the other alone. If we differ, let us differ like fair-minded, honest individuals. It's a mighty small man who has no respect for anybody's opinion except his own."

## STRIKE SITUATION.

The strike situation remains about the same. The freight heretofore coming by the way of Mina from San Francisco is arriving over the southern route via Goldfield.

It is estimated that the strike is costing the Tonopah and Goldfield railroad company at least \$1,000 a day over the old scale of wages paid the Brotherhood employees, or \$30,000 a month.

The local formerly run from Tonopah to Goldfield in the morning and returning at 6:05 o'clock in the evening is now running via Millers where switching is done. The train arrives in Tonopah about 8 o'clock in the evening, two hours late.

## REFUSED TO ANSWER QUESTIONS OF CENSUS MAN

CHANGED MIND WHEN INFORMED THAT CRIMINAL PROSECUTION WOULD RESULT.

Supervisor of Census George B. Russell received a telegram from one of his enumerators at Tonopah, today, stating that parties were refusing to answer questions asked in the census schedules, and he was asked for instructions in the matter.

He wired a reply directing the enumerator to call the attention of the parties to section 10 of the census act, which provides that any person who refuses to answer questions contained in the schedule shall be guilty of a misdemeanor and upon conviction thereof may be fined a sum not to exceed \$100, and if the parties still refuse to answer, cause their arrest and prosecution.

The law is very plain in the matter and the supervisor intends to carry it out. He believes that if an example is made in one case that no further difficulty will be experienced. No one should hesitate about answering the enumerator's questions, as all census officials are under oath of secrecy as well as a heavy penalty, and there is no danger of any information they obtain being divulged.—Elko Independent.

The telegram referred to above was sent by one of the local enumerators after he had been shown the door by a man high in this community, who is likewise in the employ of the government and who failed to construe the correct meaning of the census taker. Later when informed that he would be subject to prosecution if he refused to answer the questions asked, he loosened up and gave the official all the information desired.

## STRONG BILL AT THE BUTLER FOR TODAY ONLY

## MINING IN ELKO COUNTY.

The Mineral Mountain Mining company, operating in Tecoma district, is driving its main tunnel with results which indicate the opening of a large mine. The tunnel is in 70 feet on the contact vein, and it has just cut through the first break which leads to an ore chamber in the limestone.

The break has been followed only far enough to prove that the ore is opening in chamber form, work being centered upon driving the tunnel ahead. A short distance ahead of the present face of the tunnel is the second ore chamber, which outcrops prominently on the surface showing ore which runs as high as \$100 a ton in silver and lead. Driving the tunnel 2,000 feet on what is known as the Copper Mountain vein will cut the entire vein system of Mineral mountain, attaining a vertical depth of 1,200 feet. And in driving that distance at least a dozen of the breaks which make ore chambers will be encountered on the vein, so that the prospect for opening a big mine is exceptionally good. There continues to be considerable activity in the district. Leasers on the Salt Lake Copper company's Copper Mountain property are shipping high grade ore as usual. The Tecoma Mines company has taken out a large shipment of sand carbonate ore. The Utah Lead company is going to the 500 level and the Tecoma Consolidated company, which is composed largely of Provo people, is soon to start work.—Mining Science.

## WILL SOON ARGUE ON PRIMARY LAW

SUPREME COURT TO HEAR LAWYERS NEXT SATURDAY; ARRAY OF COUNSEL.

The appellant's opening brief in the supreme court on the direct primary law contest has been filed for some time and it is expected that the oral argument which is set for next Saturday, April 25, will bring out one of the most interesting legal contests that has been before the upper tribunal in years.

It is understood that Colonel Harry V. Morehouse and Attorney Horatio Ailing will assist in the defense of the constitutionality of the law as friends of the court. On account of the intricate nature of some of the points of law brought up it is expected that the court will be glad to receive the assistance of the attorneys in briefing the authorities as the task of a thorough examination of the cases on primary laws will prove a laborious one.

Attorney General Stoddard will present the reply brief in defense of the law and it is possible that Senator Payne, the author of the act in question may be called to assist in the work.

The state fish commission has shipped 20,000 salmon from the hatchery at Verdi, where they will be kept until arrangements are complete for their distribution in the various streams of the state. The commission has about 150,000 left in the local hatchery and these will be taken to Verdi within the next couple of weeks.
