### Senator Rayner Succumbs—Republican To Be Successor

#### DEATH OF HONORED STATESMAN MAY LOSE CONTROL TO PARTY

(By Associated Press)  
WASHINGTON, Nov. 25.—Senator Isador Rayner of Maryland, one of the leading democrats whose name was offered at the Baltimore convention by Bryan as a suitable candidate for the presidency, died here today after a long illness resulting from attacks of neuritis. The death may mean the loss to the democrats of the control of the senate as the governor of Maryland will appoint a republican successor. With Rayner's vote the democrats counted on a majority in the senate.

Will Appoint Jackson  
BALTIMORE, Nov. 25.—It is understood that Governor Goldsborough will appoint William H. Jackson, the republican national committeeman, to succeed Rayner and serve until his successor is chosen by the legislature in 1914.

#### FORMER BANKER OF GOLDFIELD IS NOW IN CONTEMPT

SENDS COLLECT MESSAGE TO JUDGE OF SAN FRANCISCO COURT

Leo Hirschfeld, well known in Tonopah and Goldfield—in the latter camp especially—where he conducted and wrecked the First Bank of Goldfield, is having trouble in San Francisco. Hirschfeld is well remembered by many southern Nevadans on account of his banking operations in this territory.

The San Francisco Call of Saturday gives the following account of Hirschfeld's latest escapade:

If Leo Hirschfeld, the artful dodger of alimony orders, who has failed to pay his divorced wife, Carrie, \$25 a month for so long a time that he is \$1000 in arrears, had any chance for further "stalling" with Judge Van Nostrand, he spoiled it when he sent this telegram to the court yesterday: "Owing to circumstances over which I have no control, neither my lawyer nor myself can appear in your court today."

This was sufficient indignity, since there has been no "R. S. V. P." in the lower left hand corner of the summons served on Hirschfeld, but there was more besides; this telegram was marked "Collect."

Judge Van Nostrand, grave and judicial outwardly, but grimly smiling within, dug down into his small change pocket and made the messenger boy wait for a reply. It was then past 9:30 o'clock, and the judge did not tarry over the wording.

"Be in court at 10 o'clock," was what he sent back to Hirschfeld.

Ten o'clock came and Hirschfeld had not arrived. He was not there at 11 nor at 12, but the judge had not forgotten. Just at the stroke of noon his honor called the case. No answer.

"Guilt of contempt of court," came the order. "Five days in the county jail. Mr. Clerk, let an attachment and order of commitment issue."

Thus was Leo Hirschfeld, bon vivant, man about town, mining and oil stock promoter, but otherwise artful dodger, punished for what L. H. Brownstone, attorney for Mrs. Hirschfeld, characterized in open court as "stalling."

PASSES AWAY AT HIS OLD HOME IN OHIO AFTER LENGTHY ILLNESS

James F. McCambridge, who left Tonopah about six weeks ago for his old home at Cleveland, Ohio, died in that city November 19, according to a message received this morning by Stephen S. Clark, president of the local Miners' union. The message was from J. D. McCambridge, who visited Tonopah at the time of his brother's illness, and accompanied him to the family home.

Jim McCambridge, as he was known throughout southern Nevada, was a pioneer of this section. He engaged in mining during his time on the desert and at one time accumulated quite a fortune. Like many others, he was caught in the panic and forced to sacrifice the greater, if not all of his fortune. He was a man of honor and his word was recognized as good as a bond. His acquaintances he numbered by the score and he was a friend to hundreds when they were in need of friends.

About a year ago McCambridge was taken ill with stomach trouble and on the advice of physicians he went to San Francisco. The lower altitude did not serve to benefit him and in June he returned to Tonopah. He continued to ill and in September, after being a patient in the Miners' hospital for a month, he was removed to the family home in Ohio, he belonged to the Masonic and

#### OLD TONOPAH STAGE DRIVER DIES IN MINE

PIONEER STAMPER OF THIS DISTRICT MEETS DEATH IN CALIFORNIA

Allie Glenn, a pioneer stage driver of Tonopah, and widely known throughout the west, was killed last Thursday at Chinese Camp, Cal., when he was overcome by gas in a mine. Glenn was working with four other miners and all were overcome by the poisonous fumes. They were carried out of the mine by a party of rescuers and all were reanimated with the exception of Glenn, who failed to respond to the treatment.

Glenn drove stage in California for years and during the early days of Tonopah he contributed to this district. He lived here for a number of years. Later he returned to California and was engaged in mining when he met his death. He is survived by a wife and daughter.
