Still Defiant

After passing through the process of slow development, a leader is now being manufactured by the few prime movers of the progressive party to accept the honors to be proffered when the next presidential candidate is named. Roosevelt has spoken, and in his address delivered at Chicago yesterday the former president declared his private party would acknowledge allegiance to no other sect. It was further declared that the progressives expected to gain strength through desertions from the ranks of the regular republican and democratic parties. The next four years, it is expected, will be devoted to the securing of recruits that a better showing might be made when the next presidential election rolls around.

Roosevelt severely criticised the judges of the supreme court of Idaho for not allowing the names of the presidential electors to go upon the ballot. His speech, however, contained no reference to the injustice done the regular republicans of California who were disfranchised and not allowed to vote for President Taft. Of course that did not interest Roosevelt and it was expected he would make no reference of the subject. At the same time the caustic remarks concerning the Idaho jurists merely termed to bring to light the calibre of the speaker. "Equal rights for all" is apparently a phrase not contained in the Roosevelt code of ethics, or if so, it has been amended to read "Equal rights for all if Roosevelt is benefited."

The actions of the former president to keep the third party alive appears to be with the sole idea of preserving the organization that allowed him to appease his personal vanity. With the party disbanded it would appear that the leader has been repudiated by all his former admirers since the election had decreed defeat, and such an idea would be intolerable and insufferable for the arrogant Oyster Bayite.

The defamatory utterances of Roosevelt, once listened to by thousands, are now heard by a very few, and as the time passes it is predicted that the popularity of the former leader will pass also and the glory that was once his will have been forgotten.

Boarding The Band Wagon

After several years of inactivity the ministers of Nevada are suddenly awake to the demoralizing influence to be felt because of the easy divorce laws to be observed in this state. At the last minute before a change is to be made the ministers hold up their hands in horror and loudly deplore such conditions. Resolutions are adopted recommending that the evil be remedied, and after performing such a solemn obligation the men of cloth adjourn their session and return to their homes, satisfied that they alone have saved the glorious state of Nevada from a lasting disgrace.

Had sentiment against the present divorce laws not been so outspoken and observed in every quarter it is doubtful if the Ministerial association would have taken action. It is a safe bet that the entire matter would have been carefully sidestepped. However, there appeared an excellent chance to play to the gallery of public approval and the players did the rest.

Should the coming legislative session result in the law being changed, and reports from every county are to the effect that delegation after delegation favors the change, the association will calmly step to the front and acknowledge that the church has again won a glorious victory and that Nevada has been saved and the tattered reputation restored to all its former glory.

Nevada Is Fortunate

Notwithstanding the assertions that Nevada is considered the joke of the nation on account of the present divorce laws, this state stands slightly in advance of Illinois, where the authorities were powerless to prevent the marriage of Jack Johnson, the negro pugilist, to a white girl. The last Nevada legislature enacted into law a measure that prevented intermarriage between the Caucasian and any other races and that law is on the statutes today. With such a law in effect the state of Illinois would be better off morally and from press reports such a measure will be presented to the legislature of that state at the next session.

Nevada may be a trifle slow in correcting the divorce question, but in other instances it can give the older and more staid eastern states a few lessons in progressive and up-to-date legislation.
