Rhyolite Coming Back

Rhyolite and southern Nevada is again coming into its own, according to reports received from that section of the country. The great activity on the part of the American Carrara Marble company has served to awaken the district, and now several mining properties are preparing to resume.

At one time the district boasted of thousands of inhabitants, but of late years the population dwindled. Now many of the old crowd are returning and with their arrival the old properties are making preparations to resume. The entire southern district has merit and its return to the old days of prosperity will be along the lines of merited advancement.

From Other Pens

Under the heading of "An Ill Timed Suit," the Goldfield Tribune has the following to say regarding the famous \$30,000 libel suit instituted by Frank L. Wildes against the Bonanza:

"Receiver Wildes has sued the Tonopah Bonanza for defamation of character, complaining that the Bonanza charged him wrongly with having committed perjury. The suit is an outgrowth of the general and persistent agitation which finally resulted in a special enactment which authorizes and directs the attorney general to examine into the affairs of Wildes' receivership and prosecute such further action civil or criminal as in his judgment may seem proper.

"No one contended more earnestly or persistently for an investigation of the affairs of his receivership than the Tribune. The sentiment not only of the press but of the people of the state demanded a full accounting. The legislature responded with a special enactment. With the investigation assured it is proper to suspend judgment, pending the result. The Tribune doesn't believe that there was malice in anything the Bonanza or any other newspaper printed, and if Mr. Wildes had been as responsive to public sentiment and the wishes of those who were appointed and paid to serve, he would have forestalled not only the occasion for newspaper or individual comment but the drastic action of the law-making body of the state. If the Bonanza or any other newspaper has wronged Mr. Wildes, he has a just cause of action, but his action would come in very much better grace after the official report on the inquiry now in progress. If he has been injured his award for damages will result from the unjust impairment of the public estimate of his character and conduct. It is not by this action at this time done greater violence to this estimate than the Bonanza did in commenting upon the report of a legislative committee? The Tribune believes he has."

Standpatters Stand Pat

From Washington comes the intimation that the republican members of the upper house of congress are inclined to allow the democratic majority to go to the limit on tariff schedule revisions, says the Reno Gazette. They argue that the sooner the democratic free trade doctrine is made effective and the sooner the people realize the effects of the Wilson policies on the country as a whole, the sooner shall we all be able to return to what the republicans regard as normal conditions—in other words, to a condition of normal prosperity.

It has been proposed that the majority members of both houses agree upon a schedule of duties which they might propose as a compromise, in an effort to defeat or delay the enactment of extreme measures by Mr. Wilson and his majority. But the standpatters on the republican side insist that they can not consent to any such program. They are of the opinion that possibly by the next presidential election, the people, if they are treated to an alaphoidic dose of the Wilson tariff reform cure-all, will be only too anxious to return a republican congress to power. When that time comes, the minority members say, they do not want to be confronted with any compromise proposals made to stave off destructive democratic enactments. This seems to be upon the theory that if the democrats are allowed a free hand and plenty of rope they will hang themselves. And there is recorded history which seems to lend sufficient color to the suspicion.

Strange as it may seem, there are democrats right here in Nevada who are brave enough and confident enough to desire that their party be permitted to go to the limit. They are hoping against hope that their leaders have acquired wisdom in their years of adversity. If they are to see their wish granted it seems not improbable that the country is to be treated to a period of genuine democratic economic control. We could hardly imagine a more propitious or happy time for again trying the experiment. We are as prosperous as a country can well be. It is better to have a drought after a long wet spell than at any other time.
