No, gentle reader, the Bonanza has made no attempt to settle the Wildes \$30,000 alleged libel suit out of court by paying 10 cents on the dollar.

Press dispatches announce that two women police of Los Angeles are ordered to do plain clothes duty. However, this does not mean that no finery will be worn. It is merely a figure of speech.

Not content with drawing \$100 a month for sixteen months, after being appointed to the \$10,000 position as receiver of the State Bank and Trust company has asked the Bonanza to kick through with an additional \$30,000. Talk about nerve.

The Bonanza today has the distinction of being the only paper published in the state of Nevada with an alleged libel suit on its hands. This distinction is valuable for the advertising and subscriptions that will result will more than pay the little sum requested.

Our Neighbors Pleased

We note that our fellow being over in Canada are immensely pleased with the Wilson tariff bill. They are jubilant by reason of the fact that this bill will give them altogether without any concession on their part, pretty much everything that the reciprocity treaty would have given them had they ratified that document; but they rejected it, chiefly on the foolish scare that it meant eventual annexation to the United States.

The state of mind thus developed in the Canadians is thus referred to editorially by the Milwaukee Sentinel, which is in an excellent position to learn and gauge Canadian feeling:

"President Wilson's sudden popularity in Canada is unbounded. Our Canadian neighbors are naturally rejoiced over the fact that what they, with unconscious sarcasm, call the 'Wilson tariff bill' will give them free, gratis and for nothing, most of the advantages which two years ago they were required by Taft to purchase with reciprocal concessions."

"What a difference, from the Canadian viewpoint, between the nobly generous Wilson and the huckstering Taft! As for the American viewpoint we won't say."

"But as Canada regards it, Taft actually wanted her to purchase this great market for her fish, lumber, farm produce, etc., by giving our manufacturers equivalent ingress to her markets. And Canada was mighty near being enojled and honeyfugged by the big, artful man into ratifying the bargain."

"'Lucky for us we didn't,' say the Canadians. For now comes Mr. Wilson with his cornucopia and gives them for nothing what Mr. Taft wanted them to buy. Says the Toronto Mail: 'What a laughing stock Canada would now have been had Mr. Taft's bunco steering been successful!'"

"Poor Mr. Taft! Called a bunco steerer and a skiffint for trying to get Canada to buy what Mr. Wilson gives away. Mr. Wilson's Canadian 'reciprocity' is of the jug handle variety, and the handle is on the other side."

That Libel Suit

Kind friends of the Bonanza, under the apprehension that this paper will be forced to pay the \$30,000 libel suit instituted by Frank L. Wildes, receiver of the State Bank and Trust company, have come forward with sympathy and \$50,000 checks. To date no less than a dozen certified \$50,000 checks have been received and every mail brings in additional offerings of this sort. The checks have been brought in by the philanthropic donors and many who desire to keep their identity secret have showed them under the door. The issue of the Bonanza Saturday containing the announcement of the suit for defamation of character had not been on the street but a few minutes when the deluge of checks started. So persevering were some that the Bonanza management was forced to depart from the office, rather than stay and risk injuring the feelings of friends.

Today the Bonanza stands as the only newspaper in the state with a real live, nice little \$50,000 libel suit on its hands. And it is not a little old lady suit at that. It is brand new, spick and span to a new cover, just from Judge Langan's court at Carson where it was born. Notice of its untimely demise will be given later.

In his action for damages for defamation of character Wildes claims that he has resided in Nevada for the last 30 years. This fact alone should entitle him to damages, but for an additional fact—that is,

the Bonanza editor has lived in Nevada for 46 years and during that time has made trails for Mr. Wildes. When it comes to question of years, it is possible that the bank receiver can be considered as a tenderfoot.

As to the charge of defamation of character, more will be said later. More will also be said upon the inactivity of Judge Langan in his failure to take action in the matter after it was announced that Wildes had drawn a salary from the state for 16 months, after being appointed receiver of the defunct bank. When this disclosure was made in the legislature by an investigating committee, one member of the committee announced on the floor of the assembly that "he would yet put the stripes on this man Wildes."

Judge Langan has apparently taken no steps to investigate this accusation, nor has Wildes publicly denied the assertion.

And now comes the attempt to establish character at the expense of the Bonanza. Wouldn't it make you peevish?
