HAMMERING STOCKS

THE past week has witnessed one of the most ferocious attacks on two of the chief properties of Tonopah that have never been impeached as valuable holdings. The West End and Jim Butler are known as two of the most conservatively managed mines in the district. Their reserves have been blocked out during the past year until they show a tonnage sufficient to keep a couple of mills busy for two years' time without doing another foot of development. The only cloud on the horizon is the dispute arising from the invasion of side lines that is now under consideration by the directors of both companies in an amicable conference. There can be no question of the outcome as the interests of the respective companies are of too vital importance to the stockholders to permit to be deadlocked by working at cross purposes. Like other varieties of the same character it is probable that the territory question will be handled in a way that will not militate against the interests or work a hardship to the stockholders. The attitude of the West End is particularly unreasonable in view of the fact that that company has done more substantial development in the past year and has brought into sight more promising ore than any other mine in camp. The management, recognizing the growth of its reserves, arranged some six months ago an increase of the milling capacity and this additional reduction about ready to begin a long and prosperous campaign. The West End, moreover, has a reserve fund estimated at close to \$100,000 and is in a position to swell this every month after paying dividends to be determined by the directors from the net proceeds. The West End has grown from a preferred prospect dividend paying mine within the past twelve months, and its wisdom in the treatment of the present problem there is on why the company should not remain permanently in the first class. The Jim Butler, according to one of the principal holders, is one of the great mines of Tonopah, whose worth will be realized at no distant date. That company is adding to its surplus between \$35,000 and \$50,000 a month and will be in a position to declare its first dividend before the close of the summer. It is unfortunate that a lot of speculators should have seized upon the affairs of these two companies to cause a raid on the value of the securities bearing their name, for these mines are above suspicion of juggling and are possessed of well developed ore bodies that are good for years.

FIND CHANGE OF HEART

THE ELY EXPOSITOR and one of the owners of the Ely Record who was in the last legislature were against the movement to allow lawyers to send typewritten briefs to the Supreme Court. They had good and sufficient reasons for their course of conduct, and the recent change of front is hard to understand. The Supreme Court, many of the district judges and the United States District Attorney each and all favored the bill to compel printed briefs. The Judges of the Supreme Court told the committee and individual members of both houses that they were firmly opposed to any system that would sanction typewritten briefs, as many came in such bungled shape that they could not make any sense of the contents, and that many had to be returned to the attorneys for correction. The Ely Expositor seems to delight in fouling its own nest by declaring the printing nothing more than graft. If the printing of briefs at \$1.25 and \$3.50 per page is graft, then printing letterheads and envelopes at local rates is bank robbery. Colorado not only insists on printed briefs, but the law directs that the bill be accompanied by a receipted bill to show the printer has been paid for his work. It is alleged the latter part would earn the undying animosity of Bertie McIntosh.

WALL STREET REFORMS

THE New York World has given the Stock Exchange a clean bill of health. It says that "great things have only recently been done toward making this market a safer resort for small funds seeking investment. Still greater things to this end are in the way of being done. A new 'Wall Street' is in process

of creation which will better deserve the attention and confidence of the industrious and saving public."
