NEW ANGLE TAKEN IN N. & O. BANK CASE

PROCEEDINGS IN WHICH THE PEOPLE OF NYE ARE VITALLY INTERESTED

The case of the First National Bank of San Francisco against Nye county, wherein E. O. Patterson, receiver of Nye and Ormsby county bank, intervened, as told in detail in a recent issue of the Bonanza, has assumed a new angle.

The San Francisco bank has filed a petition requesting that the case be removed to the federal court upon the grounds of diversity of citizenship. The hearing of the petition was to have taken place today, but has been postponed until such a time as Judge Langan can hear the matter in the fifth judicial district court of Nye county.

This county is vitally interested in the outcome of the proceedings, for should the county or the receiver ultimately prevail, it will mean the recovery of Nye county's balance in the defunct Nye & Ormsby county bank, amounting to something like \$40,000.

MAP OF THE MIDLAND TRAIL IS RECEIVED

TONOPAH IS VERY IMPORTANT POINT ON THIS SHORTLINE ACROSS CONTINENT

FINANCIAL STATEMENT MADE BY COMMITTEE

RELIEF WORK WILL BE CONTINUED IN TONOPAH AS LONG AS IS NEEDED

The combined community Christmas tree and relief committee met yesterday afternoon at 2 o'clock in the club room at the Hotel Mizpah and canvassed the accounts of the organization. It was reported that \$785.75 had been contributed in cash, as well as a large amount of supplies and labor. The disbursements were:

New clothes, \$90.11; coal, \$190.50; nuts, candy and crackerjack for Christmas tree, \$185.65; groceries, \$42.15; meat, \$23.12; rent, \$7; cash to families, \$25; labor on Christmas tree and for relief, \$14.50; lamps and ornaments for Christmas tree, \$14.40; hauling, \$10.50; wood, \$4, making a total of \$606.93. The balance on hand is \$178.82. There are a few small bills outstanding and the committee requests that they be sent in at once, so that the affairs of the committee, particularly so far as the community Christmas tree is concerned, may be wound up.

A meeting of the committee will be held Wednesday evening of next week, to which the public is invited. It will be for the purpose of changing the organization to that of a general relief committee and continue the work of the organization throughout the winter.

Clouded Windows. Many people have a window or a part of one which they would like barred to the too curious gaze of passers-by or, possibly, of neighbors.

This can be managed by prettily crystallizing the window glass as follows: Fill a jam pot one-third full of gum arabic and add a little hot water. Let this soak for some hours and when the gum has quite dissolved add the same quantity of epsom salts. Then stand the jam pot in a basin of hot water and stir well until the salt has quite dissolved. Apply the mixture to the glass quickly with a camel's hair brush.

The effect is like crystallized ground glass, and, while light is admitted, no one can see through it. The effect of plain ground glass is obtained by using a linen rag instead of a brush and putting the preparation on thinly.—Exchange.
